

A RESOLUTION AMENDING FEES FOR PASTIME PARK, RECREATION FEES AND AQUATIC CENTER RATES AND FEES

WHEREAS, the Village of Plain City is responsible for maintaining and operating the Village Aquatic Center, the Village parks and recreation facilities and Village recreation programs and determining the fees for use of the same; and,

WHEREAS, the Village Council has evaluated the needs and operating expenses of the Village Aquatic Center, the Village parks and recreation facilities and Village recreation programs; and,

WHEREAS, as a result of said evaluation, the Village Council believes it necessary and appropriate to amend the rates and fees for the Village Aquatic Center, the Village parks and recreation facilities and Village recreation programs; and,

WHEREAS, the Village Council believes that amendment of the Village Aquatic Center, the Village parks and recreation facilities and Village recreation programs rates set forth below are necessary and appropriate.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, as follows:

Section 1. The Village Aquatic Center Rates and Fees shall be as follows:

Section 2. That the park rental fees for Pastime Park shall be amended and adopted as follows:

Youth Building Rental	\$75.00 per day Mon – Thurs \$100 per day Fri, Sat, Sun \$ 25 early setup fee the day before, if facility is available
Rental of Area “A”	\$150.00 per day
Rental of Area “B”	\$200.00 per day
Full Park Rental (single day)	\$650.00 per day
Full Park Rental (multi-day)	\$337.00 per day
Camping Fees Grass sites	\$28.00 per night \$25.00 per night for military & seniors (over 60) \$800 per month \$725 per month for military & senior (over 60)
Camping Fees Gravel sites	\$35.00 per night \$32.00 per night for military & seniors (over 60) \$950 per month \$900 per month for military and seniors (over 60)
Nov. 1 – March 31	\$900 per month No rate discount for military or seniors
Full Hook up (w. sewer)	\$38.00 per night \$35.00 per night for military & seniors (over 60)
Nov. 1 – March 31	\$950 per month No rate discount for military or seniors
Tent Camping – Primitive Area	\$15.00 per night – Maximum stay 14 days in a calendar year
Dump Station	\$5 per use
Wood	\$5 per bundle
Water Fill Up	\$5 per fill

Section 3. The Village recreation fees shall be as follows:

Swim Team	\$95.00 per child; \$65.00 for each additional child in same family
Other Recreation Teams	\$100-\$500 per team depending on the sport
Other recreation programming	\$0 to \$100 per person, depending on program

Section 4. The Village Administrator is hereby authorized to amend any and all rates established by this resolution by notifying Village Council in writing of proposed rate changes at least thirty (30) days in advance of said changes taking effect. Village Council, after receiving written notification from the Village Administrator, may request that the proposed changes be reviewed and consented to, denied, or further amended by motion of Council within the thirty-day notification period. If Village Council takes no action within the thirty-day notification period, the proposed changes shall take effect.

Section 5. This Resolution shall take effect at the earliest time allowed by law.
