

RESOLUTION 03 -20
AUTHORIZING LEGISLATION

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND / OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the Village of Plain City is planning to make capital improvements to Gay Street, and

WHEREAS, the Village previously applied for financial assistance from the Ohio Public Work Commission for said project and obtained contingent approval; and

WHEREAS, the Ohio Public Works Commission has communicated its willingness to proceed with assisting with the project and requires the Village to pass enabling legislation authorizing the Village Administrator to enter into all necessary agreements to facilitate this cooperative effort, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs.

NOW THEREFORE, BE IT RESOLVED by the Village of Plain City, Ohio:

Section 1: The Village Administrator is hereby authorized to apply to the OPWC for funds as described above.

Section 2: The Village Administrator is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3. This Resolution is declared an emergency measure and effective immediately upon passage. Such emergency exists to ensure that the Village may obtain OPWC funding assistance for the subject project and not unnecessarily delay the release of funds by OPWC and construction of the project. Any delay in the same will deny the public the benefits of improved infrastructure and utility services, all contrary to the public good.
