

RESOLUTION NO. 05-2021

A RESOLUTION AUTHORIZING THE SALE OF IMPOUNDED VEHICLES

WHEREAS, the Village of Plain City wishes to sell unneeded and obsolete equipment; and,

WHEREAS, Ohio Revised Code Section 4513.61 authorizes the Chief of Police to come into possession of vehicles as a result of the performance of the Police Department's official duties and to impound the same; and,

WHEREAS, Ohio Revised Code Section 4513.62 authorizes the Chief of Police to dispose of impounded vehicles, that remain unclaimed by the vehicle's owner, by auction or other statutorily permissible means; and,

WHEREAS, the Chief of Police has identified the following vehicles that have been impounded by the Village Police Department in the course of the Department's official duties and seeks the sale of the same by public auction:

- 1999 Chevrolet Blazer (VIN: 1GNDT13W1XK180707)
- 1994 Cadillac (VIN: 1G6KD52B0RU274140)
- 2007 Nissan Sentra (VIN: 3N1AB61E77L708421)
- 2009 Chevrolet Malibu (VIN: 1G1ZJ577X9F253740)
- 1995 Honda Accord (VIN: 1HGCD5633SA090274)

WHEREAS, the Chief of Police has provided notice to owners of the above vehicles to reclaim such vehicles and the same have gone unclaimed and the Chief of Police has obtained valid titles to these vehicles; and

WHEREAS, the Village Council approves the sale of the above vehicles by public auction through the Village's contracted auctioneer GovDeals.com.

NOW THEREFORE BE IT RESOLVED by the Village Council of Plain City, Ohio, as follows

Section 1. The Village Council of Plain City hereby authorizes the Chief of Police to sell at public auction the following vehicles:

- 1994 Cadillac (VIN: 1G6KD52B0RU274140)
- 2007 Nissan Sentra (VIN: 3N1AB61E77L708421)
- 2009 Chevrolet Malibu (VIN: 1G1ZJ577X9F253740)
- 1995 Honda Accord (VIN: 1HGCD5633SA090274)

Section 2. The Village Council hereby directs the Chief of Police to sell the identified vehicles, set forth in Section 1, by public auction through GovDeals.com.
