RESOLUTION NO. 22-2021

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN EMPLOYMENT AGREEMENT FOR THE POSITION OF FINANCE DIRECTOR

WHEREAS, the Village of Plain City Council approved an employment agreement in 2016 between the Village and Renee Sonnett for the position of Village Fiscal Officer, and

WHEREAS, the voters of the Village of Plain City approved the adoption of a municipal charter that will take effect on July 1, 2021, and

WHEREAS, the position of fiscal officer under the charter will be reclassified as the position of finance director, and

WHEREAS, the existing employment agreement between the Village and Ms. Sonnett contains certain provisions, amongst other things, that will not be in congruence with the provisions of the charter upon its effective date, and

WHEREAS, the Village Council and Ms. Sonnett are in agreement to extinguish the existing employment agreement and enter into a new employment agreement for the position of finance director.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. The Village Administrator is hereby authorized and directed to enter into an employment agreement with Renee Sonnett as detailed in Exhibit A attached hereto and incorporated herein. The previously approved employment agreement between the Village and Ms. Sonnett shall be extinguished upon the execution of the new agreement by both parties.

Section 2: Village Council, pursuant to Article 7.04 of Charter of Plain City, consents to and approves the appointment of Renee Sonnett to the position of finance director upon the effective date of the charter.

Section 3: This Resolution shall take effect at the earliest time allowed by law.


