

RESOLUTION NO. 02-22

**A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO DISPOSE OF VILLAGE PROPERTY NO LONGER NEEDED FOR PUBLIC USE**

**WHEREAS**, the Village of Plain City possesses certain personal property that Village Council has previously determined to no longer be needed for public use which is described in Exhibit A attached hereto and incorporated herein; and

**WHEREAS**, Village Council had previously authorized the sale of said personal property by internet action; and

**WHEREAS**, the Village did not receive any bids for said personal property; and

**WHEREAS**, the results of the previous sale effort have now caused Village Council to determine that said personal property has no value; and

**WHEREAS**, Ohio Revised Code Section 721.15 (C) authorizes the Village to discard or salvage property that is not needed for public use, or is obsolete or unfit for the use for which it was acquired, and that the property has no value.

**NOW THEREFORE BE IT RESOLVED** by the Village Council of Plain City, Ohio, as follows

**Section 1.** The Village Council of Plain City hereby authorizes and directs the Village Administrator to dispose all personal property of the Village detailed in Exhibit A pursuant to Ohio Revised Code 721.15(C).

**Section 2.** Upon final disposal of said personal, the Finance Director shall record said disposal as it relates to the Village's schedule of assets.

**Section 3.** This Resolution shall be effective from and after the earliest period provided by law.
