
**What is the clear reason for the recognition and why is the person / group / organization being honored? Why is this achievement extraordinary?**



Nickey attended Jonathan Alder High School in Plain City, Ohio, and wore number 2, and was an All-Ohio running back. He also played free safety in football. In addition to his football talent he was selected as an All-State center fielder as part of the 1998 OHSAA State Championship team (baseball). Nickey was a co-captain with Mike Doss on the 2002 NCAA National Championship team. Nickey was drafted by the Tennessee Titans in the 5th round (19th pick) of the 2003 NFL Draft. He played his entire career with the Titans. Most of his time playing time logged on special teams, where he had been label as an 'Ace'.

In 2010, while with the Titans. He was released by the Titans on July 25, 2011 after spending 8 seasons with the team. Nickey is married with three kids and currently lives in Dublin, Ohio.
