

RESOLUTION NO. 03-2023

A RESOLUTION AMENDING THE RENTAL RATES FOR FACILITIES OWNED BY THE VILLAGE OF PLAIN CITY

WHEREAS, the Village of Plain City is responsible for maintaining and operating the Village facilities and determining the fees for use of the same; and

WHEREAS, in 2022, the Village of Plain City Council previously adopted Resolution 27-2022 amending the rental fees for facilities owned by the Village of Plain City; and

WHEREAS, the Village staff has evaluated the needs and expenses of Pastime Park and other Village rental facilities in an effort to determine the appropriate fees to be assessed for said rentals; and

WHEREAS, as a result of the evaluation process, staff recommends to the Village of Plain City Council that adjustments be made to the current rental fees and the inclusion of new rental fees to reflect the incorporation of additional facilities, as shown in Exhibit A.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. That the facility rental fees shall be amended and adopted as shown in Exhibit A.

Section 2. Where applicable, all ordinances and resolutions, or parts thereof, in conflict with the provisions of this resolution are hereby repealed and of no further force or effect.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
