

RESOLUTION NO. 17-2023

**A RESOLUTION TO ADOPT THE SOLID WASTE MANAGEMENT PLAN FOR THE ALLEN-CHAMPAIGN-HARDIN-MADISON-SHELBY-UNION JOINT SOLID WASTE MANAGEMENT DISTRICT**

**WHEREAS**, the Village of Plain City is located within the jurisdiction of the Allen-Champaign-Hardin-Madison-Shelby-Union Joint Solid Waste Management District (District); and

**WHEREAS**, the District Policy Committee prepared and adopted a final draft of the Solid Waste Management Plan in accordance with Ohio Revised Code Sections 3734.53, 3734.54 and 3734.55; and

**WHEREAS**, the District has provided a copy of the Draft Final Solid Waste Management Plan for ratification to each of the legislative authorities of the District; and

**WHEREAS**, the Village of Plain City must decide whether it approves of said Solid Waste Management Plan within ninety days of receipt of the Final Draft Plan.

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

**Section 1.** The Village of Plain City approves the District Solid Waste Management Plan.

**Section 2.** The Finance Director is hereby directed to send the District a copy of this resolution to the attention of Mr. Jack Dewitt, Executive Director, Allen-Champaign-Hardin-Madison-Shelby-Union Joint Solid Waste Management District, 815 Shawnee Road, Suite D, Lima, OH 45805 or by email at jack@ncowaste.org.

**Section 3.** It is found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were adopted in an open meeting of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Sections 121.22 of the Ohio Revised code.

**Section 4.** This Resolution shall be effective from and after the earliest period provided by law.
