

RESOLUTION NO. 24-2023

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENTS AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTIVE CONTRACTS AS REQUIRED AND REQUESTING A WAIVER OF THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the Village of Plain City is planning to make capital improvements to public infrastructure through the West Avenue Culvert Extension Project; and

WHEREAS, the Village is in the process of preparing engineering information and project cost estimates for said project; and

WHEREAS, the infrastructure improvement herein is considered to be a priority need for the community and is a qualified project under the OPWC programs; and

WHEREAS, the Village Council desires to seek OPWC financing assistance for said project.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. The Village Administrator is hereby authorized and directed to apply to the OPWC for funding for said project under terms deemed appropriate by the Administrator.

Section 2. The Village Administrator is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
