

RESOLUTION NO. 35-2023

A RESOLUTION AMENDING THE RENTAL RATES FOR FACILITIES OWNED BY THE VILLAGE OF PLAIN CITY

WHEREAS, the Village of Plain City is responsible for maintaining and operating Village facilities and determining the fees for use of the same; and

WHEREAS, the Village staff has evaluated the needs and operating expenses of the Village rental facilities, including those within Pastime Park, in an effort to determine the appropriate fees to be assessed for the use of said facilities; and

WHEREAS, as a result of the evaluation process and staff's recommendation, the Village Council has determined it necessary and appropriate to amend the rates and fees for the Village rental facilities as set forth in Exhibit A and attached hereto and incorporated herein.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. That the facility rental rates shall be amended and adopted as set forth in Exhibit A and attached hereto and incorporated herein.

Section 2. Where applicable, all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Resolution are hereby repealed and of no further force or effect.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
