

RESOLUTION NO. 10-2024

A RESOLUTION AMENDING THE WAGE SCALE OF THE EMPLOYEES OF THE PLAIN CITY POLICE DEPARTMENT

WHEREAS, thorough research and discussion has taken place within the Personnel & Finance, CIP Committee in regards to the current wage scale of employees of the Plain City Police Department; and

WHEREAS, it is the intention of this Council to employ the highest quality law enforcement personnel to continue to provide the utmost safety for residents of the Village of Plain City; and

WHEREAS, through careful consideration, and in an effort to provide competitive salaries to employees of the Plain City Police Department, a wage scale amendment has been determined to be required; and

WHEREAS, the Village Council deems it necessary and appropriate to modify the wage scale of the employees of the Plain City Police Department.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

Section 1. The Village Council hereby approves an amendment to the wage scale of the employees of the Plain City Police Department as detailed in Exhibit A, as attached hereto and incorporated herein.

Section 2. The Finance Director is hereby authorized and directed to make all necessary adjustments and revisions to the current wages of employees of the Plain City Police Department, whose pay is modified by the enactment of this Resolution upon its effective date.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
