

TECHNICAL ASSISTANCE PROGRAM

KEY DETAILS:

- Technical Assistance Awards do not include any direct cash assistance to awardees instead, the program reimburses qualified technical assistance providers directly for services provided to awardees.
- Business owner technical assistance awards will be provided to eligible businesses for services such as business planning, financial management, design assistance, design/build assistance, content creation, and web development.
- While each of the services offered through technical assistance awards has a value, there is no money exchanged between the City of Pontiac and the awardees.
- Technical assistance awards are available to: (1) Pontiac residents who own Pontiac-based businesses, and (2) non-resident business owner applicants who will be seeking future small business loans
- This program is funded through the American Rescue Plan Act funding and is meant to offset negative impacts of COVID-19

ELIGIBILITY

- The following individuals **are not** eligible to apply: business owners who are (1) employees who are directly assigned to work on the Pontiac Small Business Program, (2) the Mayor and City Council, and (3) contractors affiliated with the Pontiac Small Business program.
