WHEREAS, the City has the available capacity to begin to transition the local registrar duties back from Oakland County to the City of Pontiac; and

WHEREAS, additional staff may be needed in the City Clerk's Office to fully complete this task; and WHEREAS, the City believes that it can provide these services to the citizens without any interruption or incident.

NOW THEREFORE BE IT RESOLVED, that the City Council for the City of Pontiac respectfully requests that the Oakland County Board of Commissioners pass a Resolution indicating the intent to transfer the local registrar function back to the City of Pontiac and for the County Clerk/Registrar of Deeds to work with the City of Pontiac to ensure a smooth and uninterrupted transition of these services.

The City of Pontiac has received an offer to purchase the building at 500 W Huron and adjacent vacant land for \$22,000 from US Healthcare MI P.C. a Michigan professional corporation led by Muhammad Shakeel Awaisi, M.C., FRCS. They are practicing physicians at Pontiac General Hospital and will be using this building for office space.

Attached are the two resolutions. The first resolution approves the direct sale. The second resolution approves the sale of the parcels for \$22,000 pursuant to terms of the purchase agreement.

WHEREAS, the City has engaged in discussions with a potential purchaser for the Real Property with Parcels ID #14-30-478-054, 14-30-478-021, 14-30-478-037, 14-30-478-038 and 14-30-478-022, Commonly Known as 500 W Huron and Adjacent Vacant Land; and

WHEREAS, Section 2-520 of the City Ordinances provides that real property must be sold or exchanged by open public auction, online auction, sealed bid auction, or direct sale; and

WHEREAS, the City Council may waive a sealed bid or auction procedure for real property upon a unanimous vote and after the public has had an opportunity to comment on the proposed disposal procedure; and

WHEREAS, the City has received an offer to purchase and a proposed Purchase Agreement for 500 W Huron and adjacent vacant land in the amount of \$22,000.00 from US Healthcare MI, P.C.; and

WHEREAS, the City Council has held a public hearing on the issue of a direct sale on July 27, 2017; and

WHEREAS, the City Council finds that it is in the best interest of the City to proceed with a direct sale of the Real Property with Parcels ID #14-30-478-054, 14-30-478-021, 14-30-478-037, 14-30-478-038 and 14-30-478-022, Commonly Known as 500 W Huron and Adjacent Vacant Land.

WHEREAS, the City of Pontiac is the owner of approximately 0.90 acres of property, identified as 500 W. Huron and Adjacent Vacant Land Lot 1AP, Parcels ID #14-30-478-054, 14-30-478-021, 14-30-478-037, 14-30-478-038 and 14-30-478-022 in the City of Pontiac; and

WHEREAS, US Healthcare MI, P.C. has tendered an offer to purchase the real property for \$22,000, in the form of a Purchase Agreement to the City; and

WHEREAS, the Purchase Agreement having been reviewed and approved by the City Administration, the City Attorney, and the Real Estate Subcommittee; and

WHEREAS, on July 27, 2017, the City Council unanimously waived the bid or auction requirements and approved a direct sale of the real property; and

WHEREAS, on July 27, 2017, the City Council held a public hearing about the sale of 500 W. Huron and Adjacent Vacant Land to US Healthcare MI, P.C.

WHEREAS, It is feelings of the deepest regret that the Pontiac City Council mourns the passing of Catherine Sykes, a giving and devoted member of this community; and,

WHEREAS, Catherine Sykes was affiliated and an active member of numerous organizations, some include, Board Divisions Project for Equal Educational Rights, the Urban League, Trustee for Macedonia Missionary Baptist Church since 1978, the National Education Association, the NAACP (national director membership), English Teacher Michigan Alliance Black Educators, National Alliance Black School Educators, Pontiac Northern High School Club, National Association Negro Business and Professional Women's Clubs (national 2nd vice president) and Alpha Kappa Alpha Sorority Incorporated; and,

WHEREAS, Catherine Sykes married Barry Sykes on December 23, 1966 and together they shared two children, Barry Jabbar Sykes and Brent Justin Sykes; and,

WHEREAS, Catherine Sykes life was a portrait of service, a legacy which will long endure the passage of time and will remain as a comforting memory to all those whose lives she touched; and,

THEREFORE BE IT RESOLVED, that the members of the Pontiac City Council and the community will greatly miss Catherine Sykes and all of her countless contributions to the City of Pontiac.

SUBJECT: AT&T Contract Renewal

Mrs. DiSessa,

Attached are the new contracts with AT&T for our telephone and internet services for the City of Pontiac:

AT&T has been the provider of these services for a long time, dating back in the mid 1990's. Currently they provide all of our telecommunication needs, including internet, for the City Hall, 50th District Court, limited service for the Sheriff's Building, and two senior centers, Bowen and Ruth Peterson.

The current contract expires in October 2017 and we have been working with AT&T to extend the contract for another 3 years.

There are few differences in price and services to be provided by AT&T with the new contract:

- 1- The new contract does not cover the senior centers, we solicited a quote from Comcast and their price was less expensive than AT&T for the Senior Centers, therefore we will have Comcast provide the services to the Senior Centers upon signing of this new contract.
- 2- The monthly price in the new contract will be \$4,348.36 vs. \$8,234.29 in the existing contract. Even when we add the monthly charge from Comcast in the amount of \$\$489.40, there are savings of approximately \$3,396 to be realized in the long run.

3- AT&T will increase the bandwidth at the Courthouse from the current 5 MB to 50 MB, which in turn will increase the user's efficiency.

Attached is the price sheet detailing all the charges that I summarized above plus the new documents for all the services provided by AT&T in the next three years.

If the council agrees with the renewal here is a resolution needed to pass:

Whereas, AT&T, the City's current telecommunications and internet provider has presented the City with proposals for these services for a period of three years; and,

Whereas, the Deputy Mayor and Finance Director have reviewed the proposals, have recommended that proposals are accepted, and have certified available funding;

Now Therefore, Be It Resolved, that the City Council approves the proposal from the AT&T to provide telecommunication and internet services as outlined in the summary sheet and the separate agreements attached in this resolution.
