WHEREAS, Human Resources is requesting authorization to increase the contract by \$60,000.00 to pay for the referenced services.

NOW THEREFORE BE IT RESOLVED that the Pontiac City Council authorizes the increase in the HRAA contract in an amount Not-to-Exceed \$60,000.00 to pay for the referenced services from General Ledger Account 101-270-819.000 to allow the continuation of HR Consulting services by HRAA.

WHEREAS, the City has a great need for a dedicated professional to manage and coordinate all finance, treasury, purchasing, accounting and payroll activities and initiatives effectively; and

WHEREAS, pursuant to the Pontiac Home Rule Charter, Section 4.106, such appointment is subject to the approval of City Council.

NOW THEREFORE BE IT RESOLVED that the Pontiac City Council hereby appoints Dee Ann Irby to the position of Director of Finance for the City of Pontiac in accordance with the Pontiac Home Rule Charter and the Municipal Code, effective immediately for a budgeted salary of \$153,000.00.

**Economic Development Division** 

24-236 Resolution Finding that the Proposed Neighborhood Enterprise Zone (NEZ) is Consistent with the City's Master Plan, Goals, Objectives, and Policies of the City of Pontiac. Moved by Councilperson Rutherford and seconded by Councilperson Goodman.

WHEREAS, The Neighborhood Enterprise Zone Act (MCL 2027.771 et al) allows the City to designate a neighborhood enterprise zone to encourage development and redevelopment by allowing the owners of parcels within the zone to apply for a property tax exemption.

WHEREAS, MCL 207.773(3) requires the Council to adopt a Resolution finding that the proposed neighborhood enterprise zone is consistent with the master plan of the City and the neighborhood preservation and economic development goals of the City, after providing notice of the proposed neighborhood enterprise zone to allow taxing units in the City, and before the adoption of a Resolution designating the neighborhood enterprise zone.

WHEREAS, on or about June 26, 2024, the Clerk's Office of the City provided written notice of the intent to adopt a neighborhood enterprise zone along with a proposed map and list of all parcels within the zone to the Oakland County Assessor's Office and all taxing units that levy ad valorem property taxes in the proposed neighborhood enterprise zone.

WHEREAS, MCL 207.773(3) requires the City to adopt a statement of the City's goals, objectives, and policies relative to the maintenance, preservation, improvement and development of housing for all persons, regardless of income level, living within the proposed neighborhood enterprise zone, prior to the adoption of a Resolution designating the neighborhood enterprise zone.

NOW THEREFORE BE IT RESOLVED that the Pontiac City Council finds that the proposed neighborhood enterprise zone is consistent with the master plan of the City, and the neighborhood preservation and economic development goals of the City, in accordance with MCL 207.773(3). BE IT FURTHER RESOLVED that the City Council states that the City's goals, objectives, and policies

relative to the maintenance, preservation, improvement, and development of housing for all persons, regardless of income level, living within the proposed neighborhood enterprise zone are as follows:

The mission of the City of Pontiac in designating the neighborhood enterprise zone is to economic growth through the City by promoting business opportunities and advantages that are unique to Pontiac; identifying the needs to the business community; facilitating strategic partnerships to address those needs; encouraging job creation and growth; and/or marketing the City's unique assets to future businesses and residents. The City has previously created a home repair program which utilizes ARPA funds provided to the City to repair and rehabilitate housing for residents of the City. When used in conjunction with the neighborhood enterprise zone's tax incentives, homeowners can repair and rehabilitate their homes without the fear of increasing their cost of living. Similarly, the City Council has found that the City is in great need of increased housing. By designating this neighborhood enterprise zone, the City is incentivizing development of new housing and rehabilitation of existing housing to accomplish this goal.

Purchasing, Section 2-517, 2-518, and 2-519 about major purchases; and NOW THEREFORE BE IT RESOLVED that the City Council authorizes the purchase and installation of mounted equipment on six newly pick-up trucks for an amount Not-to-Exceed \$34,666 for the American Rescue Plan Act General Ledger account 285-818-977.002-ARPPRK.
