Applications for Dale I & II Apartments will be accepted <u>online only</u>. Applicants will be placed on the <u>preliminary waiting list according to the Agency preference(s) and a lottery system</u>. The lottery system will randomly pick 200 applicants for each bedroom size. Once each applicant has been randomly assigned a number, the applications will be placed on the preliminary waitlist in order of the assigned numbers and preferences. Upon acceptance of application, applicants will be given a confirmation number. Applicants are encouraged to print the confirmation page containing this number, or document the confirmation number, as it will be used to identify your application.
