Based upon the evidence presented and the testimony of the Code Enforcement Officer concerning the condition(s) of the premise(s) owned by <u>Matthew R. Elliott and Carleen Elliott</u>, located at 38 Elizabeth Street, I hereby by move:

- That the Council adjudge these properties to be a nuisance and dangerous to life or property;
- That the Council make and record an Order stating that the owner shall, within (30) days of service of this Order, abate all conditions creating a nuisance or dangerous condition to the satisfaction of the Code Enforcement Officer;
- That should the owner fail to comply with the specified time, the owner shall be assessed a civil penalty of \$100.00 per day and the City Council further directs the City Manager to cause the structure(s) to be demolished and removed. The cost of such demolition and removal shall be charged against the real estate upon which the structure sets and shall constitute a lien on such real estate.

Maine Revised Statutes

Title 17: CRIMES

Chapter 91: NUISANCES

§2851. DANGEROUS BUILDINGS

The municipal officers in the case of a municipality or the county commissioners in the case of the unorganized or deorganized areas in their county may after notice pursuant to section 2857 and hearing adjudge a building to be a nuisance or dangerous, in accordance with subsection 2-A, and may make and record an order, in accordance with subsection 3, prescribing what disposal must be made of that building. The order may allow for delay of disposal if the owner or party in interest has demonstrated the ability and willingness to satisfactorily rehabilitate the building. If an appeal pursuant to section 2852 is not filed or, if an appeal pursuant to section 2852 is filed and the Superior Court does not order, stay or overturn the order to dispose of the building, the municipal officers or the county commissioners shall cause the nuisance to be abated or removed in compliance with the order. For the purposes of this subchapter, "building" means a building or structure or any portion of a building or structure or any wharf, pier, pilings or any portion of a wharf, pier or pilings thereof that is or was located on or extending from land within the boundaries of the municipality or the unorganized or deorganized area, as measured from low water mark, and "parties in interest" has the same meaning as in Title 14, section 6321. [2017, c. 136, §1 (NEW).]

2-A. Standard. To adjudge a building to be a nuisance or dangerous, the municipal officers or county commissioners must find that the building is structurally unsafe, unstable or unsanitary; constitutes a fire hazard; is unsuitable or improper for the use or occupancy to which it is put; constitutes a hazard to health or safety because of inadequate maintenance, dilapidation. obsolescence or abandonment; or is otherwise dangerous to life or property.

3. Recording of the order. An order made by the municipal officers or county commissioners under this section must be recorded by the municipal or county clerk, who shall cause an attested copy to be served upon the owner and all parties in interest in the same way service of process is made in accordance with the Maine Rules of Civil Procedure. If the name or address cannot be ascertained, the clerk shall publish a copy of the order in the same manner as provided for notice in section 2857.

4. Proceedings in Superior Court. In addition to proceedings before the municipal officers or the county commissioners, the municipality or the county may seek an order of demolition by filing a complaint in the Superior Court situated in the county where the building is located. The complaint must identify the location of the property and set forth the reasons why the municipality or the county seeks its removal. Service of the complaint must be made upon the owner and parties in interest in accordance with the Maine Rules of Civil Procedure. After hearing before the court sitting without a jury, the court shall issue

an appropriate order and, if it requires removal of the building, it shall award costs as authorized by this subchapter to the municipality or the county. Appeal from a decision of the Superior Court is to the law court in accordance with the Maine Rules of Civil Procedure.

Foreclosure notices were sent to taxpayers and other interested parties on properties with 2019 Tax Liens that were unpaid as of October 16, 2021.

Attached is a list of twelve properties on which I am recommending the Council approve Waivers of Foreclosure. The Waiver simply waives the current automatic foreclosure it does not waive the taxes due or the right of the City to foreclose in the future.

Properties 1 and 2 were a Junkyard and the State of Maine DEP is concerned about the Environmental Hazardous materials remaining in the land.

Properties 3 thru 12 are all older mobile homes on rented property. In my opinion it would be wise for the City to waive foreclosure on these properties causing the responsibility of cleaning up the lots to remain with the land owner. Without a waiver, the City will own the properties as of December 16th, 2021 at 4:30 pm. It would then be the responsibility of the City to dispose of the mobile home and the taxpayer would be relieved of any liability at that time. The owner of the real estate would get a cleared mobile home lot at no cost to him and would be entitled to receive lot rent from the City from the date of foreclosure until the date of demolition.

Demolition costs for a mobile home is minimally \$5,000.

If the 'Waiver of Foreclosure' is issued, the City:

- Will not foreclose on, and therefore own, and possibly owe lot rent on undesirable properties, and
- Will not be required to evict individuals and become a landlord until the eviction takes place if the home was occupied or there was a rental situation.
- Is not waiving the taxes due, only foreclosure for the current year; if they don't follow through we can foreclose in December 16, 2022.

Properties 13 thru 14 I have set up payment arrangements and the parties have been paying faithfully each month.

Attachment A is a worksheet listing those properties being recommended for Waiver of Foreclosure.


Per your request, I am including answers to common questions the Council may have heard from the community to aid in their discussion of the Marijuana Ordinance.

- We have too many pot stores. Can the City prohibit or limit Medical Marijuana Retail Establishments?
 - No, Per Title 22 §2429-D. Local regulation Pursuant to the home rule authority granted under the Constitution of Maine, Article VIII, Part Second and Title 30-A, section 3001, a municipality may regulate registered caregivers, caregiver retail stores operating pursuant to section 2423-A, subsection 2, paragraph P, registered dispensaries, marijuana testing facilities and manufacturing facilities. [PL 2019, c. 217, §5 (AMD).] A municipality may not: 1. Registered caregivers. Prohibit or limit the number of registered caregivers;
- What about prohibiting or limiting Adult Recreation Marijuana Establishments?
 - Yes, Per Title 28-B §401. Municipal regulation of marijuana establishments generally In accordance with the applicable provisions of this subchapter and pursuant to the home rule authority granted under the Constitution of Maine, Article VIII, Part Second and Title 30-A, section 3001, a municipality may regulate marijuana establishments within the municipality, including, but not limited to, adoption of the following types of regulations and restrictions. [PL 2017, c. 409, Pt. A, §6 (NEW).]
 - 1. Land use regulations. A municipality may adopt an ordinance providing land use regulations applicable to marijuana establishments within the municipality.
 - 2. General authorization or limitation of marijuana establishments. A municipality may adopt an ordinance generally authorizing the operation of some or all types of marijuana establishments within the municipality. A municipality may adopt an ordinance limiting the number of any type of marijuana establishment that may be authorized to operate within the municipality.


- What is the breakdown of marijuana stores in PI?
 - Medical Retail Caregiver Stores at the end of 2021 account for two-thirds of all retail stores in PI.
 - 4 Medical Caregiver Stores & 2 Recreational Retail Stores, One Medical Cultivation Facility
 - Cloud 9 28 Houlton Road Not open yet, but approved by Council will be Medical Caregiver
 - Northern Euphoria, LLC 11 Davis Street Medical Cultivation
 - Northern Maine Flower 540 Main Street Medical Caregiver
 - Star City Wellness 694 Main Street Medical Caregiver
 - Richardson's Remedies 719 Main Street Medical Caregiver
 - Royal Leaf Apothecary 415 Main Street Adult Recreational
 - Full Bloom Cannabis 483 Main Street Adult Recreational
 - o In 2020, there 106 registered caregivers (can grow and sell) in Aroostook County. PI has approximately 3.77% of the County's total registered caregivers.
- What about the negative impacts to children and youth?
 - o Per state law and rulemaking, qualifying patients under 18 may be issued a medical card only after obtaining written consent by parent or legal guardian. *The City cannot regulate this.*
 - o PI Ordinance has 1000 ft buffer for the location of any school. 150' from daycares, pre-schools, etc.
- Can marijuana businesses offer delivery service?
 - Only Medical Caregivers can offer delivery service per state law. Our ordinance allows for delivery only by Medical Caregivers per page 11 Section 7 of the City's Ordinance. In addition, the State is implementing seed to sale software to track all transactions to comply with state law.
- What towns have marijuana ordinances in Central Aroostook County
 - Caribou In zoning, prohibit recreational marijuana, regulate medical dispensaries and medical retail establishments
 - o Easton prohibits adult retail marijuana stores and social clubs
 - o Chapman, Castle Hill & Mapleton None/Could not find
 - o Mars Hill None/ Could not find
 - o Washburn Adopted similar ordinance to PI (setback for schools 500 ft)
 - o Fort Fairfield None / Could not find
