



TOWN OF PUTNEY COMMITTEE MEMBERSHIP POLICY

Section 1: Title and Authority

This policy shall be known as the Town of Putney Committee Membership Policy. It has been adopted by the Town of Putney Selectboard pursuant to 24 V.S.A § 872.

The Selectboard reserves the right to amend any of the provisions of this policy for any reason at any time, with or without notice.

Section 2: Application


This policy shall be applicable to all Selectboard appointed Advisory Committees on or after August 14, 2021 unless superseded by statute.

Section 3: Committee Membership and Appointment

Members of Town Advisory Committees shall be appointed annually for a one-year term beginning and ending on or around Town Meeting Day. Midyear appointees shall serve a partial year term through Town Meeting Day. A prospective member must submit a letter of interest and be interviewed by the Selectboard of the Town of Putney before being appointed by the Selectboard. The committee and its members are subject to all applicable public meeting laws including Vermont's Open Meeting Law and the Public Records Act. Members may be removed at any time and for any reason or no reason at all by majority vote of the total membership of the Selectboard.
