ELIGIBILITY

City Council Members must be at least 18 years of age and a registered voter in the City of Rancho Mirage.

APPLICATION FILING REQUIREMENTS

Completed applications will be accepted in the City Clerk's office until 5:00 P.M. on November 13, 2024. Please feel free to include additional information with your application. Your application must be signed and include your current registered voter information. Voter registration will be confirmed. FINANCIAL INTERESTS

Council Members are required to complete and file a Form 700 Statement of Economic Interests disclosing various financial interests.

PUBLIC INFORMATION

Becoming a candidate for public office means that information about you will become a matter of public record immediately. This includes any and all documents submitted to the City during the course of the application period. As such, these documents must, by law, be available to the public for inspection and/or copying.

GENERAL INFORMATION REGARDING THE POSITION

Regular meetings of the City Council are held on the first and third Thursdays of each month at 1:00 P.M. Additional meetings may be called as necessary. In addition to regular Council business, the individual selected must be available to actively participate as a Council liaison to numerous external agencies and organizations.

The City of Rancho Mirage operates under a council-manager form of government. The five City Council Members are elected to four years terms. The Mayor and Mayor Pro Tem are appointed every year on a rotational basis by the City Council. The City Council is the legislative body responsible for the overall policies of the City. The Council makes all policy determinations through enactment of ordinances and resolutions and has final authority in the implementation of these policies. The Council determines how the City will obtain and spend funds and approves the City's budget. The City Council appoints the City Manager, City Attorney, and City Clerk, as well as members of the City's various advisory boards and commissions.
