2024 Hauler Permit Policies

Definitions and Payments

Minor Haulers is defined as any person who collects and / or transports solid waste generated within the County as a result of their own business. Minor Haulers cannot use a residential sticker to dispose of waste.

- Minor Haulers are required to pay a \$60 application processing fee (includes 1 vehicle) & \$20 per additional vehicle fee, before a permit is issued.

Major Hauler is defined as any person who collects waste generated within Oswego County as a commercial endeavor and any person who collects from multiple locations and/or transports solid waste in significant quantity on a daily or weekly basis; and/or transports waste to a County Solid Waste facility that requires special handling.

- Major are required to pay a \$110 application processing fee (includes 1 vehicle) & \$20 per additional vehicle fee, before a permit is issued.

Application can only be processed at the Solid Waste Main Office, 3125 Rte. 3, Fulton, NY 13069.

- When your major/minor hauler permit application is approved, you have established a billing account.

- There is a \$20 fee for all returned (bounced) checks. Hauler accounts will be locked until the returned check clears and \$20 fee is paid.

- Application fee, additional vehicle fee and account payments can be made at all transfer stations/scale houses and the Solid Waste main office. Payment can be made with cash, check or credit card (\$10.00-\$42.00 a \$1.00 fee applies. From \$43.00 and up a 2.35% fee applies).

- Accounts are invoiced monthly, and payment is due in full by the last weekday of the month. Outstanding balances will be charged a late fee at the rate of 2% per month.

- Accounts past due two billing cycles or more (61-90 days), will have privileges to use Solid Waste Facilities revoked.

- Accounts past due 120 days are sent to the Oswego County Attorney for legal prosecution. Account holder will be responsible for paying all fees associated with prosecution.

- Permits expiration extensions will not be given for any reason and account will have privileges to use all Solid Waste facilities revoked.

Penalties

- Business use of Residential Sticker:
1st Offense \$100, Recurrent \$500
- Multiple household use of Residential Sticker:
1st Offense \$50, Recurrent \$150
- Untarped Loads: \$50 each time
- Disposing of source separated recyclables/ mixing same with trash (residential haulers):
1st Offense \$500, Recurrent \$1,000
- Failure to provide for recyclable collection:
1st Offense \$250, Recurrent \$500
- Roll-off taken for out of county disposal:
1st Offense \$250, Recurrent \$1,000
- Residential/Commercial packer truck taken for out of county disposal:
1st Offense \$250, Recurrent \$1,000
- Trailer taken for out of county disposal:
1st Offense \$500, Recurrent \$2,000

Waste Disposal

- All loads entering facilities must be weighed in and out.
- All loads must be properly secured / covered.
- All haulers **must follow the instructions of the transfer station attendant** (Local Law II of 2011). No waste generated from outside of Oswego County will be accepted for disposal.
- Sealed containers and liquid wastes are NOT accepted for disposal.
- Clean fill (concrete, asphalt, stone, & brick) is accepted for disposal at the Bristol Hill Landfill ONLY.
- Loads must be sorted (i.e. no recyclables mixed with wastes, or vice versa) or they will not be accepted for disposal.
- All waste generated in Oswego County MUST be disposed at Oswego County Solid Waste Facilities.

Mix papers and containers together

Must be rinsed and dry

Refrigerated Units - CFC

A \$15.00 CFC sticker needs to be purchased for each refrigerated unit delivered that does not have an Environmental Protection Agency (EPA) certification sticker. CFC stickers can be charged to an account and purchased in advance.

Other chargeable waste

Compost: \$30/ton (including leaves, grass, hay & plant waste)
Must be free of bags, twine & plastic containers

Fish Waste: \$85/ton at Bristol Hill Landfill

Tree Waste: \$50/ton at Transfer Station

No Charge for Brush (under 6") & Wood Chips

(Excludes Oswego Transfer Station)

New Charge:

Mattresses: \$15.00 Per Unit

Box Spring: \$15.00 Per Unit

Business Hazardous Waste that meets the Conditionally Exempt Small Quantity Generator (CESQG) requirements may use our facility from May through September, on Wednesdays. For a quote or more information please contact us at (315) 591-9200.
