NYS David W. Mills Submerged Cultural Preserve and Dive Site.

Located along the easternmost Great Lake, Oswego County has a rich maritime history. It hosts a bevy of lakeshore and underwater assets that harken back to a time when commercial shipping drove the development of Lake Ontario and other Great Lakes communities. New York waterways have been heavily navigated for travel, transport and recreation for centuries, but commerce really flourished from the 18th century into the early 20th century. At that point, railway and air travel became the dominant means of moving people and goods.

Known for its unpredictable and often unforgiving conditions, Lake Ontario can rapidly evolve from an uncanny calmness to a sinister storm in a matter of moments. Those unruly waters, together with a vast commercial shipping industry, led to hundreds of shipwrecks over the centuries. The lake's cool, clear waters have preserved many of the wreckages in pristine condition.

More than a dozen known shipwrecks line the Lake Ontario shoreline in Oswego County, and historical records indicate more than a dozen others could be present in the area.

The *David W. Mills* was a typical Great Lakes steam-powered cargo vessel built in Cleveland, Ohio in the late 1800s. It operated as a bulk carrier on the Great Lakes before running aground on a shoal in August 1919 carrying a load of coal from Montreal to Sodus, New York. Thick summer smog fueled by Canadian wildfires hindered visibility and led to the grounding. Captain and crew remained onboard until insurance underwriters visited the wreck, but multiple attempts to dislodge the ship were unsuccessful and a powerful storm eventually tore the 925-ton vessel to pieces. The 202-foot steamship sits scattered across a roughly 180,000-square-foot area on the bottom of Lake Ontario about four miles west of Oswego.

In May 2000, the *David W. Mills* was designated New York's first Submerged Cultural Preserve and Dive Site in Lake Ontario.
