# History Comes Alive in Oswego County!

Oswego County is rich in history.

As the nation celebrates its Semiquincentennial (250th) anniversary of the United States Declaration of Independence, we pause to remember the people and events that helped to form our great nation.

Even before Fort Ontario was built, there were two forts at the mouth of the Oswego River to protect the lucrative fur trade as far back as 1727. Oswego is the site of three battles during the French and Indian War and two War of 1812 battles. In 1756, during the French and Indian War, Fort Oswego was taken by the French under General Montcalm. The current Fort Ontario built in the early 1840s is the fourth fort built at the mouth of the Oswego River.

Throughout the Revolutionary War, the fort was held by the British. Few Americans settled in the Oswego area because of the danger from the British and their Native American allies. As a result, areas of the county farther from Oswego were settled earlier. Only one Revolutionary War patriot was found who lived in Oswego County during the war. He was captured by the Indians and adopted by a squaw who had lost a son. He lived in the Oswego area for two years before escaping from Fort Oswego. There have been over 370 patriots identified who came to Oswego County after the Revolutionary War. Some of them participated in a failed attempt to take Fort Oswego during one of our famous lake effect snowstorms (General Washington's last order of the war). The largest number of known patriots lived in the Richland area. The British did not leave the fort until 1796, nine years after the end of the war.

During the Civil War, Oswego County contributed more than its fair share of men to fight on the side of the Union. The Oswego County 147th Regiment were among the first in battle at Gettysburg and fought all three days. Of 380 men, 212 were killed or wounded at Gettysburg.

In 2024, The Lake Ontario National Marine Sanctuary, which lays partially in Oswego County, was designated. The sanctuary preserves forgotten shipwrecks and archaeological resources hidden in the cold fresh waters of a portion of Lake Ontario.

Oswego County has several museums and historical societies who collect, preserve and celebrate the history in our own backyard.
