COUNTY OF OSWEGO LOCAL LAW No.: 4 OF 2023 ENTITLED A LOCAL LAW

AMENDING LOCAL LAW NUMBER 1 OF 2022 REGARDING INCOME QUALIFICATIONS FOR PARTIAL TAX EXEMPTIONS ON CERTAIN REAL PROPERTY OWNED BY ELIGIBLE PERSONS 65 YEARS OF AGE OR OVER

BE IT ENACTED by the County Legislature of the County of Oswego as follows:

Section I. Title and Legislative Findings.

- (a) The Oswego County Legislature has, heretofore, passed County of Oswego Local Law Number 1 of 2022 concerning granting a partial real property tax exemption for eligible persons sixty-five (65) years of age or older, based upon certain income qualifications, pursuant to Real Property Tax Law §467, as amended. This Local Law shall be titled as follows: "A Local Law Amending Local Law Number 1 of 2022 Regarding Income Qualifications for Partial Tax Exemptions on Certain Real Property Owned By Eligible Persons 65 Years of Age or Over."
- (b) This body finds it both necessary and convenient to amend section 3 of Local Law Number 1 of 2022, as concerns income qualifications only, in light of changes to Real Property Tax Law §467 while continuing the rest and remainder of Local Law Number 1 of 2022 in full force and effect.

Section 2. Amendment to Section 3 of Local Law Number 1 of 2022.

Section 3 of Local Law Number 1 of 2022 be, and is hereby, **AMENDED** in its entirety to read as follows:

Section 3. Income Qualifications.

- (a) The "applicable income tax year" as used herein shall mean the second most recent calendar year.
- (b) The term "income" as defined herein shall mean "adjusted gross income" for federal income tax purposes as reported on an applicant's federal or state income tax return for the applicable income tax year, as defined in and as is subject to any subsequent amendments to Real Property Tax Law§ 467(3)(iv), et seq.; provided, however, if no such tax return was filed for the applicable income tax year, the applicant's income shall be determined based on the amounts that would have so been reported if such a return had been filed; and provided further, that when determining income for purposes of this section, the following conditions shall be applicable:
 - (1) any Social Security benefits not included in such federal adjusted gross income shall be considered income;

- (2) distributions received from an individual retirement account or individual retirement annuity that were included in the applicant's federal adjusted gross income shall be considered income and shall not be excluded;
- (3) any tax-exempt interest or dividends that were excluded from the applicant's federal adjusted gross income shall be considered income;
- (4) any losses that were applied to reduce the applicant's federal adjusted gross income (AGI) shall be subject to the following limitations:
 - (A) the net amount of loss reported on federal schedules C, D, E, or F shall not exceed three thousand dollars (\$3,000) per any given schedule,
 - (B) the net amount of any other separate category of loss shall not exceed three thousand dollars (\$3,000), and
 - (C) the aggregate amount of all losses shall not exceed fifteen thousand dollars (\$15,000).
- (c) Where title is vested in a married person, the combined income of such person and such person's spouse may not exceed such sum, except where one spouse or ex-spouse is absent from the property as provided in subparagraph (c)(2) of Section 4 of this local law, then only the income of the spouse or ex-spouse residing on the property shall be considered and may not exceed such sum.
- (d) No exemption shall be granted hereunder if the income of the owner or the combined income of the owners of the property for the applicable income tax year exceeds the sum provided in Section 2 of this local law.

Section 3. Severability.

If the provisions of any section, subsection, paragraph, sentence, subdivision, clause, phrase or provision of this local law shall be, for any reason, held or adjudged invalid or unconstitutional by a court of competent jurisdiction, such order or judgment shall not affect or invalidate the validity and enforceability of the remainder of any section, subsection, paragraph, sentence, subdivision, clause, phrase or provision of this local law.

Section 4. SEQRA Determination.

This Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this local law constitutes a Type II action pursuant to Section 617.5(c) (26), and (33) of Title 6 of the New York Code of Rules and Regulation (6 NYCRR) and within the meaning of Section 8-0109(2) of the New York State Environmental Conservation Law as a promulgation of regulations, rules, policies,

procedures, and legislative decisions in connection with continuing agency administration, management and information collection. The Clerk of the County Legislature be, and is hereby, directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this law.

Section 5. Effective Date.

This local law shall take effect immediately upon its adoption.

COUNTY OF OSWEGO LOCAL LAW No. 8 OF 2023 A LOCAL LAW ESTABLISHING THE DEPARTMENT OF WORKFORCE DEVELOPMENT

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF OSWEGO AS FOLLOWS:

Section 1. Legislative Intent.

The County Legislature of the County of Oswego, in its continuing efforts to bring about the most efficient manner of providing services to residents of this County finds and determines that the increasingly difficult and complex task of coordinating and implementing a variety of workforce development programs across several county departments is best administered by a separate department of County government which can liaise and work with the Oswego County Workforce Development Board, a separate entity required by federal and state law, other county departments and local residents and employers alike. The Legislature is aware that, while the planned investment in the Micron facility to be built in Onondaga County is a potential benefit to the region, it brings with it significant challenges for existing industries, businesses and employers to recruit and retain their present workforce and maintain jobs within Oswego County as well as a new need to prepare county residents with the requisite skills and training to also fill available jobs at and/or related to Micron. Oswego County has unique industries, resources, employers and economic development needs in relation to other counties within the Central New York region. The County Legislature finds and determines that the creation of a Department of Workforce Development is in the best interests of the County of Oswego and, accordingly, necessary and proper.

Section 2. Department of Workforce Development Established.

Pursuant to the powers enjoyed by the County Legislature under NEW YORK STATE MUNICIPAL HOME RULE LAW§10 concerning the creation of departments of its government and the prescription or modification of their powers and duties, the Oswego County Department of Workforce Development is hereby created and established. Said department shall be under the day-to-day supervision and oversight of the Director of Workforce Development whom shall be appointed by the County Legislature for a term of two (2) years to coincide with the term of the County Legislature. The Director of Workforce Development shall be responsible for the management and operation of the Department of Workforce Development (hereinafter "Department") and shall possess all the powers and duties necessary and proper to carry out the functions of the Department as set forth herein and such other responsibilities as may, from time to time, be required by resolution of the Oswego County Workforce Development Board and/or the County

Legislature or as otherwise provided for by law.

Section 3. Director of the Department of Workforce Development; Duties.

The Director of Workforce Development, within the budgetary appropriation for the Department, shall:

- (a) Be the chief administrative official of the administrative unit comprising the Department and shall be responsible for all programs, activities and projects undertaken within or by the Department.
- Have charge of and control of, under the general oversight of the County (b) Administrator and County Legislature, employees within the Department. The Director of Workforce Development shall have the power to appoint, hire, suspend, lay-off, discipline and/or remove any employee of the Department subject to the provisions of any applicable collective bargaining agreement, NEW YORK STATE CIVIL SERVICE LAW and the Oswego County Rules for the Classified Civil Service. The Director shall establish and oversee Departmental policies, as may be necessary or required, to promote the interests and efficient operation of the Department. The Director shall have and enjoy the power to assign and reassign powers and duties to Departmental employees, as may be necessary and convenient, for Departmental needs and operations subject to the provisions of any applicable collective bargaining agreement, NEW YORK STATE CIVIL SERVICE LAW and the Oswego County Rules for the Classified Civil Service. The Director of Workforce Development shall manage the Department in accordance with this enactment, sound management principles, Oswego County administrative policies and procedures, New York STATE CIVIL SERVICE LAW and all other applicable state and federal laws, rules and regulations which may be applicable to the Department and its operations.
- (c) Prepare statistical and other reports as required by the county, and/or state or federal government, and present same as may be necessary.
- (d) Assign professional, technical and/or clerical personnel to assist with Department duties and oversee all Department contracts and accounts.
- (e) Exercise sound judgment and keep sensitive information provided by local businesses and employers regarding their individual employment needs, changes in markets and other business information in confidence when and where required.
- (f) Develop policies and procedures to enhance county workforce development and economic development goals within the County of Oswego to benefit local industries, employers and residents alike and work with other economic development agencies and the Oswego County Workforce Development Board in furtherance of same.

- (g) Apply for, manage and/or administer grant applications for the Department independently and/or in conjunction with other county departments and/or the Oswego County Workforce Development Board, local businesses and/or other entities.
- (h) Assist the Social Services District comprising the County of Oswego with the implementation of its biennial plan for the provision of education, work, employment and training and supportive services related to the operation of work activity programs pursuant to New York State Social Services Law §333, the local biennial plan required to be filed thereunder and/or as otherwise provided for in Title 9-B of the New York State Social Services Law.
- (i) Separately serve as Executive Director of the Oswego County Workforce Development Board, without additional compensation, and provide assistance and county resources as may be requested or required by the Oswego County Workforce Development Board including, but not limited to, assisting the board in developing strategic plans to match employers with qualified candidates and in delivering skill-based programs to job-seekers through One-Stop Career Centers. Nothing herein prevents or precludes the Department from contracting with, or assisting, the Oswego County Workforce Development Board in carrying-out its duties.
- (j) Perform such other duties, and make such reports, as may be required by the County Legislature including an annual report to the County Legislature of the Department's activities. The Department shall constitute an administrative unit of the county and the Director is required to develop and manage its annual budget and to submit to the county's budget officer an estimate of revenues and expenditures of such administrative unit for the ensuing fiscal year in accordance with NEW YORK STATE COUNTY LAW §353.
- (k) Report to the Economic Development & Planning Committee of the County Legislature, or any successor legislative committee by any other name, as well as the County Administrator regarding day-to-day activities and operations. The Department shall also, separately, keep the Workforce Development Board of Oswego County apprised of its general activities on at least a quarterly basis.
- (1) Possess such other and further powers and duties as required by law and/or as authorized by the County Legislature.

Pursuant to New York State Municipal Home Rule Law§10(a)(1), the title of Director of the Department of Workforce Development shall be placed in the exempt class of the Civil Service due to the unique duties pertaining to Oswego County employers and businesses, the title's handling of confidential information from private industry and employers within the county and from other county agencies. The County Legislature finds and determines that an individual holding the title of Director must possesses requisite skills and experience to best serve the needs of the County of Oswego, its employers and residents, and to promote the county's economic development needs, which are distinct from surrounding counties in many respects. The Director of the Department of Workforce Development shall have a salary fixed by the County Legislature in the annual budget or by resolution at time of appointment. The Director of the Department of Workforce Development shall enjoy the benefits of the Management Compensation Plan.

Section 5. Oswego County Workforce Development Board; Separate and Distinct.

Although the Department will work closely with, and provide assistance to, the Oswego County Workforce Development Board, nothing herein shall impair the independence or operation of, or shall conflict with the powers possessed by, the Oswego County Workforce Development Board under 20 CFR Part 678 and 20 CFR Part 679, concerning Workforce Innovation and Opportunity Act Local Governance, Title 1 funded roles, the local plan and/or as otherwise provided for by law, rule or regulation. Oswego County Workforce Development Board operations and accounts shall continue to be separate and distinct from the Department as provided for by law. The Department may, however, act as the repository for the Oswego County Workforce Development Board's papers and minutes as requested or required. The Department may also enter into agreements with the Oswego County Workforce Development Board.

Section 6. SEQRA Determination.

The County Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this local law constitutes a Type II action pursuant to §§ 617.5(c)(26) and (33) of Title 6 of the New York Code of Rules and Regulations (6 NYCRR) and within the meaning of §8-0109(2) of the New York State Environmental Conservation Law as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with routine and continuing agency administration and management. The Clerk of the Legislature is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance as, may be necessary, in accordance with this local law.

Section 7. Severability.

If any clause, sentence, paragraph, section, subdivision, or other part of this local law, as written or in its application, shall be inconsistent with any federal or state statute, law, regulation or rule then the federal or state statute, law, regulation, or rule shall prevail. If any clause, sentence, paragraph, section, subdivision, or other part of this local law or its application shall be adjudged by a Court of competent jurisdiction to be invalid or unconstitutional, such order,

judgment or legislation shall not affect, impair, or invalidate the remainder of the local law which shall remain in full force and effect except as limited such order or judgment.

Section 8. Effective Date.

This Local Law shall take effect upon its adoption and being duly filed with the New York Secretary of State and Oswego County Clerk as provided by the New York State Municipal Home Rule Law.

OSWEGO COUNTY BUSINESS EXPANSION CENTER LEASE AGREEMENT

(One-Year Extension)

This Agreement, extending a Lease Agreement further described herein, is made effective the 1st day of January, 2024 between **OPERATION OSWEGO COUNTY, INC.** (OOC) of 44 West Bridge Street, Oswego, New York 13126 (the "Landlord") and **COUNTY OF OSWEGO** of 46 East Bridge Street, Oswego, New York 13126 (the "Tenant").

- 1. Third Extension of Lease Agreement. Landlord and Tenant desire to extend the Lease Agreement for a period of one year, commencing January 1, 2024, and ending on December 31, 2024, unless sooner terminated pursuant to the provisions of the Lease Agreement. The terms and conditions contained in the Lease Agreement shall be extended in full, unless otherwise stated herein.
- 2. Entire Agreement. This Lease contains the entire agreement of the parties.
- 3. **Modifications**. This Lease may not be modified except in writing executed by both parties.
- 4. No Waiver. No provision of this Lease shall be effectively waived unless in writing signed by Landlord. The failure of Landlord to seek redress for a violation of this Lease, or to insist upon the Tenant's performance of any provision of this

Lease, shall not preclude Landlord from seeking redress for a subsequent violation or from insisting upon Tenant's subsequent performance.

5. Notices. Any notice, demand, or request, required or agreed to be given hereunder by either party, shall be sufficiently given or served if in writing and signed by the party giving it, and mailed to the party to be notified as follows:

E911 Overtime budget mod request 10/16/2023

2023 continues to be a difficult year with staffing for the E911 Department. E911 recently has 11 full time telecommunicator positions open. The increase in vacancies have compounded our overtime costs unexpectedly in the last couple months to maintain appropriate coverage of the department. We are half way through a recruit class of 6 people for full time positions which will help with overtime once they complete the recruit academy and are assigned to a shift in late November.

I am requesting a budget modification from salaries and wages to overtime to cover the required overtime that E911 is incurring. I am requesting to move \$60,000 to the overtime budget line A3020-512000 from salaries and wages line A3020-511000. The vacancies will allow for this amount to be moved and keep the budget impact at zero. This amount should cover overtime expenses for the remainder of 2023 barring any further major impacts to staffing.

PURPOSE:

INFORMATIONAL MEMORANDUM

SUBJECT: RFP 23-MH-001 Five Awards

BACKGROUND: NYS OASAS is providing the Division of Mental Hygiene, Local Governmental Unit for Oswego County, with dollars for the LGU to fund services and interventions at its discretion, based on the allowable use of funds per Settlement and Statute. Identification of local priorities has been guided by the Mental Hygiene Local Services Plan as well as engagement in local planning and prioritization activities of the Oswego County Community Services Board, County Departments, and Community Stakeholders.

Eleven proposals were received. Ten proposals were submitted by applicants meeting the eligibility criteria.

Five proposals are being recommended for contract awards as detailed below.

- 1. Farnham's Deficit Funding proposal meets the intent of the RFP by ensuring the successful expansion of essential outpatient treatment services for OUD/SUD in the Northeast area of the County. This one-time award will provide fiscal stability to cover the deficit incurred in 2022 due to the caseload build and resulting low revenue. 2023 and future years are projected to be self-sustaining with revenue generated from billable services. The recommended award is for one-time funding in the amount of \$110,000 payable in 2023.
- 2. Farnham's proposal for Empowering the Human Services Workforce: Enhancing CASAC and CRPA Certification through Salary-Funded Training and Retention Initiatives meets the intent of the RFP by implementing an innovative strategy to address staff recruitment, development, and retention. The proposal aims to increase a trained workforce and provide career advancement opportunities for existing employees in critical direct service program areas experiencing workforce issues. The recommended award is for a three-year contract in the amount of \$100,000 to begin January 1, 2024 and end December 31, 2026.

- 3. The Desens House proposal aims to support their newly opened long-term Residence Program and Peer Recovery Coach service. The proposal meets the intent of the RFP by implementing an innovative model for women working to overcome addiction. There are no long-term residential programs for women with SUD in Oswego Co. The recommended award is for a one-year contract in the amount of \$51,670 to begin January 1, 2024 and renewable for an additional two years in the amount of \$50,000 each year.
- 4. Child Advocacy Center of Oswego County proposal is for a full-time clinician dedicated to providing trauma therapy to parents/caregivers with significant Adverse Childhood Experiences (ACEs). A strong correlation exists between the occurrence of ACEs and the likelihood of developing substance use disorders. The proposal meets the intent of the RFP by slowing the impact of generational trauma, decreasing risk of Adverse Childhood Experiences for children in their care, and thereby reducing the number of youth who might develop alcohol and substance use disorders later in life. The recommended award is for a one-year contract in the amount of \$108,936 to begin January 1, 2024 and renewable for an additional four years in the amount of \$105,354 each year.
- 5. ConnexCare proposal to enhance their Substance Use Disorder Treatment Program and Primary Care Services meets the intent of the RFP by adding interventions, supports, and best practices to address the significant county issue of newborns with withdrawal symptoms due to maternal use of drugs. Oswego County has the second highest rate in NYS of newborn discharges who are opioid dependent. The recommended award is for a one-year contract in the amount of \$122,584 to begin January 1, 2024 and renewable for an additional four years in the amount of \$116,150 each year.

FISCAL IMPACT: There is no fiscal impact. No budget modification is needed. Revenue (A4310. 434900.NYSOP) and expense (A4310.545500.NYSOP) lines were created in the Mental Hygiene budget upon receipt of the funding allocation to the Division (Resolution No.051 dated 3/9/2023). Reimbursement is as follows: 100% Opioid Settlement Fund – Regional Abatement dollars. There is no local share.

RECOMMENDATION: The Department of Social Services recommends that the Human Services Committee, and the Legislature approve these five awards as detailed above.

BACKGROUND: The NYS Office of Mental Health (OMH) introduced Supported Housing in 1990 as an initiative to facilitate an increase in long term/permanent housing options for people with mental illness coupled with an individual support services to help them succeed. Supported Housing, when provided with non-residential and other complementary mental health services, can meet the needs of many individuals who have multiple service requirements. The goal is to support individuals to live in their own apartments of their choosing and to fully participate in the community. A total of 65 OMH Supported Housing units are allocated for Oswego County and for long term / permanent housing. Long term/permanent housing is considered community-based housing without a designated length of stay where the recipient has a leased or subleased apartment unit.

OCO is the current contractor for this service. OCO has successfully operated the program in compliance with the NYS OMH Guidelines in partnership with the Division of Mental Hygiene. OCO's proposal meets the criteria to continue the current operations.

FISCAL IMPACT: There is no fiscal impact. No budget modification is needed. Expense is included in 2024 budget request. Reimbursement is as follows: 100% NYS OMH State Aid. There is no local share.

These services include On-the-Job Training with reimbursement of new hire wages to local employers and Individual Training Accounts (ITA) Tuition for scholarships to customers enrolled in vocational training. DET has issued more ITA scholarships than originally budgeted for and less OJT requests. Therefore, this is a shift in WIOA funding for planned services. 1. Title.

This local law shall be known as "A Local Law Establishing the County Planning Department as the Sole County Planning Agency for the Purposes of Referrals under New York State General Municipal Law §§239-1, 239-m, and 239-n."

The purpose and intent of this local law is to designate and empower the Oswego County Department Community Development, Tourism and Planning (hereinafter "County Planning Department"), and any successor county planning department as the case may be, as the sole planning agency for purposes of referrals under New York State General Municipal Law §§239-1, 239-m and 239-n. This body finds and determines that coordinated handling and review by the County Planning Department of referrals results in greater consistency across jurisdictions as well as a more expedient turn around for projects and activities requiring same.

3. General Provisions.

- (a) The County Planning Department of the County of Oswego shall, for the purposes of referrals under New York State General Municipal Law §§239-l, 239-m and 239-n, be the sole county planning agency.
- (b) The County Planning Department shall enjoy, exercise and have all the powers and duties of a county planning agency under New York State General Municipal Law §§239-l, 239-m and 239-n.

Severability.

If the provisions of any section, subsection, paragraph, sentence, subdivision, clause, phrase or provision of this local law shall be, for any reason, held or adjudged invalid or unconstitutional by a court of competent jurisdiction, such order or judgment shall not affect or invalidate the validity and enforceability of the remainder of any section, subsection, paragraph, sentence, subdivision, clause, phrase or provision of this local law.

5. County Planning Board.

Notwithstanding the adoption of this local law, the Oswego County Planning Board shall continue to exist and to handle such other business as may be directed or referred by the Oswego County Legislature, and as otherwise required to come before the board, except for those matters under General Municipal Law §§239-l, 239-m and 239-n delegated to the County Planning Agency by this enactment.

6. Repealer.

Local Law Number 6 of 2003 entitled "A Local Law Establishing the Planning Director as the Sole Planning Agency for the Purposes of Referrals under New York State General Municipal Law §239-m" be and is hereby **REPEALED** upon the adoption of this local law.

7. SEQRA Determination.

This Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this local law constitutes a Type II action pursuant to Section 617.5(c)(24), (26), and (33) of Title 6 of the New York Code of Rules and Regulation (6 NYCRR) and within the meaning of Section 8-0109(2) of the New York State Environmental Conservation Law as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection. The Clerk of the County Legislature be, and is hereby, directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this law.

6. Effective Date.

This local law shall take effect immediately upon its adoption.

Summary:

The adopted 2022 budget does not include funding for spraying for mosquito control. The Health Department has an ongoing mosquito surveillance program monitoring for mosquitoes that may be carrying certain viruses that can cause diseases. This year we detected the virus that causes EEE (Eastern Equine Encephalitis) in multiple pools of mosquitoes in the Palermo and Big Bay areas of the County. With a State declaration of an Imminent Threat to Public Health for the area, steps were taken to initiate a program of spraying

to significantly reduce the population of mosquitoes in the area.

Subsequently, the Department of Environmental Conservation issued permits to allow spraying. Areas that would require spraying were identified and defined. The arrangements were made to carry out the spraying.

Fiscal Impact 2023: Increase Environmental Other Fees & Services \$38,179. This is offset by unused funds in Preschool Other Payments and Article 6 reimbursement, there will be no change to local share.

This year has been a very busy year for the Dept of Solid Waste. The following is a bird's eye overview of the Department. We purchased five new trailers to haul msw from the transfers to the ERF and Bristol Hill. We are utilizing these trailers for hauling recyclables to the Onieda Herkimer processing station as well. We purchased a used TANA landfill compactor to increase our compaction rate in the landfill, which leads me into the next topic, we had a landfill survey done to compare to with the one done in 2021. The results of the survey showed us that the landfill is filling up faster than anticipated. We started the process for Cell #5 construction, the engineering phase, which will be completed mid-January of 2024, we will then get bids on the street to determine the costs for the capital project to construct cell #5. We funded some of this through the operating budget, the rest was taken out of our fund balance. The costs for cell #5 are estimated at \$5-\$7.5 million dollars as of this writing. This will take our fund balance down significantly.

The ERF also has had a significant amount of money allocated to various projects in 2023. We rebuilt the scrubber tops. We are in the middle of the final phase of re lighting, we installed a new BRC (Baghouse Residue Conditioner) mixer in the fly ash system, we started a rear deck maintenance project as the deck is degrading. We are doing work on the water intake structure for the steam turbines, and the electrical distribution system. We are formulating a long term plan for the ERF, as it is aging and the annual maintenance costs are increasing year over year.

We also have the CSEA and OCPA contracts in negotiation (as of this writing) which will increase our labor cost. That, coupled with the material/supply cost increases (as much as 40% in some areas) have driven our operating costs up.

Due to the increased costs, we are looking at our fee structure, moving forward to continue our service to the communities and residents we serve, as well as maintain, operate, and upgrade the facilities we have.

I respectfully submit the attached fee increase for the 2024 calendar year. It should also be noted, the Department of Solid Waste has not had a fee increase in 7 years. As costs continue to rise, we may have to revisit the fee schedule in the coming years as well.

"A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR FISCAL YEAR 2024"

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF OSWEGO AS FOLLOWS:

Section 1. Title:

This local law shall be known as "A LOCAL LAW OVERRIDING THE TAX LEVY LIMIT FOR FISCAL YEAR 2024."

Section 2. Legislative Intent and Purpose

It is the intent and purpose of this Local Law to allow the County of Oswego to adopt a budget for the fiscal year commencing January 1, 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c. The intercept by the State of New York of Enhanced Federal Medical Assistance Program (eFMAP) funds intended to be sent directly to Oswego County will, alone, exceed the tax levy limit growth factor allowed by Chapter 97 of the Laws of 2011. The newly-adopted state budget removes eFMAP payments to local governments which were intended, in part, to go directly to the county to help keep costs down. Moreover, there is wide uncertainty regarding fluctuations in other state mandated programs/obligations and economic factors which could affect the actual county tax levy limit for 2024. This enactment overrides the tax levy limit and will provide the county stability and predictability regarding the 2024 annual county budget process. The County Legislature has determined that, as a result, such an override is both necessary and in the best interests of the County of Oswego whether or not the tax levy limit is actually exceeded in the adopted budget.

Section 3. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Oswego County Legislature to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of the voting strength of said body.

Section 4. Tax Levy Limit Override

The Oswego County Legislature be and is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2024 that requires a real property tax levy in excess of the

amount otherwise prescribed in General Municipal Law §3-c.

Section 5. Severability

If a court determines that any clause, sentence, paragraph, section, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 6. Effective Date

This local law shall take effect immediately and a certified copy of this local law shall be filed in the office of the Secretary of State pursuant to section 27 of the Municipal Home Rule Law.

Claimed violations of this provision shall not be subject to the grievance procedure.

4. Section 11.2 - Bereavement Leave

Revise first paragraph of Section 11.2 as follows:

Bereavement leave of twenty-one (21) hours for thirty-five (35)-hour-per-week employees and twenty- four (24) hours for forty (40)-hour-per-week employees per instance shall be granted to an employee for use upon the death of a relative as follows: mother, father, husband, wife spouse, son, daughter, ward under a legal guardian, sister, brother, grandfather, grandmother, granddaughter, and grandson, or committed partner. The above terms shall include but are not limited to natural, step, and in-law relations. Committed partners are defined as those who are financially and emotionally interdependent in a manner commonly presumed of spouses and as defined by domestic partnership as unmarried persons of the same or opposite sex with whom the employee shares a

committed relationship, who is jointly responsible for the other's welfare and financial obligations, who is at least 18 years of age, who is not related by blood, who maintains the same residence, and who is not married to or legally separated from anyone else. The County may request documentation or information to substantiate the status of a committed partner.

5. Section 3.1 - Membership:

Revise as follows:

Membership in the Association shall be voluntary, but since it is recognized that a strong and active Association with full membership and participation on the part of the employees is desirable for the collective bargaining process, the County agrees there shall be no discrimination, interference, restraint or coercion by the county or any of its agents against any employee because of his membership in the Association or because of any activities on behalf of the Association.

The Oswego County Professional Association having been recognized or certified as the exclusive representative of employees within the bargaining unit represented by this Agreement shall have dues deducted ions made from the wage or salary of employees of said bargaining unit who are not members of the Oswego County Professional Association. the amount equivalent to the dues levied by the Oswego County Professional Association. The employer shall make such deductions and transmit the amount so deducted to the Oswego County Federal Credit Union, and provide a listing of such employees to the Oswego County Professional Association Treasurer, on a payroll basis. If a member of the bargaining unit approaches the County to either begin or cease paying union dues, the County will refer the employee to the union. The County will take action based on the union's response.

Section 10.4 – Sick Leave Credit

Revise Section 10.4 as follows:

The rate of earnings is determined by the designated number of work hours per year divided by the total number days earned per payroll year (Ex. 1820 work hrs/12 days earned).

An employee hired before January 1, 2006, shall earn sick leave credit at the rate of seven (7) hours with pay-for each one hundred fifty one (151) hours of employment, not to exceed annual earnings of eighty- four (84) hours per payroll year. Comparable credit shall be provided to forty (40)-hour employees on a prorated basis to a maximum of ninety-six (96) hours per payroll year.

Effective January 1, 2023, employees hired on or after January 1, 2006 will earn seven (7) hours of sick leave credit with pay, for each one hundred and eighty two (182) hours of employment, not to exceed annual earnings of seventy (70) hours <u>per payroll year</u>. Comparable credit shall be provided to forty (40)-hour employees on a prorated basis to a maximum of eighty (80) hours <u>per payroll year</u>.

Maximum hours that may be accrued:

Thirty-five (35) hours per week

1540

Forty (40) hours per week

1760

This clause defines the method of accruing sick leave credit and does not establish a minimum standard use.

County employees who join the collective bargaining unit are not considered to be "hired" for the purposes of this provision.

Upon employees' retirement under the New York State Employees' Retirement System, the following will apply:

- A. Unused sick leave shall be applied to an employee's years of service in accordance with the provisions of section 41 J of the New York State Retirement Law and
- B. Upon written request prior to applying for retirement, After applying for retirement, and upon completion of the Request to Bank Sick Leave Form provided to you by the Human Resources Department, cash equivalent of sick time accrued as of date of retirement (limited by maximum set in 10.4) may be banked at ninety (90) percent.

Cash value will be calculated by multiplying total sick hours accrued by hourly rate as of the date of retirement multiplied by ninety (90) percent. Money so banked shall be used to offset cost of retiree's or dependent's health insurance and/or a prescription drug card. In the event a retiree dies prior to exhausting available funds, the remainder may be used to pay premiums for any COBRA benefits available to and selected by the retiree's dependents.

There shall be no direct cash payment to the retiree, retirees' dependents, or his/her estates.

Upon employee's death while still in county service, an employee's sick leave credit shall be paid to his/her beneficiary at the employee's regular compensation.

7. Section 14.4 Health and Welfare

Effective January 1, 2024 revise Article 14.4 as follows:

The County shall provide quarterly reimbursement of documented health-related expenses up to \$1,500 \$1600 maximum per year for all employees covered under this Agreement, as well as their dependents as defined by the health insurance benefit.

Effective upon ratification (insert date), employees covered under this Agreement have the option to enroll for coverage with CSEA Dental and Vision insurance plans with the bargaining unit member paying the cost. Any employee electing such coverage shall be responsible for paying one hundred percent (100%) of any applicable premium, which shall be paid through payroll deduction.

8. Section 17.4 - Discipline Procedure

Revise as follows:

The following discipline procedure for incompetence or misconduct shall apply to all employees as provided herein in lieu of the procedures specified in the Civil Service Law Section 75 and 76.

[A., B., and C. remain unchanged]

D. Suspension

Prior to service of Notice of Discipline, or prior to exhaustion or initiation by an employee of <u>Step 2</u> of the grievance procedure applicable to discipline, an employee may be suspended without pay if the appointing authority determines there is probable cause to believe that the employee's continued presence on the job represents a potential danger to persons or property or would severely interfere with operations.

Notice of Discipline must be served within seventy-two (72) hours following suspension. Suspension shall be reviewable by the arbitrator to determine whether the appointing authority had probable cause.

E. Disciplinary Process [add heading]

1. The specific acts for which discipline is being imposed and the penalty proposed shall be specified in a written <u>Notice of Discipline</u> and served on the employee personally or by registered or certified mail, return receipt requested, with a copy provided to the Association President. The notice served on the employee shall

contain a description of the acts or omissions alleged to be evidence of misconduct or incompetence including references to dates, times, and places.

In addition, the Notice of Discipline served on the employee shall be accompanied by a written statement that:

- a) the employee has a right to object by filing a grievance in accordance with the procedure contained herein.
- b) the grievance procedure provides for a hearing by an independent arbitrator at its final step.
- the employee is entitled to representation by Association representative or attorney of his/her choice at every step of the proceedings.
- 2. A Notice of Discipline may be the subject to Step 23 of the grievance procedure contained herein. A written decision shall be rendered and shall be delivered in person or by certified or registered mail, return receipt requested. If the grievance is not resolved at the second step third-step of the grievance procedure, it may be appealed to arbitration by filing a Notice in accordance with Step 34 of the grievance procedure.
- 3. Disciplinary arbitrators shall confine themselves to the determination of guilt or innocence and the appropriateness of proposed penalties. Disciplinary arbitrators shall neither add to, subtract from, nor modify the provisions of this Agreement. The disciplinary arbitrator's decision with respect to guilt or innocence, penalty, or probable cause for suspension shall be final and binding upon the parties, and the disciplinary arbitrator may approve, disapprove, or take any other appropriate action warranted under the circumstances, including ordering reinstatement and back pay for all or part of the period of suspension. If the disciplinary arbitrator, upon review, finds probable cause for suspension, the arbitrator may consider such suspension in determining the penalty to be imposed.
- 4. The penalty proposed by the appointing authority may not be implemented until either:
 - a) the matter is settled, or
 - b) the employee fails to file a <u>Step 2</u> grievance with the appointing authority within ten (10) working days of the receipt of Notice of Discipline, or
 - c) failure to file a demand for arbitration at Step 3 4 timely appeal within ten (10) working days from the decision of the Director of Human Resources or
 - d) the penalty is upheld by the arbitrator or a different penalty is determined by the arbitrator.

F. E. Settlement

A disciplinary matter may be settled at any time following service of the Notice of Discipline. The terms of the settlement shall be agreed to in writing. An employee executing a settlement shall be notified of the right to have an Association representative or attorney of his/her choice or to decline any such representation. A settlement entered into by an employee or their representative shall be final and binding on all parties.

9. Article 18.4 - Grievance Process

Amend as follows:

Step 1: Formal State [remains unchanged]

Step 2: Appeal Stage

- A. In the event that the an employee grievance is not resolved within Step 1, the aggrieved employee may submit within ten (10) working days from the department head's response, a formal written grievance to the County Director of Human Resources.
- B. In the event of a Notice of Discipline, the employee may respond by submitting within ten (10) working days of Notice, a formal written grievance to the County Director of Human Resources.
- C.B. The County Director of Human Resources or his/her designee shall meet within ten (10) working days of the receipt of the written grievance with the aggrieved employee(s) and the Oswego County Professional Association President or his/her designee to discuss and review the allegations.
- <u>C. D.</u> Within five (5) working days of the Step 2, part <u>BC</u> meeting, the County Director of Human Resources or his/her designee must respond in writing to the aggrieved employee(s) with a copy to the Association President.

Step 3: Arbitration Stage

A. In the event the grievance is not resolved within Step 2, the Association or County only may submit within ten (10) working days from the decision of the Director of Human Resources a written request to demand for arbitration to the American Arbitration association NYS Public Employment Relations Board to submit a list of Arbitrators from which the parties may select an arbitrator for arbitration of the grievance in accordance with its Voluntary Labor Grievance Arbitration Rules.

[B. — G. remain unchanged]

10. Section 5.3 - Association Rights

Revise as follows:

The County shall supply to the Oswego County Professional Association President the following information on a quarterly basis:

- 1. A list of all employees in the bargaining unit, including name, home address, social security number, job code and title, department name and budget number, position number, membership status, insurance deduction, start date, and county hire date.
- 2. On a monthly basis, a A list of employees that have terminated employment, including job code-title, and-position number, and date of termination.

11. Article 8 - Holidays

Amend current language in Article 8.3 as set forth below:

8.3 Saturday/Sunday Holidays

Consistent with New York State law, wWhen a holiday falls on a Saturday, the holiday shall be observed on the preceding Friday. A holiday falling on a Sunday shall be observed on the following Monday. When New Year's Day falls on a Saturday, it is agreed that the previous year will have 13 holidays and that year will have 11 holidays.

Employees assigned to departments working seven (7)-day schedules will observe the same holiday schedule as other County employees with the exception that Christmas Day, December 25, New Year's Day, January 1, and Independence Day, July 4, shall be observed on the day they fall.

12. Article 9.2 - Annual Leave Credit

Amend current language in Article 9.2 to reflect the below:

Effective January 1, 2023, employees hired on or before October 9, 2013 shall earn annual leave in accordance with Schedule A. Entitlement is based upon years of service and scheduled hours worked. No additional entitlement is earned for premium or overtime hours worked. The rate of earnings is determined by the designated number of work hours per year divided by the total number days earned per payroll year (Ex. 1820 work hrs/12 days earned).

Employees that qualify for part-time status as defined in 16.2 of the labor Agreement shall earn annual leave credit at a rate of seven (7) paid hours, based on ten (10) twelve (12) days per payroll year.

13. Article 16.2 - Part-Time Status

Amend current language to reflect as follows:

Employees working more than fifty (50)% but less than ninety (90)% of a full schedule shall be considered as part time and eligible for Association benefits as follows:

- 1. Discipline Procedure
- 2. Grievance Procedure
- 3. Shift differential
- 4. Annual leave prorated on hours worked based on twelve (12) days per payroll year.
- 5. Sick leave prorated on hours worked based on twelve (12) days per <u>payroll</u> year. Effective January 1, 2023, employees hired after January 1, 2009 will earn seven (7) hours, <u>with pay per one hundred eighty two (182) hours of employment</u> based on ten (10) days per <u>payroll</u> year. Eighty (80)-hour/pay period employees will be prorated accordingly.
- 6. Holidays New Year's Day, President's Day, Independence Day, Labor Day, Thanksgiving Day, day after Thanksgiving, Christmas Day

Part-time employees will be paid for hours that would have normally been scheduled the day the holiday is observed, or a minimum of four (4) hours at their straight time hourly rate, whichever is greater. If hours are increased to ninety (90)% or more of a full schedule during a calendar quarter and they are eligible to work ninety (90)% or more of a full schedule for a calendar year, they will receive benefits listed above for part time employees with the addition of health insurance. However, if hours are reduced to less than ninety (90)% in a calendar quarter, they will no longer be eligible for health insurance.

Employees hired to work ninety (90)% or more of a full schedule for a calendar year shall receive benefits listed above for part time employees with the addition of health insurance. However, if hours are reduced to less than ninety (90)% in a calendar quarter, they will no longer be eligible for health insurance.

All other provisions contained with Section 16.2 to remain the same.

14. Article 4.1 – Definition

Add the following paragraph:

Effective upon ratification (insert date), the Collective Bargaining Unit shall be expanded to include any newly created position titles which both parties have jointly agreed to in writing.

15. Article 7.3 - Overtime

Amend as set forth below:

The following bargaining unit titles shall be eligible for overtime:

- 1. Administrative Secretary
- 2. Chief Maintenance Mechanic ERF
- Secretary to the Family Court Attorney
- Shift Supervisor ERF

The parties agree to study overtime eligibility under the Fair Labor Standards Act for those titles the OCPA identify as titles to which FLSA overtime eligibility applies. The parties agree that the labor management provisions of this agreement (Article 19) and labor management meeting shall be forum within which discussion will occur regarding overtime eligibility. At the request of either party, additional labor management meeting dates can be scheduled beyond the allotted dates in this agreement. The request to schedule a meeting will not be unreasonably denied.

Thirty-five (35)-hour-per-week employees who are overtime-eligible shall be paid straight time for hours worked between thirty-five (35) and forty (40) hours and time and ¹/₂ for hours worked in excess of 40 hours.

For those employees that are overtime eligible in accordance with the Fair Labor standards Act as set forth above, for hours worked in excess of forty (40), employees shall be paid at one and one-half (1 ½) times their normal hourly rate of compensation.

Overtime-ineligible employees shall be entitled to in-lieu time, with the approval of the department head or designee, or given the option of receiving a maximum of five (5) hours additional pay (straight time) per week, with the approval of the department head or designee, to be paid to the employee in the next paycheck, In-lieu time must be used within ninety (90) days of earning. In no event shall in-lieu time be paid in cash.

16. Article - 9.4 - Annual Leave Conditions

Amend as follows:

Effective upon ratification (insert date), employees are not entitled to utilize annual leave earnings until completion of six (6) months of full- time or part-time employment. In cases in which the employee experiences an emergency in the first six (6) months of full-time or part-time employment, which requires time off, the department head/designee, having sole discretion, may grant early access to annual leave earned.

[All other provisions contained within Section 9.4 to remain the same.]

17. Article 13.2 - Meals and Lodging

Reimbursement for meals and lodging expense shall be allowed for an employee on official business outside the limits of Oswego County or attending authorized conferences or meetings within the County with the prior approval of the department head.

Reimbursement shall be made in accordance with applicable Oswego County Operating policies, regulations & procedures, PRP 2006-7, Expense Reimbursement and Travel and any revisions made thereto.

The County is prohibited from requiring an employee to use a personal credit card to pay, or secure in advance, reservations, registration fees, or other expenditure larger than meals. Reservation and registration transactions can be handled by the County Purchasing Department.

18. Article 13.6 – Shoes

The County will pay up to a maximum of \$300.00 for safety shoes per employee per year for certain classifications.

Classifications covered are:

Assistant Engineer/Highway Chief Facility Operator (ERF) Chief Maintenance Mechanic (ERF) Highway Engineer Airport Manager Public Health Engineer Shift Supervisor (ERF) Solid Waste Operations Manager Staff Engineer Supervising Public Health Engineer [All other provisions contained within Section 13.6 to remain the same.]

19. Article 13.7 – Tools

The County agrees to reimburse the Chief Maintenance Mechanic up to \$400 \$500 per year.

The Chief Maintenance Mechanic must provide an itemized paid receipt for tools purchased. Tools must be for performance of normal duties and available to employee during the normal work day. The County reserves the right to inspect tools for which reimbursement is requested.

In the event of a fire or structural damage such as a roof collapse at a County facility where *employee's* tools are stored, the County will reimburse the Chief Maintenance Mechanic for tools destroyed up to \$1,500 \$2000 per incident.

An inventory of all tools must be submitted annually to the Chief Maintenance Mechanic's supervisor by January 31 each year. No reimbursement will be considered without a current inventory or record.

Losses covered by insurance shall not be considered for additional reimbursement.

20. Article 16.1 - Full-time Status

Amend as follows:

A regular full-time employee is one who occupies a budget line item position and who is scheduled and works on a full-time basis for the County and is thereby entitled to all rights and benefits of the Agreement. Any employee working ninety (90)% of a full schedule shall be considered as full-time.

For purposes of eligibility for health insurance only, and notwithstanding anything to the contrary set forth in Section 16.2, employees regularly scheduled to work thirty (30) or more hours per week shall be considered full-time employees and entitled to health insurance as set forth in Article 14.

21. Article 21.2 - Longevity Adjustment

Amend as follows:

Longevity increases will be awarded based on the employee's County Hire Date.

Effective January 1, 2023, a longevity increase of two percent (2%), will be added to employee's salary on anniversary date end of year 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, and 34, 37, and 40. No longevity increases will be awarded for service greater than thirty four (34) forty (40) years. Longevity increases will be awarded based on the adjusted start date. Current employees will receive credit for longevity increases received prior to 1/1/2014.

Longevity will be added to salary on employee's anniversary date the anniversary of the employee's County Hire date (as adjusted) thereby increasing hourly rate used to calculate a seventy (70) or eighty (80)-hour, two (2)-week pay. Increase will be calculated by dividing longevity increase by hours as projected for current year.

Longevity will be granted to any employee having an adjusted start date that matches *years* of service as listed above.

22. Article 21.3 - Shift Differential

Effective upon ratification (insert date), amend as follows:

An overtime-eligible employee whose major part of the working-day falls between the hours of six (6) p.m. and six (6) a.m. on a regular basis shall be paid thirty five (35) fifty (50) cents per hour shift premium. The major part of a working-day is defined as fifty (50) percent or more of the employee's hours.

An overtime-eligible employee who, is not regularly scheduled to work between the hours of six (6) p.m. and six (6) a.m. shall be entitled to the shift premium only when filling in for an absent employee whose regularly scheduled hours are between six (6) p.m. and six (6) a.m.

ERF Shift Supervisors assigned to a four (4)-crew, seven (7)-day schedule shall receive seventy five (75) cents one (1.00) dollar per hour shift differential for all hours worked in lieu of the normal shift differential.

23. Article 21.4 - On Call

Amend as follows:

Effective upon ratification (insert date), Supervising-Public-Health-Nurses are eligible for on-call premium when directed by his/her Department Head to be on-call.

Mandatory on-call duty by an employee shall be compensated at the rates shown below per twenty-four (24)-hour for Friday, Saturday, Sunday, holidays, and the day prior to holidays.

All weekdays other than Friday or the day before holidays shall be compensated at the rates shown below per sixteen (16)-hour day.

Friday, Saturday, Sunday, holidays, and day prior to holidays

\$50 \$100

Weekdays other than Friday or day prior to holidays

\$45 \$75

Should the tour of on-call duty be less than the previously stipulated hours the premium shall be prorated on an hourly calculation.

In the even that on-call employees are actually called out, they shall receive pay at their normal hourly rate of pay for actual hours worked or two (2) hours at their normal hourly rate of pay, whichever is greater. Employees called out between the hours of 12:00 midnight and 6:00 a.m. shall receive pay at their normal hourly rate for hours worked or three (3) hours at their normal hourly rate of pay, whichever is greater. Employees who are assigned to be on-call and are required to use the telephone in the performance of county business will be paid for time worked at their normal hourly rate of pay rounded to the nearest one-fourth (1/4) hour upon submission of an approved time form.

Any employee placed on mandatory on-call for a twenty-four (24)-hour period during any holiday as enumerated in this Agreement shall receive a compensatory day off or a day's pay at the employee's normal hourly rate of pay at the <u>discretion of the department head and by mutual</u> agreement between the employee and the department head.

In the event that on-call employees are actually called out during any holiday enumerated in this Agreement, they shall receive one and one half (1 ½) for all hours actually worked.

Every employee shall have at least one (1) day per week when he or she is not working and is not on-call, except in emergency situations.

Employees may not be placed on-call when on approved leave using accrued leave time including the day before and after such leave time, except in an emergency satiation, as determined in the sole discretion of the Department Head.

Except in emergency situations, an employee shall be given a minimum of seven (7) calendar days' notice of being placed on-call.

Employee's on call shall abide by the County's drug and alcohol policy and remain fit for duty. On call employees shall also be reachable by phone and/or text message and are expected to be able to respond within one (1) hour of being notified.

An employee directed to be on-call may arrange substitute on-call coverage by another employee, provided the Department Head is notified and approves of the substitution and that the employee who will actually be on-call has the necessary qualifications or training to adequately fulfill the duties if called upon. The restriction set forth above requiring an employee to have at least one (1) day per week when he or she is neither working nor on-call shall not be applicable in the case of a voluntary substitution.

24. Appendix B: Amend as follows:

Effective upon ratification (insert date), the range of salaries for each grade as set forth below are intended to establish the permissible range of starting base salary for an employee hired or transferred to a new title. Any additional compensation provided by other provisions of this Agreement, such as (but not limited to) longevity may result in the total compensation amount actually received by an employee exceeding the maximum amount identified in the schedule below.

25. The agreed upon increases to compensation provided in Sections 21.1 and 21.2 are fully retroactive back to January 1, 2023 for those employees in the bargaining unit on the date of ratification of this memorandum of agreement (insert date). Following ratification, the County shall make payments for such retroactive increases as soon as practicable, but in no event more than thirty (30) days after ratification. Bargaining unit employees who retired during 2023 shall be entitled to retro payments for that period of time after January 1, 2023 in which they were employed in a bargaining unit position.

26. All other proposals are deemed rejected and withdrawn.

MEMORANDUM OF UNDERSTANDING BY AND BETWEEN THE COUNTY OF OSWEGO AND THE OSWEGO COUNTY PROFESSIONAL ASSOCIATION (OCPA)

WHEREAS, both the County of Oswego ("County") and the Oswego County Professional Association ("Union") have heretofore entered into a collective bargaining agreement ("Agreement") effective January 1, 2018; and

WHEREAS, the Oswego County Legislature awarded a professional service contract, providing professional services in administering a Medicare Advantage with prescription drug plan related to Oswego County's Self-Insured Health Program provided to Medicare eligible retirees, effective January 1, 2021; and

WHEREAS, the parties mutually agree that a written memorandum of understanding is both necessary and desirable to memorialize same,

NOW, THEREFORE, it is mutually agreed between the parties that the current language under Article 14.3 of the 2018-2022 collective bargaining agreement shall be deleted in its entirety and amended to read as follows:

14.3 Health Insurance

A. The County agrees to provide to all full-time employees a health insurance plan covering medical and prescription drug benefits as outlined in 14,3 (D) below.

This coverage commences the first day of the month following a thirty (30) day period of full-time employment with Oswego County.

B. The provisions of this plan shall be extended to dependents of employees covered by this Agreement and the County will pay 85% of the cost of dependent coverage and 15% will be paid by the employee. For employees who entered the bargaining unit after June 10, 1999, the County will pay 75% of the cost of dependent coverage and 25% percent will be paid by the employee.

The monthly employee contribution for employees hired into County employment on or before October 9, 2013 will be 6% of the individual premium equivalent with the County paying the balance. All employees hired into County employment on or after October 10, 2013 who enroll in the health insurance plan will contribute 15% of the individual premium equivalent, on a bi-weekly basis, with the County paying the balance.

For self-insured plans, the individual premium equivalent is the cost per covered employee or the amount that reflects the cost of claims paid, administrative cost, and stop-loss premiums.

E. Employee Assistance Program (EAP)

The County agrees to provide an Employee Assistance Program (EAP) available to all members and their eligible dependents.

F. Upon obtaining County retirement status, medical and prescription drug coverage will be provided subject to the following:

The County will pay the premium for the retirees' insurance as described in 1 and 2 below:

- Retirees not yet Medicare eligible will be offered medical and prescription drug coverage through a county sponsored plan.
 - --Retirees not yet Medicare eligible, who entered the bargaining unit after June 10, 1999, are required to pay 100% of the cost of prescription drug coverage unless offset in accordance with Article 10.4 B.
 - --Retirees with dependents who are not yet Medicare eligible will pay 100% of the cost for dependent medical and prescription drug coverage unless offset in accordance with Article 10.4 B.

- Retirees eligible for Medicare will receive medical and prescription drug coverage provided through a plan that is specifically designed for Medicare eligibles, conditional upon the retiree's enrollment in Medicare Parts A and B,
 - --Retirees who are Medicare eligible, who entered the bargaining unit after June 10, 1999, will be required to pay 35% of the cost of the medical and prescription drug premium equivalent rate in effect for Medicare eligibles unless offset in accordance with Article 10.4 B.
 - --Retirees with dependents who are Medicare eligible will pay 100% of the cost for dependent coverage of the medical and prescription drug premium equivalent rate in effect for Medicare eligibles unless offset in accordance with Article 10.4 B.

For employees hired into County employment on or after October 10, 2013, provisions in 14.3 (F) above will apply only if employee has completed ten (10) years of continuous full-time service to the County. Part-time equivalent service will be counted provided the employee is employed at full-time status by the County at the time of retirement.

Nothing contained within this section is intended to conflict or be interpreted inconsistent with the insurance contracts entered into by the County.

County employees who join the collective bargaining unit are not considered to be "hired" for the purposes of this provision.

The County may change health insurance plans or providers in effect at the time of the signing of this Agreement so long as the plans are equivalent with respect to benefits and access to providers. The Association may grieve and arbitrate the issue of equivalency.

IN WITNESS WHEREOF, the parties hereto have caused this Memorandum of Understanding to be signed by their respective representatives on September 29, 2021.
