INFORMATIONAL MEMORANDUM

SUBJECT:

Establish capital project for update of some of the County's core technology systems and for purchase of cybersecurity related monitoring and protective systems.

PURPOSE:

To provide funding of \$700,000 to support this initiative as follows:

- ~\$350,000 for replacement of County's primary virtual server and upgrading of associated software licenses;
 - ~\$100,000 for replacement of the County's wireless network;
- ~\$100,000 for replacement and upgrade of County's battery backup devices used to provide supplemental power to servers, network devices, and other key systems;
- -\$100,000 for purchase of licensing/subscriptions for existing or new monitoring and cybersecurity related applications;
 - ~\$50,000 for miscellaneous technology projects.

SUMMARY:

This capital project provides for updating of essential technology systems that have reached end-of-life, as well as funding of systems related to monitoring, cybersecurity, and regulatory compliance.

Key points to note are:

- The County's primary virtual server runs 80+ virtual servers, including MUNIS, E911 CAD, and several other mission-critical applications. The purchase includes 5-years of support.
- The County's wireless network is deployed to approximately a dozen sites and is comprised of ~75 access points. The purchase includes 5-years of support.
- Key elements of the battery backup device upgrade project are replacement of the larger units in the PSC and DSS datacenters, as well as purchasing a maintenance agreement covering most, if not all, devices.

RECOMMENDED

I respectfully request transferring \$ 700,000 from General Fund Appropriated Fund Balance to establish Capital Project T0123 for the expenditures listed above.

In support of policy objectives set forth in New York State's Environmental Conservation Law, solid waste management facilities within the State may accept waste only from municipalities having an approved Draft Local Solid Waste Management Plan (LSWMP). Likewise, pursuant to 6 NYCRR Part 366, the State permitting and funding determinations hinge upon the relevant solid waste planning unit having an approved plan. Despite submitting an original draft plan a decade ago, the County of Oswego has not received approval of the same and upon consultation with the NYS Department of Environmental Conservation (DEC) has undertaken to draft an updated plan.

Barton and Loguidice was contracted to complete the updated draft LSWMP which is submitted herewith for Committee review and approval. The Department of Solid Waste has solicited public comment upon the plan and has held a public meeting concerning the LSWMP in accordance with Part 366-3.1. The public participation period is now complete and the plan is ready for submission to the NYSDEC for its regulatory review and approval.

Accordingly, the Department of Solid Waste requests Committee review and approval to submit the Draft LSWMP to the NYSDEC.

EXECUTIVE SUMMARY

The purpose of the Oswego County Local Solid Waste Management Plan (LSWMP) is to identify the path to be pursued for managing solid waste generated in Oswego County during a ten-year planning period, in an economical and environmentally sound manner, which is consistent with the State's solid waste management policy. The initial year of this ten-year planning period will commence following approval of this Plan by the New York State Department of Environmental Conservation (NYSDEC), which is expected to be 2023. The ten-year planning period will be 2023-2032.

The residents, businesses, industries, and institutions in Oswego County currently produce approximately 425 tons of solid waste every day. This act creates a need to develop a plan to increase recovery, to decrease disposal or incineration, and to reduce waste generation, now and in the future.

This LSWMP will: 1) serve as a countywide framework for the coordination of solid waste management; 2) establish countywide solid waste goals and objectives -- including goals for waste reduction and recycling -- and a plan to monitor progress toward the goals; and 3) satisfy the latest NYSDEC requirements for solid waste planning and comprehensive recycling analyses.

Oswego County, through its Department of Solid Waste (DSW), serves as the solid waste planning unit for all municipalities within the County. This LSWMP recognizes, however, that local municipalities, the NYSDEC, private waste haulers, and neighboring solid waste planning units all play important roles in Oswego County's current and future management of solid waste and recyclable materials.

The Solid Waste Management Act of 1988 established a State Solid Waste Management Policy. The policy defines the following solid waste management priorities in New York State:

- first, to reduce the amount of solid waste generated;
- second, to reuse material for the purpose for which it was originally intended or to recycle material that cannot be reused;
- third, to recover, in an environmentally acceptable manner, energy from solid waste that cannot be economically and technically reused or recycled; and
- fourth, to dispose of solid waste that is not being reused, recycled or from which energy is not being recovered, by land burial or other methods approved by the Department (from New York State Environmental Conservation Law (ECL) 27-0106.1).

NYSDEC (December 2010) issued a statewide SWMP, Beyond Waste: A Sustainable Materials Management Strategy for New York. It defines broad statewide objectives for waste reduction, reuse and recycling, waste-to-energy, landfilling, and special issues consistent with the State Solid Waste Management Policy. The quantitative goal of Beyond Waste is to reduce the amount of waste New Yorkers dispose by preventing waste generation and increasing reuse, recycling, composting and other organic material recycling methods. Based on the data gathered and compiled for this LSWMP, the County has identified program strategies to work toward during a ten-year LSWMP planning period that

is consistent with the State Solid Waste Management Policy. The strategies set forth below were identified with the goal of further enhancing the reuse and recycling of materials generated in Oswego County and providing for the means to recover energy in an environmentally sound manner from solid waste that has not been reused or recycled. Each strategy and corresponding goal will be evaluated for feasibility and cost-effectiveness on an individual basis according to the implementation schedule included in Chapter 6.0.

Program Strategy #1 - Promote Waste Reduction Programs

Goal: Establish a waste reduction policy to increase waste reduction at County facilities and events.

Program Strategy #2 - Promote Reuse Programs

Goal: Promote reuse programs through education and outreach.

Program Strategy #3 - Expand Accepted Materials

Goal: Increase the types of materials accepted for recycling at the County's transfer and convenience stations and educate residents on proper recycling.

Program Strategy #4 - Increase Recycling at County Facilities & Events

Goal: Increase recyclables recovery at County owned and/or operated facilities.

Program Strategy #5 - Support Product Stewardship Framework

Goal: Shift government funded waste diversion program to one that relies on product stewardship, and if feasible adopt product stewardship framework.

Program Strategy #6 - Support Organics Diversion Efforts

Goal: Encourage diversion of organics from the solid waste disposal stream through education and training. In addition, consistent with the October 2022 Composting Feasibility Study consider development of an organics compost facility at the Bristol Hill complex.

Program Strategy #7 - Evaluate Pay-As-You Throw Program

Goal: Continue the modified PAYT program (volume based pricing) at transfer stations to potentially enhance waste diversion effectiveness.

Program Strategy #8 - Improve Public Outreach and Education

Goal: Educate residents to increase recycling and waste diversion and reduce improper disposal of materials.

Program Strategy #9 - Improve Solid Waste and Recycling Data Collection

Goal: Obtain a more complete data set specific to private commercial entities recyclables quantities to assist with the implementation of program strategies.

Program Strategy #10 – Implement C&D Debris Reduction and Diversion

Goal: Consider implementation of C&D reduction and diversion from disposal on County projects.

Program Strategy #11 - Identify Management and Coordination Opportunities

Goal: Assess the availability of funding opportunities or partnerships with other organizations to assist the County in accomplishing the LSWMP program strategies.

Program Strategy #12 - Review Available Technologies

Goal: Evaluate proven, cost effective alternative waste disposal technologies that may be available to the County

Program Strategy #13 – Continue Existing Disposal Methods as Primary Disposal for Non-Recyclable/Non-Recoverable Waste

Goal: Continue to provide reliable, economical, and environmentally-sound outlets for County residents to dispose of all non-recyclable and non-recoverable waste.

Program Strategy #14 - Review County Local Solid Waste Management and Recycling Law

Goal: Conduct a review in order to ensure the local solid waste law is up to date.

Program Strategy #15 - Agricultural Recycling Initiatives

Goal: Support the potential development of an agricultural plastics recycling program through the Soil and Water Conservation District or through partnering with neighboring planning units.

COOPERATIVE AGREEMENT

INTENT:

WHEREAS, the NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION. Office of Public Protection, (NYSDEC) and the COUNTY OF OSWEGO, Highway Department (County), through their joint and collective efforts, have designed, constructed, currently operate an Emergency Vehicle Operator's Course (EVOC) at the Oswego County Airport's Law Enforcement Training Facility, located in the Town of Volney, County of Oswego, New York. Both the County of Oswego and the NYSDEC have committed significant resources to this unique facility and wish to formalize the current arrangement on a long-term basis for their mutual benefit. The purpose of this Cooperative Agreement allows the use of the EVOC by NYSDEC, the County of Oswego and other agencies consistent with its intended design and purpose and establishes terms and conditions for said use.

WITNESSETH:

TERM:

The term of this Agreement shall be TWENTY (20) YEARS from January 1, 2008 to December 31, 2027 as authorized by County of Oswego Local Law No. 2 of 2005.

DEFINITIONS:

FLETC,	Federal Law Enforcement Training Center
Certified Instructor	Certified Police Trainers who have minimum qualifications/ expertise in field and BMP or equivalent (FLETC) certification.
Facility	Oswego County Airport EVOC Training Center at Volney, NY.
Training Agency	Agency who has requested the use of the EVOC Track and who is the primary trainer for their own officers/cadets.

OVERVIEW:

It is mutually agreed by and between the parties to this Agreement that the EVOC facility will be operated in accordance with the following guidelines:

- The area allotted for the EVOC facility and the attendant support facilities will be, at all times, owned and governed by the County of Oswego.
- The cost for the construction and maintenance of the EVOC facility, exclusive of any buildings, improvements or facilities constructed and/or occupied by NYSDEC at the EVOC, shall be solely a county charge. Any improvements shall become the sole property of the County of Oswego upon the expiration of this agreement.
- NYSDEC shall provide their significant expertise in the areas of track design and the proper operation of this specialized type of facility/course as needed.
- 4. NYSDEC EVOC instructors will be solely responsible for the oversight and scheduling of all EVOC training operations held at the facility. All scheduled training shall include at least one (1) instructor and shall have the prior approval of the NYSDEC Division of Law Enforcement Coordinating Officer and, further, shall be on one week's notice to the Airport Manager or his designee.
- 5. The county reserves the right to close the Oswego County Airport, including the EVOC, due to weather-related problems, general aviation related matters or emergencies, the request of the Federal Aviation Administration, or for scheduled, special events at the airport. Should any of the foregoing occur, the county will endeavor to provide such reasonable advance notice to a designated representative of NYSDEC as may be practicable under the circumstances.
- 6. All instructors from any other agency utilizing the EVOC shall be BMP or FLETC

- certified and shall operate under the NYSDEC Division of Law Enforcement's Training Rules/Policies for EVOC Instructors, a copy of which shall be kept on file at the facility and will be available for inspection.
- 7. All fuel and necessary supplies, including vehicle repairs for EVOC vehicles, shall be the sole responsibility of the Training Agency. At the conclusion of the training, all vehicles, parts, and supplies will be removed by the Training Agency at its sole cost and expense. Any exception(s) to this policy must be approved by the Airport Manager of the Oswego County Airport in writing.
- All Training Agencies utilizing the EVOC must:
 - Enroll through NYSDEC Law Enforcement by calling 518-527-5501;
 - Register with the Airport Manager of the Oswego County Airport;
 - c. Have a Track Safety Officer from NYSDEC, or, if an outside agency, a Track Safety Officer certified by FLETC or BMP present during all EVOC operations;
 - d. Have instructors present that are BMP or FLETC certified EVOC instructors during all track operations;
 - Ensure that all vehicles utilized meet or exceed minimum safety requirements;
 - Be responsible, at all times, for the security, storage, and safe operation of the vehicles utilized.
 - g. Provide the Office of Oswego County Attorney a Certificate of Insurance naming the County of Oswego and the New York State Department of Environmental Conservation as additional insureds for the purposes of its use of the EVOC training course and indicating the dates of training thereupon prior to the commencement of same to 46 East Bridge Street, Oswego, New York 13126;
 - Any Certificate of Insurance shall conform to the minium requirements set forth on EXHIBIT A, annexed hereto and made a part hereof; and
 - Provide the names of all students, instructors, and other personnel prior to the utilization of the EVOC.
- In consideration of the foregoing, and as partial consideration for this agreement, the NYSDEC shall provide at least eighty (80) hours of training to be supervised by the NYSDEC EVOC Instructors (BMP certified) to the Oswego County Sheriff's

Office at no charge on an annual basis.

- NYSDEC shall, at all times hereunder, provide a training building for the facility, equipped as is necessary for EVOC training and will provide potable water for same.
- NYSDEC shall, at all times hereunder, provide supervision and oversight of EVOC training operations at the facility, including the scheduling of all training and coordinate same with Airport Manager.
- Other than NYSDEC EVOC training, any other police, fire or ambulance agency utilizing the facility (excluding the Oswego County Sheriff's Office and other Oswego County/in- county EMS, police and fire agencies) shall be charged a usage fee of \$125.00 per diem payable in advance to the Oswego County Treasurer, 46 East Bridge Street, Oswego, New York 13126. This fee shall be irrespective of any other fees charged by NYSDEC or third parties for EVOC training. The Infrastructure and Facilities Committee shall review the EVOC per diem rates on an annual basis and shall establish separate rates or terms for commercial (i.e. non-law enforcement, non fire/EMS) entities wishing to utilize the facility, on a case-by-case basis, as warranted.
- 13. For the terms of this agreement, and any renewal thereof, and subject to the Constitution and laws of the State of New York, NYSDEC agrees to indemnify and hold harmless the County of Oswego for any and all causes of action in law or equity arising directly from the negligence of the NYSDEC or its employees in its use of the premises as an EVOC training facility.
- Pursuant to applicable FAA regulations, no fuel or other combustible materials will be stored on the EVOC premises without the written approval and consent of the Airport Manager.
- The Airport Manager and NYSDEC shall agree upon an appropriate location for the storage of any vehicles or other equipment upon the EVOC premises, if necessary.

ASSIGNMENT:

NYSDEC hereby agrees that it shall not assign, transfer, convey, sub-contract or otherwise dispose of this agreement, or its responsibility to perform under this agreement, or its right, title or interest in and/or to the same, nor any part thereof, nor the power to execute such agreement to any other person, department, municipality, company or corporation without the prior express written consent of the County of Oswego.

CONTRACT MODIFICATIONS:

This agreement represents the entire and integrated agreement between the NYSDEC and the County and supersedes all prior negotiations, representations or agreements wither written or oral. This agreement may be amended only by written instrument signed by both the NYSDEC and the County.

SEVERABILITY

If any term or provision of this agreement shall be held invalid or unenforceable, the remainder of this agreement shall not be affected thereby and every other term and provision of this agreement shall be valid and enforced to the fullest extent permitted by law.

ADDITIONAL CLAUSES AS REQUIRED BY LAW

The parties hereto understand and agree that each and every provision of law and clause required by law to be inserted in this agreement shall be deemed to have been inserted herein, and if through mistake or inadvertence such provision is not inserted, said clause shall be deemed to have been inserted and shall have the full force and effect of law.

In accordance with Section 41 of the State Finance Law, the State shall have no liability hereunder to County of Oswego or anyone else beyond funds appropriated and available for this agreement.

NOTICES

Unless otherwise specified herein, all notices shall be made to the addresses first indicated herein via first class mail.

"EXHIBIT A" NYSDEC AND COUNTY OF OSWEGO EVOC TRACK INSURANCE REQUIREMENTS

- 1. Notwithstanding any terms, conditions or provisions, in any other writing between the parties, any agency utilizing the EVOC hereby agrees to effectuate the naming of the County of Oswego and the New York State Department of Environmental Conservation as unrestricted, additional insureds on the agency's insurance policy(ies), with the exception of Workers' Compensation coverage. If the agency is self-insured, evidence of its status as a self-insured entity shall be provided to the Oswego County Attorney's Office. If requested, the contractor must describe its financial condition and the self-insured funding mechanism(s).
- The policy naming the County of Oswego and NYSDEC as additional insureds shall, without exception:
 - Be an insurance policy from an A.M. Best rated "secured" New York State licensed insurer.
 - Contain a 30-day notice of cancellation.
 - State that the insurer's coverage shall be primary coverage for NYSDEC and the County of Oswego, its officers, and employees in connection with the use of the EVOC track.
 - The NYSDEC and the County of Oswego shall be listed as an additional insureds by using endorsement CG 2010 10 85 or broader. The certificate must state that this endorsement is being used. If another endorsement is used, a copy shall be included with the certificate of insurance.
- The agency further agrees to indemnify the NYSDEC and the County of Oswego for any applicable deductibles.
- 4. Required Insurance:
 - Commercial General Liability Insurance \$1,000,000 per occurrence/ \$2,000,000 aggregate.
 - Automobile Liability
 \$1,000,000 CSL for owned, hired and borrowed and non-owned motor vehicles.
 - Excess/Umbrelia Insurance
 \$1,000,000 each Occurrence and Aggregate
 - Workers' Compensation and N.Y.S. Disability
 Statutory Workers' Compensation, Employers' Liability and N.Y.S. Disability Benefits Insurance for all employees.
- V. The agency is to provide the County of Oswego and NYSDECwith a certificate of insurance, evidencing the above requirements have been met, prior to the commencement of use of the EVOC. The failure of the County of Oswego or NYSDEC to object to the contents of the certificate or the absence of same shall not be deemed a waiver of any and all rights held by the County of Oswego or NYSDEC.

WHEREAS, NYSDEC is desirous of entering into a long-term agreement regarding the relationship between the county and the state as concerns the EVOC; and

WHEREAS, a long-term agreement may place the County of Oswego at a competitive advantage as compared to other counties for the siting of any future NYSDEC Training Academy facilities; and

WHEREAS, a written agreement is both necessary and desirable,

NOW, THEREFORE, upon the motion of the Infrastructure and Facilities Committee of this body, it is hereby

RESOLVED, that the Chairman of the Legislature be, and is hereby authorized to execute the annexed Memorandum of Understanding with the New York State Department of Environmental Conservation; and, it is further

RESOLVED, that the term of the annexed agreement shall be twenty (20) years and shall run from January 1st, 2008 to December 31st, 2027.
