The \$175,000 budgeted amount for 2022 to cover medical expenses incurred to date, will not meet the current and anticipated expenses incurred by inmates housed at the Oswego County Correctional Facility through the year's end. A request is being made to transfer \$120,000.00 from Unappropriated Fund Balance into 3150.543500 (Medical Fees) to cover current costs and those anticipated expenses for the remainder of the year.

This year's increase is a result of an increased jail population, increased medical costs and several inmates with higher than usual medical needs.

### Director Carpenter:

Regarding the bid received by Jerome Fire on 7/18/22 below is a list of reasons I feel that the bid should be listed as non-responsive.

- 1. Under section 2.1, "it is the intent of these specifications to describe the minimum requirements for one (1) new, unused Breathing Air Compressor complete with one new & unused Variable Frequency Drive". Jerome failed to mention the variable speed drive in the bid. This is a crucial piece of equipment for this project to protect the compressor system and the truck mounted generator. That was a requirement of this project.
- 2. On page 11 the following states "A cascade control system shall be included for the number of banks specified below to permit drawing down each air storage cylinder independently of each other for filling SCBA/SCUBA cylinders. The system shall include an automatic refill system designed to feed air from the breathing air compressor and air storage system to the SCBA fill station. When SCBA fill operation ceases, air from the compressor will be diverted to top-off the air storage system before shutting off. Anytime that the operator resumes the SCBA fill process, the compressor will flow to the fill station as the priority. An additional priority will be placed on first refilling bank four as the "top-off" bank. Once the compressor has filled bank four to 6000 p.s.i.g. it will then proceed to refill banks one thru three. This automatic refill system requires no operator action to perform these functions." No where in the bid that was submitted did it mention this language.
- 3. On page 9 under General Arrangement, it states "The fill station containment design must be UL® (Underwriters Laboratories) classified and for maximum operator safety certified to meet NFPA 1901-2016 standards. The UL® testing certificate must be included with the bid or request for quotation and included with the operator's manual when the system is shipped." The submitted bid, submitted testing from a company called Damarc the S.C.B.A. fill station does not meet the UL certification. It only was tested and certified to the N.F.P.A. 1901.2009 Para 24.9.7.2.

For the above-mentioned reasons the bid submitted by Jerome Fire Company INC. should be labeled non-responsive. Should you have any questions please contact me at your convenience.

EMO - August 2022

### Planning/Grants:

- Continue to manage and administer various grants with our stakeholders. Homeland Security Grant 2018 and 2019 are ending on August 31, 2022. We expect to receive notification in September on the SHSP22 grant.
- 2. Continue the planning efforts to implement WebEOC in the county as our incident management system.
- 3. EMO conducted an additional COOP initial planning and refresher session for county departments that could not attend sessions in July provided by the vendor.
- 4. Reviewed the proposals submitted for RFP 22-EMO-001 Mass Fatality Plan Exercises and have selected a consultant for the legislature to approve.

### Meetings/Webinars/Conferences:

- 1. EMO director, completed the Tier 2 NYS Emergency Management & Training Academy Refresher as required to continue receipt of grant funding.
- 2. Attend the monthly National Weather Service (NWS) update.
- 3. Participated in the NYS OEM Region 4 quarterly conference call regarding training and exercise requests through NYS.
- Participated in the National Grid Climate Change Vulnerability Study and Resilience Planning Webinar.
- Attended the Munis training in preparation for 2023 budget entry.
- 3. EMO staff attended the NYS Hurricane Awareness Webinar
- 4. EMO staff participated in a planning meeting for Super Dirt Week.

### Radiological Preparedness:

- EMO participated in a virtual County Coordination Meeting with Constellation, NYSOEM, FEMA, NYS PSC, NYS DOH, Wayne and Monroe County Emergency Management Offices to discuss ongoing radiological planning and exercises activities.
- 2. Met with E911 Director, Communications Coordinator to walkdown Personnel Monitoring Center at Parish Highway Facilities to establish another back-up communication capability.
- 3. Continue evaluating County REP Plan to changes in the 2019 FEMA REP Manual.
- Attend monthly meetings with Constellation to gauge support needs and maintain open lines of communication.
- 5. Planning efforts continue for our off-year radiological exercise with NYS and Constellation.
- 6. Planning efforts continue for our FEMA Evaluated Post Plume TTX with our partners.
- 7. Radiological Emergency Preparedness emergency worker training sessions are ongoing with our partners.

- 8. Completed the review of the KLD Engineering summary of the Evacuated Time Estimate Study based on the 2020 census data.
- Completed the review of the Upstate Emergency Operation Plan for handling of a radiologically contaminated patient.
- 10. Attended Constellation NMP/JAF Multi Site Exercise at EOF/JIC.
- 11. EMO has two openings as of August 17<sup>th</sup>. We have been unable to fill one part time typist position that has been available since February and currently looking for a radiological specialist.

### Response:

- 1. Continue to support requests for PPE and test kits from county departments and agencies.
- 2. Continue to support COVID-19 testing at EMO.
- 3. Provided Oswego Police Department with logistic support for Harborfest.

### **UAS (Unmanned Aircraft Systems) Activities:**

- Submitted a grant application for funds that support community initiatives. If awarded, funding will be utilized to purchase a project lifesaver device that can be attached to drone to enhance capabilities.
- 2. Attended the DSHES UAS Summit at the State Training Center in Oriskany, NY.
- 3. The Sheriff's Dept. will have representation at the County Fair to educate on drone technology.
- 4. DroneSense vendor was onsite working to identify the reliability of the Drone Sense Remote (DSR) program and will work to rectify issues as a result.
- 5. Drone Coordinator provided additional training with Oswego Police Department, Fulton Fire/PD on the DroneSense technology and DSR program.
- 6. Entered a requisition to purchase a replacement drone for the unit that was damaged.
- 7. Working on 2023 budget.

### **Great Lake Level Conditions and Forecast:**

- 1. In the last month, Lake Ontario dropped 7 inches. This is 1 inch higher than the same time last year.
- 2. Over the next month, Lake Ontario is forecast to be 6 inches lower through September 5<sup>th</sup>. The outflow into the St. Lawrence River is projected to be above average.
- 3. As of August 11th, the Lake Ontario water level is 245.34.

**EMS Coordinator Report** 

### August 2022 Activities

### 1. EMS Education

- a. The EMT-B Core Hours Class at Menter wrapped up
- b. The Brewerton Fall EMT Class has started, with approximately 8 students
- c. We received DOH Approval for an additional Fall EMT course at McFee Ambulance. This class will start in September, we currently have 5 registered.
- d. Workforce NY application has been approved, working with them on implementing their assistance for a Fall EMT Academy, Menter is aiming for 12 students. Many of these students are recent high school graduates. This class will also start in September.

### 2. Response

- a. All area hospitals continue to struggle with caseload in the Emergency Rooms, and many are DOH Diversion frequently.
- b. Psych cases are still high.
- COVID Testing of County Employees continues, however we have been seeing very low utilization recently, and have been testing on a as needed basis.
- d. Continued to monitor ambulance resources/coverage in the county
- e. Working with the Fire Coordinator's Office to deploy Emergency Vests, MCI equipment, and new rapid response bags throughout the county.

### PUBLIC SAFETY COMMITTEE REPORT PROBATION

August 29, 2022

### Supervision

 As of 8/16/22, the department had 638 individuals under some level of supervision/monitoring (Criminal Court, Family Court and Juvenile Intake).

### Investigations

 52 investigations were assigned in July 2022 (Presentence, Pre-Plea, Predisposition, and Pre-Transfer).

### **Electronic Monitoring**

As of 8/16/22, the department had 16 individuals under electronic monitoring. This
number, which varies month to month, includes individuals under Pre-Trial Release,
Probation Supervision and Predisposition (Family Court).

### Pre-Trial Release

• As of 8/16/22, the department was monitoring 65 individuals on Pre-Trial Release.

### Cognitive Behavioral Intervention Grant

- This grant provides funding to offer evidence-based programming (Interactive Journaling and Thinking for a Change) to incarcerated individuals. All milestones specified in the grant were exceeded in 2021.
- The grant was renewed for 2022. However, because of COVID restrictions and limitations on entering the jail, the program has not been operating. We are currently working with jail personnel to provide the service to incarcerated individuals virtually.
- The grant application has been submitted to operate the program in 2023. The department has also applied for a grant to add a probation officer position to supervise a women's specific caseload.

### Restitution/DWI Fees

- In July 2022, the department collected \$10,515.26 in restitution (\$518.24 in surcharge).
- In July 2022, the department collected \$2818.90 in DWI supervision fees.

### **Special Services**

- The department currently has 9 officers who are qualified to carry a firearm full time.
   Special Services Officers execute Violation of Probation warrants and conduct unannounced home visits with probationers.
- As of 8/26/22, the department had 57 active VOP warrants.

### Staffing

- The department presently has 3 Supervisors, 7 Sr. Probation Officers, 15 Probation
  Officers, 3 Probation Assistants, an Administrative Secretary, a Principal Account Clerk,
  an Account Clerk, 2 Typists and 1 Sr. Typist. We currently have a Supervisor and 3
  Probation Officer positions vacant.
- The department has three Probation Officers who are attending the Fundamentals of Probation Practice Academy. The program is approximately 4 weeks, 2 of which are virtual and 2 are in-person in Albany. It is anticipated that these officers will then begin attending the Correction's Academy in September.

### Alternatives to Incarceration (ATI)

 The department receives State funding for the Enhanced Pre-Trial Release program. As such, DCJS requires that a local planning group meet on a regular basis to review the ATI plan and delivery of ATI services. This board is scheduled to meet next on 9/14/22.

### Victim Impact Panel (VIP)

• The department works in conjunction with STOP DWI to provide the Victim Impact Panel. The next panel is scheduled to be held on Wednesday, 8/17/22.
