WHEREAS, the County of Oswego has identified the lack of sufficient municipal wastewater conveyance and treatment as an impediment to the future growth of its communities, and

WHEREAS, the County, the Village of Phoenix, the Town of Schroeppel and the County of Oswego Industrial Development Agency (hereinafter the Partners) also find it desirous to enhance wastewater services to those properties known as the Oswego County Industrial Park as well as the other homes and businesses in the greater Phoenix/Schroeppel area, and

WHEREAS, if funded, these improvements will significantly increase the treatment capacity at the Phoenix Wastewater Treatment Plant as well as the capacity to convey sanitary and industrial wastewaters from the Oswego County Industrial Park, and

WHEREAS, improvements at the Phoenix Wastewater Treatment Plant will also resolve wet weather concerns as identified in the Village's Order on Consent opening-up new opportunities for business growth within and around the Village and the Town., and

WHEREAS, the Partners propose to work together to pursue these improvements including their joint efforts to apply for grants and other sources of funding, and

WHEREAS, the Partners further propose to enter into an Intermunicipal Agreement to guide these projects and the future relationships with each other regarding the use of the improved systems, then therefore be it and it is hereby

RESOLVED, that the County of Oswego does hereby support applications for funds through the Northern Border Regional Commission and other sources that would assist with the development of this project, and be it further

RESOLVED, that the County of Oswego is hereby authorized to assist the Village of Phoenix and the Town of Schroeppel with applications for funding this project from any sources that become available during the course of this project, and be it further

RESOLVED, that the Chairman of the Legislature is hereby authorized to execute any and all documents that may be necessary for the application, acceptance and disbursement of

additional funds for this project from any appropriate sources that become available during the course of this project, and be it further

RESOLVED, that the Chairman if is hereby authorized to enter into an intermunicipal agreement with the other Partners once the respective municipal attorneys and their clients concur on acceptable final language.

#### INFORMATIONAL MEMORANDUM

SUBJECT:

Chairman's authorization

**PURPOSE:** 

This resolution demonstrates support of and authorization for grant applications to enhance wastewater treatment and conveyance systems where appropriate in the County of Oswego. It also endorses the establishment of intermunicipal agreements that may be necessary for these improvements.

**SUMMARY:** 

The county has identified the lack of sufficient wastewater treatment and conveyance systems as a significant impediment for future growth. The county is proposing to work with the IDA, the Town of Schroeppel and the Village of Phoenix to resolve this issue as it affects the ability to attract new businesses to the Oswego County Industrial Park on Rt 481. This resolution acknowledges our commitment to solve this problem and authorizes us to work with the partners referenced above to do so.

FISCAL IMPACT: Approximately \$1 million which could be reduced by grant funds if approved.

RECOMMENDED

**ACTION:** 

The Government, Courts and Consumer Affairs Committee recommends that the Oswego County Legislature authorize these activities.

# INTERMUNICIPAL AGREEMENT BY AND BETWEEN THE TOWN OF SCHROEPPEL, THE COUNTY OF OSWEGO, THE VILLAGE OF PHOENIX AND THE COUNTY OF OSWEGO INDUSTRIAL DEVELOPMENT AGENCY

(Phoenix/Schroeppel Wastewater Treatment and Conveyance Project)

THIS AGREEMENT entered into this \_\_\_\_\_ day of May, 2021 by and between the TOWN OF SCHROEPPEL, a municipal corporation by and of the State of New York with its principal offices for business located at 69 County Route 57A, Phoenix, New York 13135 (hereinafter "Town"); the COUNTY OF OSWEGO, a municipal corporation by and of the State of New York, with its principal offices for business located at the Legislative Office Building, 46 East Bridge Street, Oswego, New York 13126 (hereinafter "County"); and, the VILLAGE OF PHOENIX, a municipal corporation by and of the State of New York with principal offices for business located at 455 Main Street, Phoenix, New York 13135 (hereinafter Village); and, the COUNTY OF OSWEGO INDUSTRIAL DEVELOPMENT AGENCY (hereinafter "IDA"), a body corporate and politic and a public benefit corporation of the State of New York, duly organized and validly existing under the laws of the State of New York with an office at 44 W. Bridge Street, Oswego, NY 13126, the foregoing entities being collectively referred to herein as the "parties,"

#### WITNESSETH:

WHEREAS, the Town of Schroeppel has, heretofore, formed a sewer district known as Sewer District 1 (hereinafter "District") which presently serves the Oswego County Industrial Park which is owned by Operation Oswego County, Inc., but is tax-exempt by virtue of a PILOT Agreement with the IDA as its sole customer; and

WHEREAS, the Town has, heretofore, adopted Local Law 1 of 2011 entitled, a "Local Law for the Management, Control and Operation of Water and Sewer Districts in the Town of Schroeppel" concerning same; and

WHEREAS, the Town and District have statutory authority to undertake sewer conveyance improvements under Town Law Articles 12-A, 12-C and, also, under Town Law §209-a; and

WHEREAS, the Village has heretofore established a complete sewerage system for the Village under Village Law Article 14 and, further, may enlarge its Publicly Owned Treatment Works (hereinafter POTW) pursuant to Village Law §14-1408; and

WHEREAS, the Village is wholly within the Town and County and it has heretofore adopted Chapter 149 of the Village Code, entitled "Sewer Use" which, inter alia, provides for the efficient, economic, environmentally safe, and legal operation of the Village's POTW which has limited capacity at present to handle and process wastewater including wastewater needs from the present Industrial Park; and

**WHEREAS**, the County of Oswego has statutory authority to further economic and municipal cooperation development within its borders under the County Law and the General Municipal Law and, further, it may also opt to create county sewer districts under County Law Article 5-a; and

WHEREAS, the IDA has broad statutory authority regarding economic development and, in particular, regarding industrial pollution control facilities including, but not limited to, water collecting systems, waste water treatment works, sewage treatment works system, sewage treatment system or solid waste disposal facility or site under General Municipal Law §854(8) et seq.; and

WHEREAS, the Town and Village have independent authority under General Municipal Law §119 et seq., concerning entering into agreements the construction and development of excess sewage capacity and facilities; and

WHEREAS, the Town, Village and County have authority to enter into an agreement under Article 5-G of the General Municipal Law§119-0(l), to include matters as are reasonably necessary and proper to effectuate and progress the joint service or a joint water, sewage or drainage project and the IDA has statutory authority to assist the Town, County and Village in furtherance of same; and

WHEREAS, the Town presently owns and operates the District and the parties are desirous of expanding and modernizing the wastewater treatment and conveyance systems in the Town and Village to protect ground and drinking water quality to provide increasing economic development opportunities to support the creation and retention of local jobs and grow the local economy; and

WHEREAS, the County has previously identified the need to improve and enhance wastewater treatment and conveyance systems throughout the County as part of its Strategic Economic Advancement Plan; and

WHEREAS, both the County and IDA want to expand and promote economic development at the IDA-owned Industrial Park serviced by the District and the POTW owned and operated by the Village; and,

**WHEREAS**, the IDA has recently-acquired approximately 200 acres to expand the Industrial Park which will further strain existing conveyance and wastewater treatment assets including the POTW; and

WHEREAS, the lack of sufficient municipal sewer capacity further hinders development in and around the Village and within the Town of Schroeppel which is an otherwise highlycompetitive area for future development; and

WHEREAS, the IDA has commissioned preliminary studies to determine the problems and identify the needed improvements in both the Town's and the Village's current respective

assets and the County is identifying eligible state and federal funding sources; and

WHEREAS, the Parties have discussed this matter and have reached an agreement regarding the payment and reimbursement of the costs incurred in these matters that is fair and equitable; and

WHEREAS, said arrangement promotes intermunicipal cooperation and shared services and is in the best interests of the respective governments and the IDA; and

WHEREAS, the Phoenix/Schroeppel Wastewater Treatment and Conveyance (hereinafter the "project"), when completed, will promote the public health and welfare as well as enhance economic development opportunities at the Oswego County Industrial Park and in the greater Phoenix/Schroeppel area; and

WHEREAS, an intermunicipal agreement to facilitate the Phoenix/Schroeppel Wastewater Treatment and Conveyance project is both necessary and desirable,

**NOW, THEREFORE**, it is mutually agreed as follows:

#### RESPONSIBILITIES OF THE COUNTY OF OSWEGO:

The following is expressly subject to the approval of the Oswego County Legislature:

- (1) The County agrees to contribute an amount for the project not to exceed \$1,000,000 for expenses related to design, construction, engineering and other project expenses expressly contingent upon receipt of state and federal grant funding for same. The actual amount of the County's contribution shall be determined upon the availability of state and federal grant funds and the final cost of the improvements. Should grants be awarded, payments will be quarterly installments (which may be of varying amounts) commencing thirty (30) days after the award of an engineering/design contract for the project.
- (2) Contingent upon the receipt of grant funding, the County will assist the Village and the Town with their efforts to prepare and let bids and proposals for the construction and engineering of the project.
- (3) The County will perform work for the benefit of the project, but, at no time, shall the County own or operate the sewer treatment and conveyance system as said ownership will remain with the Town or Village respectively unless separately agreed to by the Town, Village and County in writing.

#### RESPONSIBILITIES OF THE TOWN OF SCHROEPPEL:

The following is expressly subject to the approval of the Town Board of the Town of Schroeppel:

- (1) To the extent allowed by law, the Town and District agree to allow the County and IDA to connect any of their own structures within the Industrial Park to the sewer district conveyance lines once the project is completed at a rate and term to be determined that takes into account the debt service obligations associated with the project without cost for a period of twenty (20) years to run from the date of this agreement.
- (2) The Town and District agree to obtain and maintain all necessary permits and approvals for the District as may be necessary for the Town to own and operate the District and to operate same in full compliance with all applicable state and federal laws and regulations.
- (3) The Town and District accept and agree to own the lines, pumps, lift stations and mechanicals of the sewer district from the date of completion of construction and will establish an equitable agreement with the Village for any repairs or maintenance necessary (e.g. clogs, broken lift stations, etc.) if not otherwise covered by warranty or regularly performed by the Town.
- (4) The Town will defend and indemnify the District if the District and/or Town is sued in an Article 78 proceeding in connection with the proposed district expansion and/or any agreement with the Village concerning this Project.
- (5) To the extent allowed by law, and, as a partial inducement for IDA assistance hereunder to fund improvements, the Town and District agree to negotiate a mutually acceptable special improvement district charge not to assess any unit charges to for the IDA and take into consideration the use and occupancy of agrees to exempt any new IDA -owned buildings at the Industrial Park in determining such special improvement district charges from normal usage charges for a period of five (5) years.
- 6) To the extent allowed by law, and, as a partial inducement for County assistance hereunder in the funding of the improvements, the Town and District agree to negotiate a mutually acceptable special improvement district charge not to assess any unit charges to for the County and take into consideration the use and occupancy of agrees to exempt any new County owned buildings at the Industrial Park in determining such special improvement district charges from normal usage charges for a period of five (5) years.
- (7) Expressly contingent upon the receipt of grant funding, the Town agrees to contribute an amount not to exceed \$400,000 for expenses related to the completion of "Phase 1" of the project (*i.e.* repairs to the existing District conveyance lines to the Village boundary). The actual amount will be determined based on the availability of other state and federal grant funds and the final cost of the improvements.

- (8) The Town shall be the contracting entity for all work associated with Town or District facilities that are proposed to be constructed and/or improved under this project.
- (9) The Town shall conduct all hearings and filings as may be necessary for this project.

#### RESPONSIBILITIES OF THE VILLAGE OF PHOENIX:

The following is expressly contingent upon approval of the Village Board of Trustees:

- (1) The Village of Phoenix agrees to accept all sewage within the allowable limits of its DEC/EPA permits and its available capacity at the time of final delivery and will work with the Town and District to develop a rate schedule that is consistent with the pricing formulas the Village uses for similar customer classes.
- (2) Prior to the completion of this project, the Village agrees to obtain and maintain all other and further permits and approvals as may be necessary for the Village to receive and treat at its POTW additional sewage from the District and Industrial Park at its own cost and expense.
- (3) Once constructed, the Village shall cooperate with the Town and District regarding district maintenance and related issues necessary for the proper operation of the district, at the Town's request.
- (4) The Village, as the owner of the POTW to be improved under this project, agrees to be contracting entity for all work at, in and around their POTW facility.
- (5) The Village shall conduct all hearings and filings as may be required for this project.
- (6) Expressly contingent upon the receipt of grant funding, the Village agrees to contribute an amount not to exceed \$600,000 for expenses related to the completion of "Phase 1" of the project. The actual amount will be determined based on the availability of other state and federal grant funds and the final cost of the improvements.

#### RESPONSIBILITIES OF THE IDA

The following is expressly contingent upon the approval of the IDA Board:

(1) Contingent upon the receipt of grant funding, the IDA agrees to contribute an amount not to exceed \$1,000,000 for expenses related to the completion of the project. The actual amount will be determined based on the availability of other state and federal grant funds and the final cost of the improvements. Should grants be awarded, payments will be quarterly installments (which may be of varying amounts) commencing thirty (30) days after the award of an engineering/design contract for the project.

#### **ADVISORY COMMITTEE**

The parties agree to form an advisory committee comprised of at least one (1) representative of each party to this Agreement. The committee will convene as needed to review funding opportunities, project details, acceptance and disbursement of funds, and report back to the respective governing body of each party on the status of the project. The advisory committee shall not have any independent decision-making authority and shall only serve as an advisory group to assist in the facilitation of the project in accordance with this Agreement.

#### **ENTIRE AGREEMENT**

This constitutes the entire and integrated agreement among the parties. This agreement may not be changed unless changed by written instrument signed by all parties. By the signatures below, each party represents that the requisite approval has been obtained for the execution of this agreement, the authorizing resolutions having been attached hereto and made a part hereof as **EXHIBIT A.**

This office represents the Estate of James J. Higby. The late Mr. Higby 's son, Christopher M. Higby was appointed as Administrator of the Estate by Oswego County Surrogate's Court on March 5, 2019, a copy of which is enclosed herewith. On January 6, 2020 the Estate received a purchase offer from Francis Steiner and Polly Davis for the purchase of the property located at 415 Valley Road, Pulaski, Town of Richland, County of Oswego and State of New York. Mr. Higby, on behalf of the Estate, and per Surrogate's Court, accepted the purchase offer. A copy of said purchase offer is attached hereto.

On or about March 19, 2020, an abstract of title and ten-year tax search were ordered from Vanguard Research & Title Services, Inc. Due to the directive of Governor Cuomo, the office was considered to be non-essential and the office was closed from March 20, 2020 to July 5, 2020 (reopening on July 6, 2020) whereby this matter had to be placed in limbo). The abstract has now been received and a copy was forwarded to the purchasers in Pennsylvania. Upon review of the abstract by the purchasers, they decided to request title insurance and a commitment for title insurance was ordered and prepared on September 20, 2010. Upon review of the title insurance, the purchasers requested clarification regarding the Limited Letters of Administration issued by Surrogate's Court. After discussing same with Surrogate's Court, amended Limited Letters were issued by the Court on October 21, 2020, with an expiration date on or about April 18, 2021. A copy of same is attached hereto.

After numerous requests made by the office to Vanguard's Title Division in Syracuse as to whether or not the new Limited Letters would be acceptable to the title company to close on the property, the office was advised on or about December 29, 2020 that the title company would, in fact, accept the new letters whereby the sale of the property could proceed.

The deed and other documents were prepared and forwarded to both seller and buyers for their signatures and we are now ready to close. The last paperwork required is the closing statement and Mr. Higby was advised to contact the County Treasurer to obtain a payout of the taxes in order to adjust same for the closing.

Upon contacting the County Treasurer's office, Mr. Higby was advised that the County had taken title to the property and that his only recourse was to attend the auction and purchase the property back. Mr. Higby lives in Midwest City, OK and is unable to come to New York for an auction.

As the attorney for the Estate, our office is respectfully requesting that the Estate be allowed to go forward with the sale of the property in order that the Administrator might be able to finalize the administration of the estate. Anything you could do to assist in this matter would be greatly appreciated.

E911 Communication Technician Reclassification 4/23/21

Over the past year the tasks assigned to the 911 Communications Technician were required to be increased with the addition of the new Records Management System that was brought online. The 911 Communications Technician is one of the primary administrators of the RMS. While working with the Sheriff's Office some gaps have been identified in support also. The gaps identified line up with some of the tasks that the 911 Communications Technician provides to the E911 department. While discussing these gaps with the Director of IT, it was noticed that a large quantity of the tasks being performed by the 911 Communications Technician align with the tasks performed by Computer Specialist. The 911 Director and IT Director discussed consolidating the positions. However, both Directors agree that E911 has needs that can't always be met by IT. The 911 Communications Technician regularly works off hours and is on call should an issue arise. They both also agree that offering the services that the 911 Communications Technician can provide, to the Sheriff's Office would be a much better use of the skills that are available.

The 911 Communication Specialist is currently a grade 8 annual salary, and a Computer Specialist is a grade 11. The 911 Director is requesting to reclassify the 911 Communications Technician to a 911 Communications Specialist that would be a grade 11 to better align with employees performing some of the same tasks with less responsibility. The increase in salary would be approximately \$6,500 for 2021. Due to savings from openings in the E911 department there is no need to increase the E911 budget for this request.



Purpose:

To amend the 2021 Office for the Aging budget to accept and allocate an additional \$47, 877 in funding from the HDC5 of the Consolidated

Appropriations Act.

Background:

The New York State Office for the Aging (NYSOFA) has allocated additional funds under the Consolidated Appropriations Act to the Oswego County Office for the Aging (OFA) to be used for Nutrition Services to be used during the time period of December 27, 2020 -September 30, 2022.

The funding will help cover the cost of an additional 7,993 meals provided to seniors aged 60+ due to the ongoing need for meals during the continued COVID-19 Emergency. OFA has provided 69,886 meals to 772 participants during the 1st quarter of 2021, an average of 23,295 meals per month.

Purpose:

Establish Capital Project No. CO320 Camp Hollis Renovations

Summary:

Oswego County has been notified by the NYS Office of Parks, Recreation and Historic Preservation that we are eligible for funding (\$229,000) known as Consolidated Funding Application (CFA) to support our Camp Hollis Lodge Renovation.

The Camp Hollis Lodge has capital improvement needs that can be addressed with this funding which would include winterization that would allow a true extension of the rental season.

**Recommended Action:** 

The department recommends the budget modification to establish Capital Project No. CO320 Camp Hollis Renovations be approved.

 NOTE: this resolution was submitted April 9, 2020 but was pulled because of unknown circumstances with COVID-19. Camp Hollis is a campground featuring a main lodge as well as several smaller cabins and buildings throughout the property. The Camp is best known for hosting a children's summer camp for youth ages 8 to 14. However, the Camp caters to a variety of other groups including private vacationers, company retreats, specialty camps for senior citizens, a bereavement camp hosted by Friends of Oswego County Hospice, Boy Scouts, other community groups, and even weddings. Activities available at the Camp include sports fields, a team-building challenge course, outdoor swimming pool, outdoor performance stage, playground, hiking trails, and lakeside views. The Camp has substantial demand for use during its current offseason from November through April. In order to accommodate tourists and community members who wish to utilize its facilities, Oswego County will winterize the main lodge at the Camp. After obtaining funding approval in December of 2019, the County will solicit an RFP and select a contractor in summer of 2021. Work will likely commence during the early fall. Along with the contractors, the County Buildings and Grounds Department will provide oversight and assistance, and students at the local CiTi BOCES will provide labor as part of their curriculum. The renovations will fully winterize the lodge: installing a furnace, upgrading the existing windows and doors, moving the pipes to below the freezing level, updating the electrical panel, adding insulation, and installing a new deck. All project phases should be complete by the spring of 2022. The items outlined in this narrative and in the budget will accomplish the project goal of winterizing the lodge and effectively extending the usable season of the facility. Rather than closing the Camp down in October, the County will now be able to keep the facilities open year-round, increasing revenues, and providing recreational opportunities in the winter months to residents and visitors.

SUBJECT: Request for approval to accept \$240,000 from the Coronavirus Aid, Relief and

Economic Security (CARES) Act ERAP.

**SUMMARY**: The NYS Office of Temporary and Disability Assistance has launched a

program funded through federal CARES II Act. NYS Senate and Assembly passed bills in January 2021 that provided federal funds to prevent eviction and homelessness in counties throughout NYS. Counties / cities over 200,000 citizens, like Onondaga County, were provided their own allocations. All other counties will be served by a program that will be administered by NYS Office of Temporary and Disability Assistance (OTDA). OTDA is making progress towards the implementation of the NYS Emergency Rental Assistance

Program (ERAP) supported by the federal CARES II Act.

The state does not have a date when ERAP will be launched – maybe sometime in May, nor do they have the web-based portal up and running – which is the only way for people to apply for the funds. The state understands that many local districts have been under a hiring freeze and staffing levels are low. The reality is, once this program is launched by the state, our Oswego County citizens will call or come to DSS. Our most vulnerable citizens may not have a computer to go on-line and apply for the funds. It will also involve uploading documents. Funding can be applied to 12 months of arrears for rent, utilities, and 3 months forward for rent. Landlords will be required to enroll and participate in the electronic payment system to get their money. NYS OTDA will provide the funds directly to landlords or utility companies.

NYS OTDA has allocated \$240,000 for Oswego County DSS to assure there are outreach strategies to facilitate vulnerable populations in accessing this program. NYS OTDA is providing DSS 30 days once the program is launched to connect vulnerable populations to the portal and facilitate the application, then it will open to all others until the funds are gone. OTDA advised we can contract out to a private partner who can mobilize this outreach effort locally. DSS will be submitting an Outreach Plan to NYS OTDA for approval that will provide a mix of DSS and private agency outreach activities, including to "small" landlords (considered by OTDA as 40 or less units).

Oswego County DSS received and will be administering the Emergency Solutions Grant (ESG) program funds totaling almost \$1M in federal CARES II Act funds. The criteria are different and what is covered is different – DSS will be administering that program. With the ESG grant funds, DSS distributes

directly to landlords and utility companies. With ERAP funds, NYS OTDA will distribute directly to landlords and utility companies.

There is no local share associated with the acceptance of these funds.

### **RECOMMENDED**



### **Dear County Leaders**

Thank you for your ongoing partnership with the New York State Department of Environmental Conservation (DEC) as we work to protect and steward our natural resources. I write to you today with exciting news on a new deer hunting opportunity that was included in the 2021-2022 New York State Budget that will provide new economic opportunities to your local hunting economies.

In upstate counties that choose to participate, youth hunters aged 12-13 will now be allowed to hunt deer with a firearm or crossbow under the supervision of an experienced adult hunter. Currently, young hunters that are 12 or13 years old can already hunt big game using archery equipment and can hunt small game with a firearm. However, until now, New York had been the only state to not allow these young hunters to hunt big game with a firearm.

Deer hunting is a valued tradition for many upstate families, providing quality food to New Yorkers and reducing the negative impacts of overabundant deer populations on agriculture, forests, and communities. Expanding youth hunting opportunities to assist with deer management and cultivating a new generation of hunters is a top priority for DEC, and we look forward to working with you to realize and capitalize on this new opportunity included in the State Budget.

The program as enacted by the legislature is treated as a pilot for upstate counties through 2023. Specifically, the new law (Environmental Conservation Law Section11-0935):

- allows 12-13 year old licensed hunters to hunt deer with a rifle, shotgun, or muzzleloading firearm in areas where and during the hunting seasons in which such firearms may be used;
- allows 12-13 year old licensed hunters to hunt deer with a crossbow during the times when other hunters may use crossbows;
- maintains existing youth hunting safety requirements, including:
  - o supervision by an experienced and licensed adult hunter who maintains physical control over the youth hunter at all times,
  - o requires the youth hunter and adult mentor wear fluorescent orange or pink clothing, and
  - o requires both the youth hunter and adult mentor to remain at ground level while hunting deer with a crossbow, rifle, shotgun, or muzzleloader.

Most importantly, the legislation requires each county to "opt-in". Counties comprising New York City, Westchester, Nassau, and Suffolk are specifically excluded from participation by the legislature.



In accordance with the requirements of the new law (legislation enclosed), DEC encourages your county to consider passage of a local law opting into the new hunting pilot for 12-13 year-old hunters. If such local legislation is in place and DEC is notified by June 1, we will be able to publish it in our annual hunting and trapping regulations guide. However, as long as your county adopts a local law to opt-in to the program and informs DEC by September 1, we will provide this information for hunters on DEC's website leading into the 2021 big game seasons.

I hope that your county will strongly consider "opting-in" to this exciting new opportunity to support our young hunters. To notify DEC of your local law opting into this program, or if you have any further questions or need any assistance regarding this new pilot, please contact our Division of Fish and Wildlife at <a href="wildlife@dec.ny.gov">wildlife@dec.ny.gov</a> and 518-402-8883.

These comments are offered by NYSSA in response to the proposed regulation regarding Fish and Wildlife Management Areas. Overall, the Association applauds the Department's effort to control the public's behavior while on lands designated as Wildlife Management Areas. NYSSA does have a few concerns with the proposed regulations.

The regulation should have a statement of intent and purpose for Wildlife Management areas Few people outside the hunting and fishing community know what a Wildlife Management Area is, how its creation was funded and what uses take priority on these lands. I recently came across a person from the equestrian community who could not understand why their access was restricted in the fall of each year. Having a statement of purpose for these lands could help educate the public and demonstrate that the regional manager's actions were consistent with this policy.

The proposed regulation leaves a great deal of discretion and interpretation to the regional manager which is not required to be explained in a public forum. Each WMA should be subjected to a recreational use plan that would describe and provide for the hunting opportunities on the unit, establish what compatible outdoor recreational uses should be allowed, when and where they should be allowed. While hunting, fishing and trapping must be a priority along with the conservation of important wildlife resources, on many parcels bicycle use, equestrian use, wildlife viewing, and snowmobile use can be accommodated if planned for. While many of these uses may not be appropriate in the fall, they may have little to no impact on the primary use of fishing and hunting during other times of the year. Having a public process that allows the primary users and the secondary users to voice their interest and concerns, ensures that both know the others' concerns. Most importantly the regional manager will not be perceived to be making arbitrary decisions on the use of the WMA.

While I believe interfering with legal hunting is addressed in other sections of the Environmental Conservation Law, I believe the regulation should address deliberate interference with the legitimate and allowed uses of the WMA. For instance, a person on a bicycle should not be allowed to harass someone on horseback. A hiker should not be allowed to touch a legally set trap. Based on increased interest in the use of public spaces there is an opportunity here for WMA's to meet some of that need while protecting the primary use.

WMA Comments 5-10-21 P.2

Many snowmobile trails pass through WMA's. They are important to our network of trails throughout the state. Establishing a process where snowmobile use as well as other uses are discussed within the larger context of the resource management goals for the unit would assure everyone that our collective need for outdoor recreation is being considered fairly. Administrative roads within these WMA's should be considered for other recreational uses during appropriate times of the year.



# **COUNTY OF OSWEGO**

Computer System Security Breach Notification Policy

- 1. PURPOSE: This Computer System Security Breach Notification Policy is intended to alert individuals to any potential identity theft as quickly as possible so that they may take appropriate steps to protect themselves from and remedy any impacts of the potential identity theft or security breach. This policy is consistent with and adopted pursuant to New York State Technology Law § 208. Where there is a separate federal or state law or regulation covering any breach, that provision shall control (See: Exceptions below).
- 2. DEFINITIONS: The following terms have the following meanings:
  - a. Breach of System: The unauthorized acquisition of computerized data which compromises the availability, security, confidentiality, or integrity of personal information maintained by the County. Good faith acquisition of personal information by an employee or agent of the County for the purposes of the County is not a breach of the security of the system, provided that the private information is not improperly used or subject to unauthorized disclosure.

In determining whether information has been acquired, or is reasonably believed to have been acquired, by an unauthorized person, the County may consider the following factors:

- i. Indications that the information is in the physical possession and control of an unauthorized person, such as a lost or stolen computer or other device containing information; or
- ii. Indication that the information has been downloaded or copied; or
- iii. Indications that the information was used by an unauthorized person, such as fraudulent accounts opened, or instances of identity theft reported; or
- iv. Indications of unauthorized access to the County computer systems, where likelihood of unauthorized access to unencrypted information is high, but specific evidence of exfiltration is absent.
- b. Consumer Reporting Agency: Any person or entity which, for monetary fees, dues or on a cooperative nonprofit basis, regularly engages in whole or in part in the practice of assembling or evaluating consumer credit information or other information on consumers for the purpose of furnishing consumer reports to third parties, and which uses any means or facility of interstate commerce for the purpose of preparing or furnishing consumer reports. A list of consumer reporting agencies may be obtained upon request to the State Attorney General.

- c. *Department*: Any board, committee, commission, council, department, office or other governmental entity performing a governmental or propriety function for the County.
- d. *Personal Information*: Any information concerning a natural person which, because of name, number, personal mark, or other identifier, can be used to identify that person.
- e. *Private Information*: Personal information in combination with any one or more of the following data elements, when either the personal information or the data element is not encrypted, or encrypted with an encryption key that has also been acquired:
  - i. Social Security Number;
  - ii. Driver's license number or non-driver's identification card number;
  - iii. Account number or credit/debit card number, in combination with any required security code, access code or password, which would permit access to an individual's financial account;
  - iv. Private information does not include publicly available information that is lawfully made available to the general public from County records.
- f. *County*: The County of Oswego, State of New York.
- 3. DISCLOSURE OF BREACH TO AFFECTED PERSONS: Any County Office or Department that owns or licenses computerized data that includes private information must disclose any breach of the security of the system following discovery or notification of the breach to any resident of New York State whose private information was, or is reasonably believed to have been, acquired by an unauthorized person. The disclosure must be made in the most expedient time possible and without unreasonable delay, consistent with the legitimate needs of law enforcement, as provided in paragraph 5 below, or any measures necessary to determine the scope of the breach and restore the reasonable integrity of the data system. The County IT Department shall consult with the State Office of Information Technology Services to determine the scope of the breach and restoration measures if necessary.
- 4. DISCLOSURE OF BREACH TO OWNER OR LICENSEE: If the County maintains computerized data that includes private information which the County does not own, the County must notify the owner or licensee of the information of any breach of the security of the system immediately following discovery, if the private information was, or is reasonably believed to have been, acquired by an unauthorized person.
- 5. PERMITTED DELAY: Notification pursuant to this Policy made be delayed if a law Page 2 of 9

- enforcement agency determines that notification could impede a criminal investigation. The notification must be made after the law enforcement agency determines that notification would not compromise any criminal investigation.
- 6. METHOD OF NOTIFICATION: The required notice must be directly provided to the affected individuals by one of the following methods:
  - a. Written notice;
  - b. Electronic notice, provided that the person to whom notice is required to be provided has expressly consented to receiving notice in electronic form and a log of each such electronic notification is kept by the Village; and provided further that no person or business may require a person to consent to accepting notice in electronic form as a condition of establishing any business relationship or engaging in any transaction;
  - c. Telephone notification, provided that a log of each such telephone notification is kept; or
  - d. Substitute notice, provided that the County demonstrates to the State Attorney General that the cost of providing notice would exceed \$250,000, or that the number of individuals to be notified exceeds 500,000, or the County does not have sufficient contact information. Substitute notice must include all of the following: i. Email notice, if the County has an e-mail address for the subject person(s); ii. Conspicuous posting of the notice on the County's website; iii. Notification to major statewide media.
- 7. INFORMATION REQUIRED: Regardless of the method by which notice is provided, the notice must at a minimum include contact information for the County and a description of the categories of information that were, or are reasonably believed to have been, acquired by the unauthorized person, including specification of which of the elements of personal information and private information were, or are reasonably believed to have been, acquired.

County notifications shall include:

What Happened?	[Describe how the data breach happened, the date of the breach, and how the stolen information has been misused (if you know)].
What Information Was Involved?	This incident involved your [describe the type of personal information that may have been exposed due to the breach].

Such notice must be made without delaying notice to the affected individuals.

Whenever more than 5,000 New York State residents are to be notified at one time, the County must also notify consumer reporting agencies as to the timing, content and distribution of the notices and the approximate number of affected individuals. Such notice must be made without delaying notice to the affected individuals.
- 9. AUTHORITY: New York State Technology Law §208

Application. Any person, business, or state entity (excepting the judiciary, cities, counties, municipalities, villages, towns, and other local agencies) (collectively, Entity) which conducts business in New York State and which owns or licenses computerized data which includes private information.

Security Breach Definition. Unauthorized acquisition or acquisition without valid authorization of computerized data that compromises the security, confidentiality, or integrity of PI maintained by a business.

Unauthorized access to, or access without valid authorization of computerized data that compromises the security, confidentiality, or integrity of private information maintained by a business. In determining whether information has been accessed, or is reasonably believed to have been accessed, by an unauthorized person or a person without valid authorization, Entities may consider, among other factors, indications that the information was viewed, communicated with, used, or altered by a person without valid authorization or by an unauthorized person.

In determining whether information has been acquired, or is reasonably believed to have been acquired, by an unauthorized person or a person without valid authorization, Entities may consider the following factors, among others:

Indications that the information is in the physical possession and control of an unauthorized

person, such as a lost or stolen computer or other device containing information;

Indications that the information has been downloaded or copied; or

Indications that the information was used by an unauthorized person, such as fraudulent accounts opened, or instances of identity theft reported.

Good-faith access to or acquisition of private information by an employee or agent of the Entity for the purposes of the Entity is not a breach of the security of the system, provided that the private information is not used or subject to unauthorized disclosure.

**Notification Obligation.** Any Entity to which the statute applies shall disclose any breach of the security following discovery or notification of the breach in the security of the system to any resident of NY whose private information was, or is reasonably believed to have been, accessed or acquired by a person without valid authorization.

**Notice to affected persons** is not required if the exposure of private information was an inadvertent disclosure by persons authorized to access private information, and the Entity reasonably determines such exposure will not likely result in misuse of such information, or financial harm to the affected persons or emotional harm in the case of unknown disclosure of online credentials. This determination must be documented in writing and maintained for at least five years. If more than 500 NY residents are affected, the Entity shall provide the written determination to the state Attorney General within ten days after the determination.

**Notification to Consumer Reporting Agencies.** If more than 5,000 NY residents are to be notified at one time, the Entity shall also notify consumer reporting agencies as to the timing, content and distribution of the notices and approximate number of affected persons.

Attorney General/Agency Notification. If any NY residents are to be notified, the Entity shall notify the state Attorney General, the department of state consumer protection board, and the division of state police as to the timing, content and distribution of the notices and approximate number of affected persons and shall provide a copy of the template notice sent to affected persons. The state AG's website has a form to be used for notifications.

Any Covered Entity required to provide notification of a breach, including breach of information that is not "private information" as defined herein, to the Secretary of Health and Human Services pursuant to HIPAA or the HITECH Act, shall provide such notification to the state Attorney General within 5 days of notifying the Secretary.

Third-Party Data Notification. Any Entity that maintains computerized data that includes private information that the Entity does not own shall notify the owner or licensee of the information of any breach of the security of the system immediately following discovery, if the private information was, or is reasonably believed to have been, acquired by a person without valid authorization.

**Timing of Notification.** The disclosure shall be made in the most expedient time possible and without unreasonable delay, consistent with any measures necessary to determine the scope of the breach and restore the reasonable integrity of the system.

**Personal Information Definition.** Information concerning a natural person which, because of name, number, personal mark, or other identifier, can be used to identify such natural person.

## **Private Information Definition.**

Personal information consisting of:

(1) any information in combination with any one or more of the following data elements, when either the data element or the combination of personal information plus the data element is not encrypted, or is encrypted with an encryption key that has also been accessed or acquired:

Social Security Number;

Driver license number or non-driver identification card number;

Account number, credit, or debit card number, in combination with any required security code, access code, password or other information that would permit access to an individual's financial account.

Account number, credit, or debit card number, if circumstances exist wherein such number could be used to access an individual's financial account without additional identifying information, security code, access code, or password; or

Biometric information, meaning data generated by electronic measurements of an individual's unique physical characteristics, such as fingerprint, voice print, retina or iris image, or other unique physical representation or digital representation of biometric data which are used to authenticate or ascertain the individual's identity; or

(2) A username or email address in combination with a password or security question and answer that would permit access to an online account; or

"Private information" does not include publicly available information which is lawfully made available to the general public from federal, state, or local government records.

**Notice Required.** Notice shall include:

Contact information for the Entity making the notification; and a description of the categories of information that were, or are reasonably believed to have been, acquired by a person without valid authorization, including specification of which of the elements of PI and private information were, or are reasonably believed to have been, so acquired. The notice required shall be directly provided to the affected persons by one of the following methods:

# Written notice.

Telephonic notice, provided that a log of each such notification is kept by the Entity; or Electronic notice, provided that the person to whom notice is required has expressly consented to receiving said notice in electronic form and a log of each such notification is kept by the Entity who notifies affected persons in such form; provided further, however, that in no case shall any Entity require a person to consent to accepting said notice in said form as a condition of establishing any business relationship or engaging in any transaction.

Substitute Notice Available. If the Entity demonstrates to the state AG that the cost of providing notice would exceed \$250,000, or that the affected class of subject persons to be notified exceeds 500,000, or the Entity does not have sufficient contact information. Substitute notice shall consist of all of the following:

Email notice, when the Entity has an email addresses for the subject persons, except if the breached information includes an email address in combination with a password or security question and answer that would permit access to the online account, in which case the Entity shall instead provide clear and conspicuous notice delivered to the consumer online when the consumer is connected to the online account from an internet protocol address or from an online location which the Entity knows the consumer customarily uses to access the online account.

Conspicuous posting of the notice on the Entity's Web site if the Entity maintains one; and Notification to major statewide media.

**Exception:** Compliance with Other Laws. If notice of the breach of the security of the system is made pursuant to any of the following laws by the County, nothing in this policy shall require separate notice to affected individuals, but notice must still be provided to the regulators noted above and the consumer reporting agencies.

- 1. Regulations promulgated pursuant to Title V of the federal Gramm-Leach-Bliley Act (GLBA);
- 2. Regulations implementing the Health Insurance Portability and Accountability Action of 1996 (HIPAA) and the Health Information Technology for Economic and Clinical Health Act (HITECH);
- 3. Part 500 of Title 23 of the Code of the State of New York (NY DFS Cybersecurity Regulation)
- 4. Any other data security rules and regulations of, and the statutes administered by, any official department, division, commission, or agency of the federal government or New York state government.

# Other Key Provisions:

**Delay for Law Enforcement.** The notification required by this section may be delayed if a law enforcement agency determines that such notification impedes a criminal investigation. The required notification shall be made after such law enforcement agency determines that such notification does not compromise such investigation.

**AG Enforcement.** The AG may bring an action to enjoin and restrain the continuation of such violation.

NOW, THEREFORE, upon recommendation of the Infrastructure and Facilities Committee of this body, it is hereby



# INFORMATIONAL MEMORANDUM

Subject: Resolution authorizing the Treasurer to reclassify positions within the County Treasurer's office. These changes will be Budget Neutral.

# **Background:**

The County Treasurer's Office has increased department revenue by 10% and decreased expenses by 5% since 2018. Not included in this number is Community College where better policing has saved County constituents the 7% mandated state increase in 2020 and a savings of \$875,730 in 2021. Something that should make the Legislature proud. A lot of factors play into those numbers but having a great workforce is the beginning.

Over the past 3-years the focus has been trying to make it easier for the public to have online access to County Treasurer functions. Some of the tasks below began implementation prior to the 2020 pandemic which made it easier for the public to do tasks safely. We were ahead of the curve.

Foreclosure has risen to the top of importance, not only to the County but also how NYS now handles STAR processing on delinquent tax properties. The process had to be better defined to insure we properly follow the Real Property Foreclosure Law and new mandates by NYS.

# **Implemented Online Systems include:**

- Image Mate Real Property Software Enhanced view to taxes
- Tax Collection Software Maintains Electronic tax collection.
- X-Press Pay Software Tax payment software.
- Certificate of Residency Community College students
- Occupancy Tax- Occupancy Tax Filing and Collections
- Delinquent Contract contracts Real Property Installment Agreements
- Vendor ACH online payments
- Payroll ACH online payroll
- Oswego County Foreclosure Auction

<u>Reason-</u> With all these new systems the needed employee <u>skill set</u> has changed drastically. The work functions no longer need people to focus on stuffing envelopes and basic counter cash transactions but have progressed to being able to manage the online systems as well assisting the public on these systems. Our success has been publicly recognizable during the pandemic period. That is why the importance of the position upgrades with the front-end staff of Account Clerk to Senior Account Clerk and Senior Account Clerk to Principal Account Clerk.

In our Foreclosure process, there always has been three people doing the Foreclosure process within the Treasurer's Office, due to the requirements of the Foreclosure Law and the continuous manual processes required to meet those requirements. By having a Foreclosure Coordinator, their sole responsibility will be the beginning to end Foreclosure process. This will reduce the staff requirements to two people as the process will include the Principal Clerk who will be focusing on the City Foreclosures. In the past, the Treasurer's Department has learned that missing or incorrect information during a Foreclosure costs the County thousands of dollars due to potential lost sales or legal delays. The Foreclosure process is a year-round activity because Foreclosure cycles overlap resulting in extreme concentration in which properties are in which Foreclosure. With the County moving from a four year to a two-year closure, it has tripled the number of properties in a Foreclosure process.

# **Conclusion:**

In private business you wait until the books are closed to review and see what changes make financial and operational sense. After we closed the 2020 books, using a three-year historical comparison I can comfortably say this request will be **budget neutral**. The budget modification needed for salaries and fringe will be offset by a reduction in Consulting Fees in the amount of \$11,950. In 2022 budget line A1325.543700 Consulting will be reduced next year by \$25,000 to cover this change.

**Recommendation:** The County Treasurer strongly recommends this request to maintain continuity of operations.

# BACKGROUND:

On March 11, 2021, the American Rescue Plan Act (ARPA) of 2021 (H.R. 1319) was signed into law, and includes \$65.1 billion in direct aid to counties and several additional funding opportunities for counties, to combat the COVID-19 pandemic, including its public health and economic impacts. Oswego County is to receive an estimated total of \$22,715,479 by March 11, 2022, and will soon receive the first installment of approximately \$11,357,739.50. The US Treasury has not issued guidance yet on the use of these funds, but we do know we will have to account for them and maintain separate accounts for them. The funds must be fully allocated to allowable uses by December 31, 2024.

### PURPOSE:

It is necessary to establish revenue and expense accounts within the county budget to manage, track, monitor, and report ARPA revenues and expenses separately from other accounts. This Resolution establishes a budgetary department (No. 1011) under the Legislature's budgetary department (No. 1010) and creates the initial account lines needed. This treats the ARPA funds as a federal grant, so that its accounts can be rolled from year to year. All current internal controls and authorizations for the expense or transfer these funds are in force.

RECOMMENDATION: Approve the attached budget modification.

FINANCIAL IMPACT: Increases the General Fund by \$11,357,739.50 in restricted use monies.
