LOCAL STATE OF EMERGENCY MESSAGE

TO: DIRECTOR, MACOMB COUNTY DEPARTMENT OF EMERGENCY MANAGEMENT AND COMMUNICATIONS - COMMANDING OFFICER – EMERGENCY MANAGEMENT AND HOMELAND SECURITY DIVISION, MICHIGAN STATE POLICE; DISTRICT 2 NORTH EMERGENCY MANAGEMENT & HOMELAND SECURITY DIVISION COORDINATOR

On Tuesday, March 10, 2020, the first two cases of novel coronavirus (COVID-19) were detected in the State of Michigan. As of today, March 17, 2020, all K-12 schools have been ordered closed by the governor, many colleges and universities have suspended face-to-face instruction, public gatherings have been limited and public gathering places, including bars and restaurants, closed, and retail establishments are facing shortages of essential supplies.

In the coming days, we expect additional facility closures, more limited public gatherings, employee absences to attend to illness and/or family matters, and continued supply shortages.

In order to effectively marshal the resources of the City of Roseville government to respond to this unprecedented situation I, as elected Mayor of the City of Roseville, in accordance with Section 10 of Public Act 390 of 1976, as amended, do hereby declare that a “state of emergency” exists within our City, that the response and recovery elements of our emergency operations plan have been activated, and that City resources are being utilized to the fullest extent possible.
