#2025-04 – AN ORDINANCE AMENDING THE CONTRACT WITH THE WOOD COUNTY

SHERIFF'S OFFICE FOR DISPATCHING SERVICES AND DECLARING AN EMERGENCY.

FIRST READING

Mr. Oberdorf moved and Ms. Reynolds seconded the motion to read by title only. All ayes. Motion carried. Ms. Murray said we have been using the sheriff's office for more than a decade for our dispatching and with the increase in calls throughout the county the sheriff is adding another dispatcher with additional costs. Mr. Owen asked that this be given a first reading only so as to research how the additional costs were computed. This was given a first reading only.

#2025-05 – AN ORDINANCE AMENDING (SUPPLEMENTAL NO. 2) THE ANNUAL

APPROPRIATION MEASURE FOR THE YEAR BEGINNING JANUARY 1, 2025 AND ENDING DECEMBER 31, 2025 PASSED BY ORDINANCE 2024-79. FIRST READING

Ms. Reynolds moved and Mr. Owen seconded the motion to read by title only. All ayes. Motion carried. Mr. Kirk said we are adding a second and third year to our contract with Cumulus, who is our email provider, and this will add the additional two years of the contract to the budget. Ms. Reynolds moved and Mrs. Eckel seconded the motion to suspend with the second and third readings. Audience comments were

requested and none received. Vote on the motion all ayes. Motion carried. Mr. Owen moved and Ms. Reynolds seconded the motion to adopt. All ayes. Motion carried.

Ms. Reynolds thanked interim fire chief Vascik for his hard work and said she is excited for the appointment of the new chief and said the department is headed in the right direction.
