

AMENDMENT TO COOPERATIVE ENDEAVOR AGREEMENT
(Manned Model Training)

This Amendment to Cooperative Endeavor Agreement (the "Amended CEA") is made and entered into effective as of the date of full execution, by and between the following parties:

ST. TAMMANY PARISH GOVERNMENT, a political subdivision of the State of Louisiana and the governing authority of St. Tammany Parish, whose mailing address is P.O. Box 628, Covington, Louisiana, 70434, herein appearing by and through Patricia P. Brister, Parish President, duly authorized by law (hereinafter referred to as "Parish"); and

MARITIME PILOTS' INSTITUTE, INC., a Louisiana non-profit corporation, whose mailing address is 8440 Jefferson Highway, Suite 301, Baton rouge, La 70809, represented herein by and through George B. Burkley, its Executive Director (hereinafter referred to as "MPI").

WHEREAS, effective as of January 1, 2013, Parish and MPI entered into that Cooperative Endeavor Agreement as amended by the Amendment to Cooperative Endeavor Agreement dated effective December 23, 2013 (collectively, the "Original CEA"), wherein the MPI agreed to provide manned model maritime training and continuing education programs; and

WHEREAS, the parties have identified a need to amend the Original CEA to extend the term and to acknowledge receipt and implementation of additional equipment and assets; and

NOW THEREFORE the parties desire to enter into this Amended CEA in order to state each party's obligations more fully herein and desire to amend and/or add the following provisions. This Amended CEA is not intended to release any party from the obligations stated in the Original CEA, but is intended only to amend certain provisions to the Original CEA:

1. The foregoing recitals are hereby incorporated into the body of this Amended CEA as if fully rewritten and restated herein.
2. Section 4(a.), the term "Property" and Exhibit "A" of the Original CEA are amended to:
 - a. Remove the following item: Sharp LC LED LCD TV – 52", Model #52LE640U, Serial #B207872732, purchased 8/8/12 for \$1,149.00, disposed of 9/8/14 for surplus auction; and
 - b. Add the following item: Insignia LED 65" HDTV, Model #NS-65D550NA15, Serial #T1114GNS65D550NA15H10087, purchased 9/8/14 for \$1,196.24.
3. Section 5(a.) of the Original CEA is hereby amended and restated as follows:

5.(a.) The term of this Agreement shall begin effective January 1, 2013 and continue in full force and effect until December 31, 2016. Prior to the end of the term, the parties can enter into negotiations for a new contract, should both parties be willing to do so.
4. This Amended CEA supersedes the Original CEA only where there exists any conflict. This Amended CEA controls any conflicts of any terms or conditions. Except as amended hereby, the Original CEA remains unmodified and in full force and effect.
5. All capitalized terms used herein but not defined shall have the meaning assigned to them in the Original CEA.

6. AND NOW, INTERVENING HEREIN, is Locus, L.L.C., a Maryland limited liability company, whose mailing address is 205 Rushley Road, Arnold, Maryland, 21012, authorized to do and doing business in the State of Louisiana, with its principal business establishment in Louisiana located at 401 New Hampshire, Covington, Louisiana, 70433, who declares that in and for the consideration recited herein and in the Original CEA, Locus does hereby agree and consent to the renewal and/or extension of the term as provided by this Amended CEA in order to continue to obligate Locus, L.L.C. to provide the insurance enumerated in Sections 6(b) through 6(d) (both inclusive) of the Original CEA during the renewed and/or extended term.

THUS DONE AND SIGNED in multiple original counterparts, to be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one in the same instrument.
