

Questions or Comments:

Speaker: Francis Dunn

- I would like to talk about things that we would like the parish to do for the West 30's
- The West 30's have done two plans, so what I am going to give to y'all are recommendations that was given to us by our planners
- One of the things they tried to install in us is to invoke pride in our own neighborhood and I tell
 you as I walked through our neighborhood there are some facilities that the parish owns that do
 not invoke pride. One in on 29th Avenue, the old Parish Concrete site. Would this plan assist in
 moving that blight off of that property and make that accessible for somebody to out something
 like senior housing, that facility should be used for senior housing
- Also for the Budweiser site, your maintenance barn, I don't know why you couldn't keep it at Koop Drive, but let's open up 22nd Avenue so that we can extend the Trace; The Trace is one of the prides of St. Tammany Parish and that facility cuts off the West 30's from continuing the Trace. We can just put some fence up and do some landscaping so it looks like y'all have pride in the West 30's.
- And also, the Fairgrounds. The fairground sits idle for many months of the year. That facility
 could be used for some purpose in the West 30's. It's taking up all this land, area in the West
 30's so we could finds so means to use that facility maybe for economic reasons, something, just
 to bring hope to the West 30's
- Also, my number one thing is site housing. We would like to know if there are any means for us
 to do scattered site housing. Everybody does not need to be a homeowner; there is a need for
 good rental property that is managed. You cannot tell homeowners they need to cut their grass
 or pick up their trash, but scattered site housing. If we could form a partnership with the Parish,
 the City, and VOA that would be a great access to the West 30's to improve the value of our
 homes.
- Also you can't have in a neighborhood, which our planners instilled in us, everybody on the same economic stage. You got to have some people that has a more elevated living standard so that our kids can see what it is to achieve those things that we want to instill in them. If we keep at the same status in the West 30's we will not have a community in 15 years. We will have failed our children. Because they have nothing to look up to.
- Also drainage. We need to do something about the drainage coming from Collins Boulevard to Columbia Street. When it rains our kids have to stand in the rain to catch busses. So we need to see if we can form some of these intergovernment agreements to improve quality of life in the West 30's.

Speaker: Nahketah Bagby

 I noticed that in the consolidated plan that you did 5 years ago, you had the needs separated in various categories. The first list that I have deals with infrastructure and non-housing community development needs. Let me piggy packed on a project that Ms. Francis talked about, but I will go into a little more detail. We would like to look at doing a North Covington Drainage Improvement Project and this project would encompass The Savannah's, River Glen, Ozone, Covington Point and the West 30's Neighborhood. This project would be to address drainage needs and improvements for properties in both the Parish and the City and the main purpose there would be to decrease flooding. No for me, I just had a planning commission meeting on the 8th, in was just a little meeting because the Savannah's neighborhood wanted to change their phase lines for phase six. At that meeting, guess who should up to also complain about drainage, the Folks from River Glenn Neighborhood. So dealing with that drainage problem in North Covington is something that the Parish Engineering staff and the City Engineering staff have been trying to solve for years. So that would help tremendously, if we could look at that for both properties in the Parish and in the City.

- Another project would be the Mile Branch Drainage Project. Now, the Mile Branch Creek passes
 through the West 30's neighborhood. And this would entail looking at stabilization and a safety
 improvement project for the portion of the Mile Branch that passes through the West 30's. In
 particularly dealing with drainage improvements, erosion control and pedestrian crossing as you
 cross the Mile Branch.
- Related to that, and keeping with that, is looking at some complete street projects that could be targeted to the West 30's. Walking paths that would connect active community centers to the existing Pine View Sidewalk Project and the St. Tammany Parish Trace.
- Another Project is the Ozone Sewer Project. Updating and rehabbing the sewer system in the
 Ozone neighborhood, and the Ozone neighborhood would be an eligible census tract, so that
 should also be another project, especially if you're looking at trying to improve housing.
- Staying with quality of life factors and water, looking at updating the lift stations at 26th Avenue, which is in the West 30's, and the lift station at East 30th Avenue, which is in the Ozone Neighborhood. This project would address water quality issues dealing with discharge.
- Now, I can stop, I won't read all of the ones in the West 30's, but what I would say though, I
 noticed a category that deals with quality infrastructure improvements and this goes back to
 looking at building a senior lifestyle center somewhere in Covington to maybe help out and
 replace Hayden Hall Center that we currently have now.
- And I notice we also talk about Transportation type needs and the need to provide transportation so that people can have access and opportunities for employment. I don't know if we've looked at maybe trying to have some type of fixed based transportation route. In particularly that can take people, give people access, to some of the major corridors where we have employment.
- And basically I am going to just tie all of the West 30's stuff under maybe one of your strategies that you have in section G dealing with neighborhood revitalization strategies. I noticed that the last 5 year plan, you had the Alton neighborhood, neighborhoods in Lacombe and you did list Polder's Lane area as part of your neighborhood revitalization strategy. So maybe it would be possible to list some of these recommendations and implementations strategies from the West 30's plan in the Neighborhood Revitalization section.
- The rest of the stuff I'll just hand in to you, I won't read it. Maps and all.

Speaker: Debbie Schimmeck

My name is Debbie Schimmeck, I am the director of Community Christian Concern and I am
here, not really as a spokesperson but just to express the needs in our community for housing.
Weather its emergency shelter, transitional shelter, SHP shelter, or just for homeless services in
general. So I brought some stats and some volunteers and I had a client who wanted to come

but who may come to another meeting, maybe in Slidell, but I can only speak to what I know. At CCC we serve right below 3,000 people a year and last year we served about 200 people that were homeless. That is both families and individuals. Well, I'm looking at the stats, we use the HMAS system which is really fabulous for us to tack data, and so when I looked at it for this year, the quarter, which is from January to April, we already hit that quota, well not quota, we hit the same percentage already in those four months. So we were at eight percent of the people we see are homeless and we already hit that in the first quarter. So that tells me that we are seeing a great increase in our community. I'm not sure if other providers are seeing that, but we hear that continuously in our communities that folks who are services providers, ministries, parish people, are all struggling with just a lack of resources, a lack of services, a lack of housing. We run a men's program, it's a transitional housing program that we are blessed to have in our community call the Miramon Center. It is a CCC program. We can house 12 men there and currently we don't have any funding for it. Which we are going to try to apply for a grant the next time it comes out, the RFP, when it comes out. But I don't have any operating expenses or any salaries or anything like that. So I guess we are just proposing to consider in the Consolidated Plan funding for housing, for homeless folks. When I looked at my stats I thought it was really interesting, most of the folks who come are working folks, families, and I know you all see it to, I may be speaking to people who already know, but in January I had counselors here who saw 10 or 15 a day. So we're seeing families. We're seeing mom or dad, or one relative, one parent come in with teens in the truck with nowhere to go and out of school and its very heartbreaking when you work diligently to try to assist and there isn't a lot of resources to refer to. SO we have a food pantry at CCC. We provide as much food as we possibly can; we're very blessed to have that. And we saw about a 20% increase last year. A lot of that was more for homeless families. Of course people ask, well how can homeless families have food? Well we have bags of food for transient food, pop tops, food bank people know what I'm talking about, but not cold items or perishable items, so we'll provide that. And we get a lot of people on foot that come in, from jail, police station transients. We try to resource with other ministries and other providers. And we are grateful to have Community Action Agencies that we can network with. But as a social service provider and ministry we are just asking for that to be a consideration, to look at see what is available to our community. We have two wonderful housing alliances. One is the Northlake Homeless Coalition, and one is the St. Tammany Housing and Homeless Alliance. And I am really grateful that we can be a part of that, proud to be a part of that; to see what we can bring to the table, to really advocate and be the voice for homeless folks and there are a lot of great people at the table trying to provide services and data and the goal is to abolish homelessness by 2020. And so are hoping that we can get to that goal and we're going to work ourselves out of a job. So I don't know if any staff has anything, I have counselors here:

Speaker: Peter Johnson

• I am Peter Johnson, I volunteer at the Community Christian Concern in Slidell, and to echo what Debbie is sharing with you we are seeing very different phenomenon's now with homelessness. For instance, we have a situation in particular in St. Tammany where we have homeless youth, it will be a Father with children, teenage children or middle school children and we don't have a facility where we can house them. We may have a transition or homeless shelter for women but she can't take her male son to if when he gets to a certain age. Or we may have a family unit where we can only house the men in one section of town and the women have to go to the other section of town so we face situation where we are having to split up the family unit. And again, we really have no, no facilities what so ever to address the phenomenon of the single

male father having to take care of his kids. This is a growing phenomenon, especially in St. Tammany Parish. We are here at the foot of the I-12 corridor, we have I-59, I-10, all of those intersecting in Slidell so we do, it's an unpleasant thing to discuss, but there is a growing homeless population in Slidell and Eastern St. Tammany in general and it's filling up St. Tammany as well because of the I-12 corridor because of where we are. We are outside of a large metropolitan area in the south, people are going to come here for the weather, thanks to the economy people are migrating here and our numbers show that it's becoming a bigger issue and so we are here now to really map our resources and hoping to find different ways to address the issue. Thanks.

Speaker: Debbie Schimmeck

• I just want to end that with saying that we saw 643 people in three/four months and 51 were homeless. So it's 51 individual families or individuals. It could be the face of a veteran; it could be a young person down the street coming from jail. It could be a person with mental health needs or disabilities, the face could be anyone. Yesterday we have a presentation at a rotary club and I found it quite phenomenal that one of the people stood up and said, "people something will think for a homeless person or individual family is a certain look of a certain someone" and this is a person who is well known in the community and well liked, and they said, "but when I was 19 I was homeless. I lived out of my car. And when I went to the CCC they were able to help me with deposit for my first apparent and gave me two weeks of food". That just meant so much and so that testimony could be any of us. We could be one paycheck shy from becoming homeless; hopefully not, God has blessed us in many ways, but we are seeing folks who are not your typical homeless. I know you probably are too, but I wanted to end with that. Thank you.

Speaker: Francis Dunn

- Wouldn't my scatter site housing take care of this problem in West St. Tammany?
- Can you acquire property with CDBG funds?
- So we would find a partner to build them?
- When I see the Groves I know anything is possible!

Speaker: Nahketah Bagby

Does the Parish receive HOME funds?

Speaker: Will Reshelly?

I just wanted to understand what the roll is in terms of Economic Development. I know we have some stuff for education and things like that but what are we looking at for the new year in terms of; we have a lot of stuff we do on an economic level in terms of large site development, but what is on there for some of these small businesses, mom and pop type business, that are in these areas which we are trying to develop?

Speaker: Jan Robert

Well I just wanted to say, and I think Debbie with the CCC helped to paint the picture somewhat
of homelessness and I really appreciate the fact that you all came to tell us more about that, but
I think that there is an even bigger picture with housing that Francis addressed and that Debbie
is addressing with homelessness, and it starts there and you guys are taking care of some of the
men who require transitional housing, but just to make a point, there is the Miramon Center

and Caring Center in Slidell, on the Easter side of the parish and Safe Harbor who provides housing for women who are subjected to domestic violence, but other than that, and I think the caring center is expanding, they're going to have about 15 beds, I can't remember if they're going from 12 to 15 beds or 15 to 20, whatever it is, and they house on an emergency basis women with younger children I think under 12, I am probably not getting these numbers right but I am trying to paint the picture. The point is, in West St. Tammany, and you can hear what the demand is on the East side, and maybe some of the folks here that are at the food bank and with other agencies see some of these homeless people coming through, particularly families, there is a tremendous demand. And so, again, starting at the very bottom spectrum of housing and looking at what the need is, there are a lot of different activities that are taking place throughout faith-based organizations to support some of the work of the parish and all of these agencies. But it's still not enough to really address the issues. So the housing issues, starting with homelessness and we probably have about 45 beds max or units that could be considered emergency shelter with, Trumpet of Truth, excuse me I forgot to bring them up also on the East side of the parish, and there is absolutely nothing on the West side of the parish. And we know that a lot of these folks are dealing with transportation issues too, so that's another story. You know CDBG, can't solve all of these problems, but certainly working in partnership with a lot of these agencies that are represented here, we can start to make a dent. But you know on the whole spectrum, as Francis said, it's really big picture that we as a community need to look at and that is after you've put these folks in emergency shelter they need to take the next step and you need to keep moving them up. Of course we that's what we want for everybody. So then the transitional piece, that the Miramon Center does so well, we need to make these people more independent, be it renal, affordable rental or work force housing. So some of the activities that CDBG has done in the past, I really commend the Parish for making the decisions to give some property to habitat or other agencies like that that can assist in helping build facilities or homes like that. The Groves, the parish played a really big role in using some of the CDBG money for infrastructure to make that project possible. And that's really, really exciting and we might see something like that in the future on the East side of the parish. And so it is all of these things together, I think that when we look at housing as a community and as a parish we need to see and hopefully that parish will make that decision and hear your voices today as you talk about housing and homeless and emergency shelters and you talk about rentals and housing for the workforce and we can all put our heads together and our resources together to really address this. So if there is any point that is made to the parish as a citizen of St. Tammany, and being involved with many of you in the room, I would just like to make sure that the message is clear, that housing, to me, is just the foundation of changing a community and creating a healthy livable community and I am hoping that we can put some attention on that in this consolidated plan and direct some of our efforts to that area. And thanks to everyone who came today to talk about that, I appreciate it.

Question proposed to the audience: In terms of CDBG Public Service funds, would it be better to award one or two larger grants to make it more competitive or three or four smaller grants to maximize funds for our local agencies?

Answer: Liz Taurman

I would say three or four smaller (echoed by Debbie Schimmeck) grants. Because then those of
us in that sector have a chance to take that money and say we have a basis for it and then can
shop for other grants and other funding sources.

Answer: Francis Dunn

I will say three or four smaller grants, but for those who have larger plans how about we have ______. Every year you would add to the plan that I would like to do so that it's not that you give me one small thing and that's it. So that you can serve both portions of the spectrum, those who have smaller projects and those who have larger projects.

Answer: Debbie Schimmeck

I would think maybe, though I don't have a lot of experience with it, having small, it depends upon how many request that you have, if you have many requests, so then you spread it out among different agencies depending on what the needs are. I know that as an agency that even that one piece could help to piece together with another grant or other types of funding. So I think for me it would depend on what comes in and if the West side is so lacking housing and they have a need, it can be spread around and shared where the need is.

Is it helpful if we come together with some stats or information from HUD to give to you?

• This is not a comment on needs; this is a comment about a section in the last plan about barriers to affordable housing. One section in there you talk about zoning, and how zoning is a barrier to provide affordable housing. And you also list in there as one of your activities that you would like to educate the public, educate planning commission members or city council members, but one activity that maybe you could do is to encourage those who support and are working toward affordable housing to also come out to public hearing where you are dealing with rezoning. For single family lots and multi-family because at zoning meetings you hear from all the people who oppose but there is no one there on the other side saying we need this. So that is a comment that I noted in reading through the overall (last consolidated) plan.

I am Annie Rushing I had had some work done in my house last year by Mr. Payne and Jessica.
 And I thank God for them because I wouldn't have had it done if it weren't for them. And I thank
 God for it.

Speaker: Barbara, Parish Resident

• My name is Barbara and I just had some work done about two weeks ago by Payne and Jessica and the other guys were Mr. Jerry, Greg and Patrick and Justin. And I was on the waiting list for a while for it, for about two years, but I kept in contact with Jessica like every month, and jut asked questions about the program and how long it was going to take. It took a while, but patients is a virtue so I waited, waited, waited. Then when that phone call came through and stated that they were going to going to help me at that time I was grateful for that. I had two rooms in my home that were damaged and they came in and just did a wonderful job. I have a daughter who lives out of state, or out of town, and the room that she was supposed to be in wasn't fix or whatever, so they came in and did the whole thing, the bathroom, the bedroom, everything. And it was just a blessing to me. Now she can come home and be safe in her own bedroom. So I just want to thank them from the bottom of my heart. And thank y'all for all the work that was done. I really appreciate it.

Yes I also want to, very much appreciate Mr. Payne and his workers, Greg and Justin. My father had passed and it was a blessing for my mother to see that kind of help. Because without them it might not have happened, and if it happened it wouldn't have been the same outcome. The outcome was beautiful workmanship and I mean that from the bottom of my heart. And I hope that whatever they need to continue their work will be given them. Thank you.

Speaker: Lara Batchelder

I would just like to talk about some needs that I see in St. Tammany Parish. One of the things that I've seen and I did work for Habitat so I did get exposed to some of our more needy areas in the parish, and well this may be a Habitat thing, but I'm sure that everyone is aware that our affordable housing is a big need here. It's unfortunate, even my own son who is 25 now he lives at home because he makes \$9.00 an hour. He's a very good worker, works very hard in a restaurant and he can't afford to live in this parish. Everywhere that he has looked the rent is so

above his means. So I basically have an adult in my house that I would really like to move out. And we see this time and time again with Habitat. We have people come and say that we're paying rent that is way above our means, we don't know how we're doing it, it must be an act of God that we can afford what we have. We see a lot of two families living in one household, a lot of rent burdened people. We have a very wealthy parish, a wonderful parish here but somehow we're missing out on being able to let our people find housing.

- Also, I do get exposed to neighborhoods that aren't visited as much as other neighborhoods and one of the things I've noted, that people who have their own septic systems that often those aren't _____ and they can become financial burdensome. I have recently had do my septic system and it's an expense. And I know; I've seen negligence in areas. And I believe it's a part of our code enforcement in the parish to check septic's but frankly, we don't have enough code enforcers, and then can we really help a family? Because now it's, if you get your electricity turned off there is some kind of mechanism where the parish comes in and does an inspection. But that becomes a whole financial burden as well. So I think it's real important for our health as a community to stay up on our home septic systems, we have a lot in this parish and because our water table is so high and the open ditch system, the heat produces as lot of bacteria both good and bad and it's something we need to pay attention to.
- I also wanted to mention, in our community we do have these wonderful REC facilities for kids who can play ball and stuff. And that's so much of an education thing, for children to learn to play with others and follow directions and all that stuff. It so important. But what about the real little guys. The guys who are three and four who need a playground to play on. They can't necessarily go play t-ball yet, if they're three or four, but they need recreational facilities. Particularly, the community in west Abita Springs has instigated, the community itself has started and is developing a park for their children of all ages. It's real exciting. We're a part of it, we're not the main thing, but we're participating with the community and it is just exciting to watch this community to come together and thinking about their children and having a park to play in. I think that is such an important part of development and education is to be able to play. That's how I learned. I learned everything I know on the playground before kindergarten. You learned how to get along with other, how to share, to not throw sand and all of those important lessons. So it would be a wonderful attribute to our community if we could entertain the possibility of helping this community develop this park for their children, and I can share more details later.
- The only thing that I wanted to say, we do have a transportation system in the parish, thank goodness, and I've called them on behalf of clients. Often time they're full. That would be awesome things if we could get larger with our transportation
- And also with our mental health, as you know we are very limited as a parish. They can only serve so many and it's almost become a community game. As a professional in the community if you call the mental health facility you have to tell them you're suicidal. And if by some magic you get them in the door it's only temporary and there is a much larger need then what we're doing. Thank y'all for listening.

Speaker: Candice Mancuso

I'm Candice Mancuso, I am the grants manager for Habitat and I would like to expand on the park a little bit. We have 156 children under the age of 18 just living in the Habitat homes in the Abita Nursery/West Abita subdivisions. So the park has been community initiated, it's on Carnation Street. It's been a huge collaboration between the School Board, who owns the land, the Town of Abita, in Abita city limits, but Former Mayor signed it into an agreement with the school board which includes the insurance, the Town of Abita is providing the liability insurance,

the Abita Friends of the Park, that's the community group, architect David Spacuza did plans for the park for free, the residents are very involved, they're doing fish fry's and whatever they can do to help raise money, Philip's Abita Lumber cleared the land for nothing, and then like Lara mention, we are matching dollar for dollar, Habitat is, with their dinners to help raise funds for the park. It's got a lot of community support. And like I said, 156 kids only in Habitat homes and it's a much broader neighborhood than that so a lot of children will benefit from it.

Question: Jeff St. Romain

Does the park being in Abita Springs; do CDBG dollars cover projects in Abita?

Speaker: Jeff St. Romain

• I'll speak of that census block, that triangle between highway 36 and 21, we build a lot of homes in West Abita/Abita Nursery, and the issues there and some issues with the park are the narrow streets, the deep ditches that don't drain properly, the septic systems that drain into the ditches and blighted homes. We own property, as Candi said we've built over 90 homes in that area, and we have property next to some monstrosities that are just havens for someone to set a fire or worse. But it's a very neglected part of the parish, and I know in terms of both code enforcement as well as the sheriff's department, we're trying to those agencies more involved, because it is a low income neighborhood and unfortunately low income neighborhoods get thrown on the bottom of everybody's list in those areas in those areas of blighted homes, drainage, and streets.

Speaker: Vera Clay

• I am going to speak as a person who is formally affiliated with an affordable housing group in St. Tammany. One of things that has happened in the last year was that there was subsidies that had come to low, very low and some subsidies for moderate income families, to use to purchase homes to; make homes more affordable for purchasing. Right now, all of those subsidies have dried up, they're pretty much gone. So you have people beyond the limits of Habitat, I'd say 60% of the area median income through 20% of the area median income who were being able to get into homes because they were able to draw down these subsidies. Sometimes up to \$3000 to buy down the cost of their home and/or to pay for closing costs. That's gone now. So we have a block of families who can't really access Habitat and who desperately need housing, they need workforce housing in our parish and it's going to be tougher for them to do that.

Speaker: Payne Diez

• I am Payne Diez and I am the manager of the Repairs on Wheels program with Volunteers of America. I want to thank all of the people who came out today to speak on our behalf. We've been in St. Tammany Parish now for four years and when the program first began we had 15/20 callers that would get on the program and we would do the work within the year. And there were other programs available as well, but those programs have dried up. We had a SNAP program, last year we did 12 homes under the SNAP program and with the HPG program which is the Home Preservation Grant program we did 12 homes under that program last year. Totally last year, on all of the programs we did 59 homes. This year we'll probably do 45 homes and then the funds will dry up. Now I know that St. Tammany is going to continue us as best they can but remember that I said there were a few people on the waiting list at first. Now we have over a 100 people waiting to get on the program waiting list. The list we're working from, we took 25 initial callers and put them on the program list for work to be done. Now we have over 100 waiting to get on that list. We will complete that work and will have 100 more in need. So please

bare that in mind, and bare that in mind when we're thinking about utilizing these funds. And thanks again for everyone who came out to speak on our behalf; it was a pleasure to work for you all.

Speaker: Vera Clay

• I would like to say one more thing in regards to the homeless population. In my work, we receive calls, and I am thinking of one situation in particular, of a family, a mom with two children who were living in a tent in Fontainebleau State Park because they had nowhere else to go. I think the issue of homelessness is an important issue and something that needs to be supported in any way that it can. And that's not an isolated instance that's something that happens more often than we think.

Speaker: Erin Matheny

I would like to piggy-back on that, I work with the Northlake Homeless Coalition which is the Continuum of Care for the 5 Florida Parishes and also serving the St. Tammany community. And my roll and my job is to work is South Eastern and am responsible for helping organizations with collecting, capturing and reporting data on the number of people they are serving in particular the homeless. Prior to coming to this meeting I looked at some of the data from the 5 agencies that serve in St. Tammany as emergency shelters, transitional housing and permanent supportive housing, with the majority of the units are permanent support housing. But of the folks that were served last year, well I should say that there are 481 in St. Tammany served by those programs. In addition to that there are service providers who don't provide housing but other supportive services and all together there were about 300 people who were attempting to accesses services amongst these providers who were living in situations that are considered not in intended for human habitations, so living in their cars or as she mentioned sleeping in tents and so forth. It has not been a priority to an extent to pull together support from government, non-profits and faith-based organizations and it is a very very difficult process. And it is certainly not from a lack of trying but it is in communities nationally CDBG funding, those who utilize CDBG funding for building a network of homeless services are also those communities who are making the largest strides towards preventing and ending homelessness. And that is one of HUD's priorities. And so a very wise person said recently that St. Tammany is new. That it's a growing parish, and I think she's right. We're at the precipice in St. Tammany where we can really develop those initiatives and put forth funding to help float these organizations to really build up those types of programs that are focusing on preventing and ending homelessness and not just maintain it. So it is evident that it is an issue on the parish, but we need to prop up these organizations who are trying to work independently on those, to build something conducive, and I think St. Tammany parish government can support that with this funding. And again, in other communities where CDBG is used for this they are making large strides. I think in terms of priorities that this should be one.

 I know I spoke another one of these town meeting, but I would just like to say that as a citizen of St. Tammany Parish I would like to see the parish folks and the counsel folks consider housing, shelter, low-income housing. Specifically shelter for families that don't have shelter and have a lack of resources.

Speaker: Liz Teague

Hi my name is Liz Teague and I'm with the St. Tammany Community Health Center, and we have not received any money in the past, the basic thing that we do provide, and these are people who have Medicaid or no health insurance, we provide health care on a sliding scale. And so if anyone here needs to refer patients we would love to see them at 501 Robert here in Slidell. We've gone from seeing, the first year we were opened in 2009 we saw 4,000 patients that year. Last year we saw 13,000. The numbers are growing of people who have no insurance, sometimes the children have Medicaid but the parents don't have any coverage and they are at jobs where they cannot take off when they get ill. And so what we do is, we take those folks in, we get them qualified on a sliding scale, we see them. Now we have pediatricians, adult doctors, we have a psychologist and a psychiatrist, and we have done this on one end of the parish, we also provided public health at that site. And I have noticed with some of the things that have come out health as not been there. Direct healthcare to people; we're not talking about programs, teaching and all that, we're talking direct help to someone who needs that assistance. That is what we do. And will be handing in something to ask this year, specifically we're looking at opening another site in Covington next to the west 30's. And specifically what I would ask this group for is a grant for a nurse practioner who could see patients specifically at that site. And that's what we would be more than likely asking for. And again, I've lived in this parish almost 40 years now and the need has grown and grown and grown. But this is a catch for it.

Speaker: Linda Anderson

My name is Linda Anderson, I am with DEAR, and that's Drug Education and Rehab. And this is a
facility that we will be opening in Lacombe to help in the Lacombe area, the rural area. And this

is for diabetes, young people who are now diagnosed with type I and II diabetes, to educate them and their families about nutrition and what they can do for diabetes. I am also in the health care field, but we will also be working on opening a facility for homeless people. I also work with the court system when people are under sanction for education to get off drugs. I work with drug education and we will be getting a nurse practioner, psychiatrist and also a social worker in the Lacombe area. This is a need because we have a lot of people who are running around homeless. And it's going to do a little bit more, not only treat the patient but also the family because the family is broken. And it's called the DEAR program and it's in Lacombe, Louisiana.

Speaker: Unknown

• In the past, I noticed that you said last year I think you were talking about, what all was done in Covington with the funds. What about the whole area of St. Tammany? Just like the last people, Lacombe and other suburbs, all of that is outside of city limits. What has been done in the past in those areas?

Speaker: Martha Meadows

• I am Martha Meadows; I am a representative of the Slidell Boys and Girls Club. We have been in the community since 1977. We have charged \$5 a year for membership and two years ago we charged \$25 for member for kids to come to the boys and girls club. We offer character and leadership development classes, health and life skills, sports fitness and recreation and we are even able to offer technology classes to the members. We serve over 500 youth a year and its getting very difficult to continue to charge \$25 a year to attend the Boys and Girls Club. So I just wanted to let you know that, we appreciate you all, this discussion and we would love to have the opportunity to apply.

Speaker: Belinda Brown

- I have a question, receiving the funding, is there specific things that HUD has to have in place in order to get that? Can it be a yay or nay in regards to getting the money?
- Have you had any funds left over from prior years that you've had to send back?

Speaker: Gordon Meadows

I have been a resident of St. Tammany Parish since 1962 and my name is Gordon Meadows. I am concerned about the Parks and Recreation aspect of St. Tammany Parish as it relates to low- to moderate-income people having access. Slidell, I live in unincorporated Slidell in the Bayou Liberty area: however, in the municipality of Slidell there are only two facilities that I know of for public recreation for basketball, which happens to be a passion of mine. That's Fritchie Park and John Slidell Park. The free play hours at those particular parks are from 1:00 pm — 3:00pm, but kids, low-to moderate-income kids are in school. So I really don't get that. I don't understand why there is such a lack, the City of Slidell gives over their public facilities to private organizations: SYBA, SBBS, everyone has their controlled situation from a private stand point, but from a public stand point there is no access for low- to moderate-income people for gymnasiums, except for free play hours from 1:00 - 3:00pm. So there is a huge need in this community for recreation, this has been slighted for years. Like I said I grew up year, I started second grade right down the street, it's a huge concern. My wife runs the local boys and girls club and where they go there isn't a roof on it so when it rains we have to leave. At a couple of public parks they are taking the goals down because they've had some incidents, gun play and that type of thing, so people didn't want those basketball courts in their neighborhood and so it's just a lack of resources. Low- to moderate-income people have no access to baseball facilities unless they join the private facilities.

Well we need a gym. By the Boys and Girls Club, I mean that's the only way that I could see that
the low- to moderate-income people will get access. It's a large majority in this district and they
have no gym. They have no access to play basketball. No public gym that they can get to, that
they can access.

Speaker: Belinda Brown

- When it comes to, how do you kind of like spread, I guess equally allocate the money amongst
 those who have received it and those who have not received it? Is there some type of criteria to
 keep the same people from getting the money over and over again?
- And along with that, in the case let's say with the Boys and Girls Club and some others that
 would probably need this money, what is the criteria to evaluate those individuals on how well
 they're doing?
- And that is my concern because if they're being monitored, then they have to do exactly what they say they're going to do. In the terms of low-income housing, when say for instance, to reduce, I'm sure you've heard of this section 8 program, you're going to reduce and help assist on the house payments. SO with this money, when this money runs out and you don't chose to fund them again, those people are kicked out?

Speaker: Gwen Wade

• I have a comment, I am Gwen Wade and I have been volunteering for 33 years since I've lived in this area. I currently serve with Liz on the advisory board and one of the things many things that we do is to provide service to a lot of the suicide prevention areas. We've been dealing with that for a long time and finally that Parish, other groups, hospitals have joined in that. And so that's something we do and there are many issues involved with people who would like to commit suicide: the person, their families, etc. etc. And the addictive disorders that many of these people have and we assist in that area. Also, we also serve homeless people because we have the sliding scale and all of that. So these are issues that tend to grown, every year the numbers get larger instead of smaller and so we are going to be asking for assistance to help address this.

Speaker: Kevin Roark

I'm Kevin Roark, I am a concerned citizen of St. Tammany and I would like to piggy-back on the idea of homeless shelters for families; because there may be a homeless shelter for women and a shelter for men but there are also in today's economy, there are people who are families who, through no fault of their own, become homeless and need a place where they can go and be together. And I just want to stress the urgency for that.

• Again, Gordon Meadows, this time about drainage. Like I said I live in unincorporated areas, and have lived here, I bought my home in '68. It never flooded until Northshore Square was built, Oak Harbor, Eden Isle. And now we've flooded three times since and we haven't gotten the elevation grant finalized. I have open ditches in front of my street which aren't good drainage not to mention West Nile. There is just no drainage out there. I keep hearing there are things in the works, but I don't know what they are. This is Laurent Road and like I said there isn't a whole lot out there.

Candice -

Please accept this as my comments regarding prioritizing CDBG funds.

Currently in St. Tammany Parish we are seeing a shift from homeless individuals to homeless families. Families come to our door or call our office asking for emergency services. Since our agency does not provide emergency services, we offer to place them on our housing waiting list that can take a year or more before their name will come up for a housing unit. Of course, this does not address their immediate need. We refer homeless families to The Caring Center. However their bed capacity often times is full. The next option is a privately owned shelter in Ponchatoula or going to New Orleans. When school aged children are involved, these options are not feasible. With the lack of shelter options, homeless families often opt to live out of their car if they lack family/friend assistance before moving their children into a different parish school system. For those with family/friend assistance the homeless families often split up as it is often a burden on the host family/friend to have the entire family stay with them in their home. If the stay becomes too long, the homeless family is often asked to leave without another place to reside.

Another area where homelessness exists is in our youth population. We have school aged youth struggling to attend school and keep a roof over their heads. The Parish needs to consider services that can help homeless youth so they have the opportunity to earn their education and move into the work force.

The Parish needs additional emergency homeless services that can help address the issues above.

In the recent HUD grant application submitted by the Northlake Homeless Coalition on behalf of the agency's in the region, a question addressed how the Coalition and the Parish coordinate CDBG funding. HUD is extremely interested and focused on preventing and ending homelessness. HUD is the only Federal agency that has adopted a Federal Strategic Plan. In the Federal Strategic Plan to Prevent and End Homelessness developed by USICH on behalf of HUD expects CDBG, ESG, Neighborhood Stabilization Programs, HUD-VASH and HOPWA funds to be used to impact the goals set forth in the Plan. Having CDBG dollars going toward homeless services and addressing one or more of the goals set-forth in the Federal Strategic Plan would greatly enhance the Parish's Consolidated Plan. Since the Northlake Homeless Coalition's Strategic Plan to Prevent and End Homelessness mirrors the Federal Plan, the Parish's Consolidated Plan would actually be aligned with both Plans.

So as you can see, our Parish has needs that have to be addressed in order for all of its citizens to experience quality of life. It is hoped that the Parish will seriously consider making dollars available to provide homeless services to assist the most vulnerable populations in our parish. Thank you for the opportunity to submit my comments.

Relative to the STP invitation to provide comments on this subject, it would be nice to have similar services (e.g.; "LA 21 Bicycle and Pedestrian Feasibility Study) in Eastern STP and the Military Road Area, as are being implemented in the Western part of STP. We do appreciate finally considering extending the Trace at least to Front Street.

But more important, eastern and southern STP really need better surge and flood protection, regardless of Mississippi's complaints and especially in light of the fortification of New Orleans.

Terry Bordelon Eastern STP

The Covington Food Bank (CFB) has been a cornerstone in the St. Tammany Parish community for 29 years providing food, clothing, dental services, and financial emergency assistance to the less fortunate. Our mission of 'feeding the hungry with dignity and compassion' has expanded from 4-6 families daily to 360 households per week being served by one of our 4 ministries.

We truly appreciate the funding the CDBG has provided to our Dental Clinic. The CDBG grant is allowing financial resources dedicated for food procurement and distribution to remain in support of the feeding ministry rather than support the shortfall we would otherwise experience in the dental clinic. Supplemental financial support is still needed as demands continue to remain high and operation costs are not declining. Although we do have volunteer dentists who give of their time, it is not enough to meet the demands within the community, so per diem daily rates are paid to 2 part time dentists as well as a dental hygienist; a dental assistant and an office manager are employed full time. Couple these salary costs with our lab fees as well as the reduced fees charged to our clinic participants and a 'break even' outcome is not likely. Bear in mind, the CFB Dental Clinic is the only clinic present in St. Tammany Parish which is offering optimal dental care to the working poor, elderly and disabled.

While support of this dental clinic ministry is still required, concern is growing over the need for additional funding of our core ministry of feeding the hungry. In the last seven years, the demand for food and services has risen over 170%. In 2012, we experienced 2303 households on our roles with over 5600 individuals being served. 57% of these households were here in St. Tammany Parish and spanned from the east to the west side of the parish. Over 845,000 pounds of food were distributed in 14,900(+) pickups from our door at 840 N. Columbia in downtown Covington. Additionally, while we are blessed to have the support of so many community volunteers, growth in need has required the CFB to have paid staff to support the expanding operations contributing to the stress being placed on the budget.

Our feeding ministry is supported by the generosity of individuals, groups, organizations, churches, schools and businesses in the form of food donations or drives, volunteerism, monetary donations and community event sponsorships. But unfortunately, this is not enough to support the growing need. In the first quarter of 2013, we experienced a decline of 30,000 pounds in food donations compared to first quarter 2012. Should that continue we will experience a shortfall of 120,000 pounds (\$108,000) of food this year. CFB will need to purchase this amount to meet our expected annual demand of 850,000 pounds. We do not anticipate the need to change as we move closer to 2014. Our hope is that in 2014, the St. Tammany Parish government will continue to support our ministry in the form of a CDBG grant targeted at food procurement and distribution as we search for alternative funding for our dental clinic.



Priorities: Where Do We Start?

Geographic Targeting

A key principle that this plan follows is that, to achieve revitalization success within a study area as geographically expansive as the West 30s, a narrow focus must be applied to very specific areas. In other words, investing random efforts and fonding in an uncoordinated manner throughout the study area will yield little in the way of long-term positive results. Instead, targeting a variety of physical, social and economic initiatives to very defined locations will bring the greatest long-term henefits. Once key locations become stabilized and revitalized, nevitalization will spread geographically from those points with less need for external public-sector help.

Three-Pronged Geographic Strategy

In deciding where to begin revitalization efforts, three principles will be simultaneously applied:

Spread Improvements from Stable Edges

One proven strategy is to build upon the healthy edges of a revitalization area. The most definitive healthy edge for the West 20s is the north-side of Downtown at mughly Jefferson Street. Areas lying south of Jefferson tend to be relatively strong economically and physically, while constitutions markedly drop of to the nonth. Investors will perceive less tisk investing in such areas.

Pocus on High Visibility Corridors

Another strategy that has often proven successful is to focus on the most visible confidors because of their impact upon the image of an area in the minds of focal residents and visitors, as well as fheir high traffic levels that give them strong market support. 


