**RESOLUTION NO. 2023 -57**

**BOARD OF COUNTY COMMISSIONERS  
OF THE  
COUNTY OF SUMMIT

**REVISING THE BOUNDARIES OF THE SUMMIT COUNTY, COLORADO  
COMMISSIONER DISTRICTS**

**WHEREAS**, pursuant to C.R.S. § 30-10-306(1), each county shall be divided into three compact districts, which districts shall be as nearly equal in population as possible, numbered consecutively and not subject to alteration more than once every two years; and

**WHEREAS**, pursuant to C.R.S. § 30-10-306(4), after each federal census of the United States, each county’s commissioner districts shall be revised or altered to ensure that such districts shall be as nearly equal in population as possible based on such census; and

**WHEREAS**, a federal census of the United States was conducted in 2020; and

**WHEREAS**, based upon the data gathered from the 2020 federal census regarding Summit County, Colorado, the Summit County Geographic Information System (“GIS”) Department, in consultation with the Summit County Attorney’s Office, produced maps revising the boundaries of the commissioner districts which satisfied the above referenced requirements of C.R.S. § 30-10-306; and

**WHEREAS**, the Board considered the proposed map revisions at a public hearing on May 23, 2023, and continued such public hearing until June 27, 2023, for additional public comment and consideration of the revisions; and

**WHEREAS**, the Board believes the attached maps of revised commissioner districts satisfies all of the above referenced requirements of C.R.S. § 30-10-306.

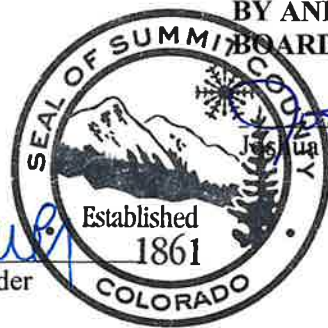
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY

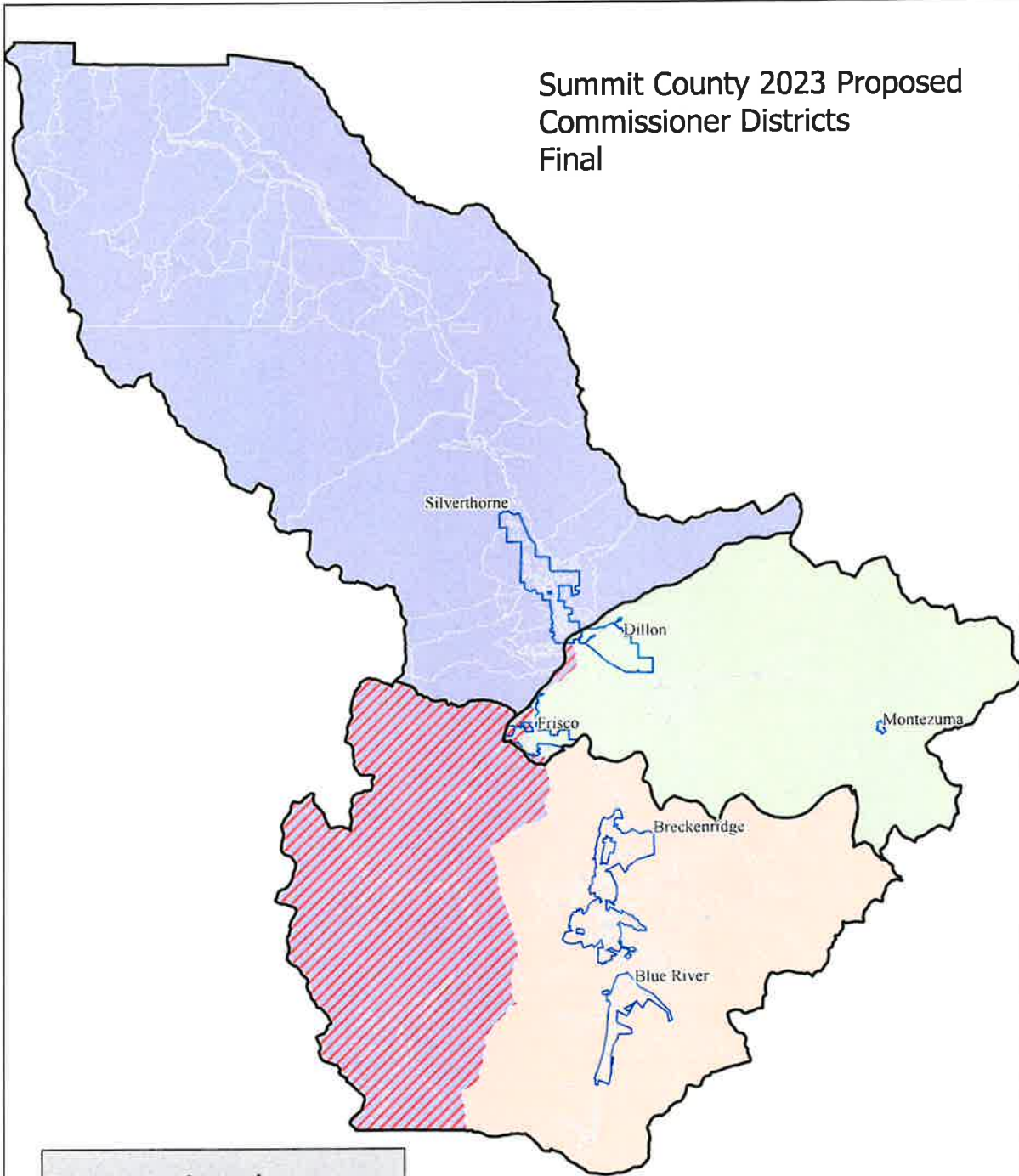

## Summit County 2023 Proposed Commissioner Districts Final

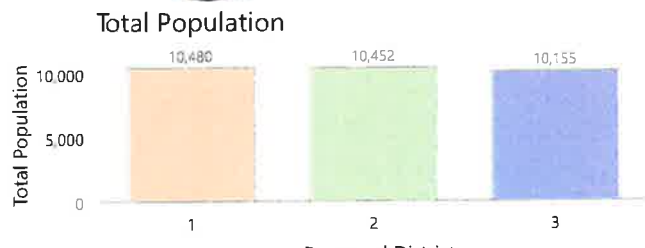


**Legend**

**Commissioner District (by Block Group)**

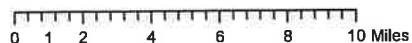

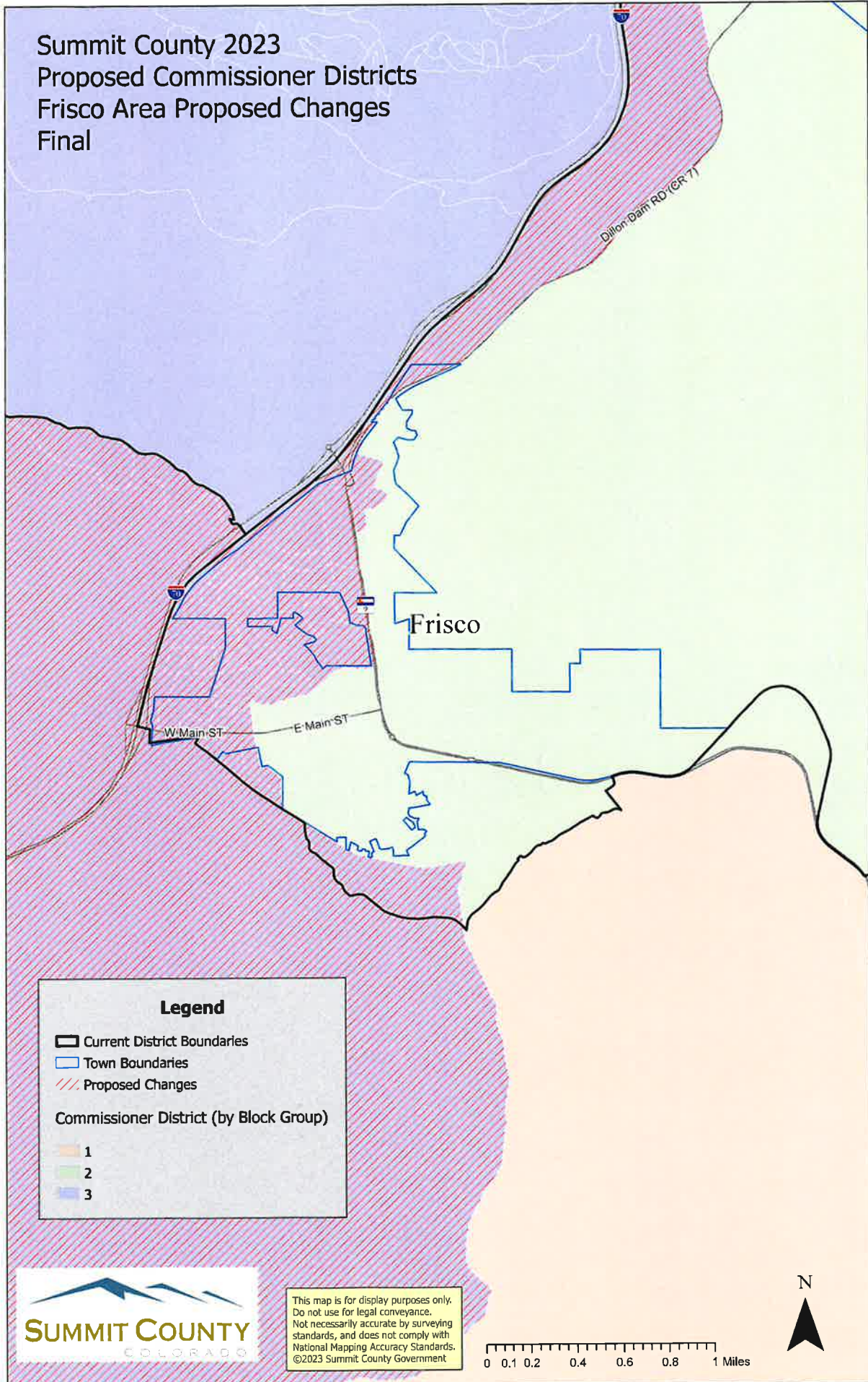
