A RESOLUTION CONCERNING THE APPOINTMENT TO VARIOUS BOARDS, COMMITTEES, AND COMMISSIONS, AND OFFICIAL POSTING LOCATION FOR MEETING NOTICES.

WHEREAS, the Board of County Commissioners of the County of Summit, State of Colorado (hereinafter referred to as “the Board”), desires to make certain administrative appointments and designations for the terms specified herein; and

WHEREAS, the following appointments and designations do not constitute contractual obligations of the Board, and the Board is not legally bound for the respective terms of appointment or designation as specified herein below; and

WHEREAS, the Board, having the authority, in its sole discretion, may change, add, or abolish such appointments and designations and to fill vacancies therefore as it sees fit.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF SUMMIT, STATE OF COLORADO THAT THE FOLLOWING APPOINTMENTS ARE HERBY MADE:

1. Andy Atencio shall be appointed as the successor to Joanne Sprouse as a Summit County Representative to the Silverthorne Childcare Authority for the term as set forth in the Agreement or until such time as he is reappointed or his successor has been appointed.
 - a. Elisabeth Lawrence and David Reynolds shall remain as prior appointed Summit County Representatives to the Silverthorne Childcare Authority for the term as set forth in the Agreement or until such time as either may be reappointed or a successor has been appointed.
2. Andy Atencio a shall be appointed as the successor to Brent Spahn as a Summit County Representative to the Medical Office Building Owner’s Association for the term as set forth in the Agreement or until such time as he is reappointed or his successor has been appointed.
 - a. David Reynolds shall remain as prior appointed Summit County Representative to the Medical Office Building Owner’s Association for the term as set forth in the Agreement or until such time as either may be reappointed or a successor has been appointed.
3. Jason Dietz is appointed as the Summit County Representative to the Huron Landing Authority and Brandon Howes is appointed as the Summit County Alternate Representative for the term set forth in the Agreement or until such time as they are reappointed or their successor has been appointed.

4. The Summit County Board of Commissioners, realizing that other appointments to various boards, committees, and commissions are pending, shall make additional appointments from time to time throughout the year.
5. The designated posting location for all official meeting notices is located in the south foyer on the main level of the Summit County Courthouse, 208 East Lincoln Avenue, Breckenridge, Colorado or on the glass doors of the south foyer during Courthouse closures.
