**RESOLUTION APPOINTING NEW MEMBERS TO THE TRANSIT ADVISORY BOARD**

**WHEREAS**, pursuant to § 30-11-101(1) (f), C.R.S., and other applicable authority, Summit County is authorized to develop, operate and maintain mass transportation systems; and

**WHEREAS**, pursuant to Summit County Resolution No. 20-61 adopted on October 13, 2020, the Board of County Commissioners of the County of Summit, State of Colorado, is empowered to appoint individuals to serve as members on the Transit Advisory Board ("Stage Board"); and

**WHEREAS**, the Board of County Commissioners expanded the Stage Board membership from twelve (12) members to fourteen (14) members for the purpose of granting the Town of Blue River as well as each planning district membership and designated seats on the Stage Board; and

**WHEREAS**, the Board of County Commissioners finds it necessary and in the best interests of the health, safety and welfare of the residents of and visitors to Summit County, Colorado to appoint one (1) new member to the Stage Board as set forth and attached hereto as Exhibit "A" (Summit Stage Board Members Revised 12/13/2023); and

**WHEREAS**, the appointment does not constitute a contractual obligation of the County of Summit nor of the Board of County Commissioners, and the County and the Board are not legally bound for the term of appointment or designation as specified herein below; and

**WHEREAS**, all prior resolutions inconsistent with this resolution are hereby repealed to the extent of any such inconsistency.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF SUMMIT, STATE OF COLORADO THAT:**

1. Candice De is hereby appointed as the Tenmile Planning Basin Representative, for a two-year term commencing on January 1, 2024, during the regularly-scheduled Transit Advisory Board meeting.
