	<p>I have read, understand, and accept the provisions of <a href="#">the STR Regulations for Summit County, specifically Summit County Ordinance No. 20-C and Section 3821 of the Land Use and Development Code</a>, including the penalties for non-compliance contained therein.</p>
	<p>There shall be a responsible agent available 24 hours per day, 7 days per week to respond to potential issues and violations. The responsible agent must respond to complaints within an hour of notification of such complaint, failure to do so may be deemed a violation. I hereby authorize the designated person or company identified in my application to assume responsibility as the responsible agent.</p>
	<p>By checking this box, Owner does hereby agree to accept service by mail of any violation notice issued pursuant to Summit County Ordinance 20-C, as such Ordinance may be amended from time to time.</p>
	<p>By renting my property for less than 30 consecutive days at a time, it is my responsibility to have or obtain a valid sales tax license account in unincorporated Summit County and to ensure that all applicable sales and lodging taxes are collected and remitted, either by me or on my behalf.</p>
	<p>By renting out my property I am subject to the reporting requirements for my rental furnishings/equipment and payment of Personal Property Tax. I will fill out the applicable forms with the <a href="#">County Assessor's Office</a>.</p>
	<p>It is my responsibility to ensure all renters and guests are aware of wildfire safety issues and any fire bans or restrictions which may be in place, and I understand that any permanent outdoor fire pit shall be permitted with the applicable fire department, and the use of portable outdoor fireplaces is prohibited. Please visit <a href="#">Summit Fire and EMS</a> website for more information and to apply for the permit.</p>
	<p>I have read, understand, and agree to comply with the Health &amp; Safety Standards and Site Plan Operations standards in <a href="#">Section 7 of the STR Ordinance</a>, including Summit County's Exterior Lighting Regulations which require all STRs to have dark sky compliant fixtures.
