What are FTS?

Fentanyl Test Strips (FTS) are small strips of paper that can detect the presence of fentanyl in various substances. FTS are a harm reduction strategy intended to reduce the risk of overdose and provide important information about the illicit drug supply.



LIMITATIONS

- •FTS do not measure quantity or potency of fentanyl present in a substance (FTS cannot determine whether a substance contains a lethal amount of fentanyl or not).
- •Other drugs such as diphenhydramine (Benadryl) can result in false positives.
- •A negative result does not mean that the drug is "safe" to use.
- •Need to test before every use, even with same batch

AND OTHER HARM REDUCTION STRATEGIES

PREPARING A SUBSTANCE TO TEST

PILLS/POWDERS

Put a small chip of the pill or a very small pinch of powder into an unused cooker, crush it and add ¼ inch of clean water.

INJECTABLES

Prepare shot as normal in an unused cooker, draw up into a clean syringe.

Add ¼ inch of clean water to the residue remaining in the cooker.

METH/MDMA

Put a small amount of residue in 4 cup of water. Sample MUST be heavily diluted for most accurate results!

TESTING YOUR SAMPLE

- Hold the blue end of the strip and dip the other end into the residue/water mixture for 15 seconds.
- Remove the strip after 15 seconds and lay it on a clean, flat surface.
- Wait one minute for final results before using:



One red line: fentanyl detected (positive test result)

Two red lines: no fentanyl detected (negative test result)

If the test does not show any lines, the test strip is not valid.

STRATEGIES FOR SAFER USE

- Take turns. Ensure that there is a designated non-user who is ready to administer naloxone and call 911
- Start slow, keep your dose low (especially after a hiatus)
- Use test kits
- Take care of your body between doses- (water, nutrition, sleep)
- Know the signs of overdose
- ALWAYS CARRY NALOXONE and let others know you have it
