### RESOLUTION ADOPTING ENO-HAW REGIONAL HAZARD MITIGATION PLAN

WHEREAS, the citizens and property within City of Burlington are subject to the effects of natural hazards that pose threats to lives and cause damage to property, and with the knowledge and experience that certain areas of the county are particularly vulnerable to drought, extreme heat, hailstorm, hurricane and tropical storm, lightning, thunderstorm wind/high wind, tornado, winter storm and freeze, flood, hazardous material incident, and wildfire; and

WHEREAS, the City of Burlington desires to seek ways to mitigate the impact of identified hazard risks; and

WHEREAS, the Legislature of the State of North Carolina has in Part 6, Article 21 of Chapter 143; Parts 3, 5, and 8 of Article 19 of Chapter 160A; and Article 8 of Chapter 160A of the North Carolina General Statutes, delegated to local governmental units the responsibility to adopt regulations designed to promote the public health, safety, and general welfare of its citizenry; and

WHEREAS, the Legislature of the State of North Carolina has enacted General Statute Section 166A-19.41 (State emergency assistance funds) which provides that for a state of emergency declared pursuant to G.S. 166A-19.20(a) after the deadline established by the Federal Emergency Management Agency pursuant to the Disaster Mitigation Act of 2002, P.L. 106-390, the eligible entity shall have a hazard mitigation plan approved pursuant to the Stafford Act; and.

WHEREAS, Section 322 of the Federal Disaster Mitigation Act of 2000 states that local governments must develop an All-Hazards Mitigation Plan in order to be eligible to receive future Hazard Mitigation Grant Program Funds and other disaster-related assistance funding and that said Plan must be updated and adopted within a five year cycle; and

WHEREAS, the City of Burlington has performed a comprehensive review and evaluation of each section of the previously approved Hazard Mitigation Plan and has updated the said plan as required under regulations at 44 CFR Part 201 and according to guidance issued by the Federal Emergency Management Agency and the North Carolina Division of Emergency Management.

WHEREAS, it is the intent of the City Council of City of Burlington to fulfill this obligation in order that the City of Burlington will be eligible for federal and state assistance in the event that a state of disaster is declared for a hazard event affecting the City;

NOW, THEREFORE, be it resolved that the City Council of City of Burlington hereby:

- Adopts the Eno-Haw Regional Hazard Mitigation Plan.
- Vests City of Burlington with the responsibility, authority, and the means to:
  - (a) Inform all concerned parties of this action.

Appoints City of Burlington to assure that the Hazard Mitigation Plan is reviewed annually and every five years as specified in the Plan to assure that the Plan is in compliance with all State and Federal regulations and that any needed revisions or amendments to the Plan are developed and presented to the City of Burlington City Council for consideration.
- Agrees to take such other official action as may be reasonably necessary to carry out the objectives
  of the Hazard Mitigation Plan.

WHEREAS, Town staff along with representatives from partnering jurisdictions in conjunction with contract services have performed a comprehensive review and evaluation of the Eno-Haw Regional Hazard Mitigation Plan and have updated the plan as required under regulations at 44 CFR Part 201 and according to guidance issued by the North Carolina Division of Emergency Management; and

WHEREAS, Person County through its desinated agents, officials and employees has pursuant to state and federal guidelines performed a comprehensive review and examination of potential risks, exposures and hazards and actions necessary and/or desirable to mitigate the effects of such risks, exposures and hazards and has done so in concert and cooperation with the other governmental units in the Eno-Haw region.

### RESOLUTION OF ADOPTION City of Roxboro Hazard Mitigation Plan

WHEREAS, the citizens and property within the City of Roxboro are subject to the effects of natural hazards and man-made hazard events that pose threats to lives and cause damages to property, and with the knowledge and experience that certain areas, i.e., flood hazard areas, are particularly susceptible to flood hazard events; and

WHEREAS, the City desires to seek ways to mitigate situations that may aggravate such circumstances; and

WHEREAS, the General Assembly of the State of North Carolina has in Part 6, Article 21 of Chapter 143; Articles 7, 9 and 11 and sections 160D-403 and 160D-404 of Chapter 160D; and Article 8 of Chapter 160A of the North Carolina General Statutes, delegated to local governmental units the responsibility to adopt regulations designed to promote the public health, safety, and general welfare of its citizenry; and

WHEREAS, the General Assembly of the State of North Carolina has in North Carolina General Statutes section 166A-19.41 (b) (2) a. enacted the following: "For a state of emergency declared pursuant to G.S. 166A-19.20(a) after the deadline established by the Federal Emergency Management Agency pursuant to the Disaster Mitigation Act of 2002, P.L. 106-390, the eligible entity shall have a hazard mitigation plan approved pursuant to the Stafford Act"; and

WHEREAS, Section 322 of the Federal Disaster Mitigation Act of 2000 (42 U.S.C. 5165) states that local government must develop an all-hazards Mitigation Plan in order to receive future Hazard Mitigation Grant Program Funds, and

WHEREAS, it is the intent of the Roxboro City Council to fulfill this obligation in order that the City will be eligible for state assistance in the event that a state of disaster is declared for a hazard event affecting the City;

### NOW, therefore, be it resolved that the Roxboro City Council hereby:

- 1. Adopts the Eno-Haw Regional Hazard Mitigation Plan; and
- 2. Vests the City Manager with the responsibility, authority, and the means to:
- (a) Inform all concerned parties of this action.
- (b) Cooperate with Federal, State and local agencies and private firms which undertake to study, survey, map, and identify floodplain or flood-related erosion areas, and cooperate with neighboring communities with respect to management of adjoining floodplain and/or flood-related erosion areas in order to prevent aggravation of existing hazards.
- (c) Adjust the boundaries of municipal planning jurisdictions whenever a municipal annexation or extraterritorial jurisdiction revision results in a change whereby a municipality assumes or relinquishes the authority to adopt and enforce floodplain management regulations for a particular area in order that all Flood Hazard Boundary Maps (FHBMs) and Flood Insurance Rate Maps (FIRMs) accurately represent the planning jurisdiction boundaries. Provide notification of boundary revisions along with a map suitable for reproduction, clearly delineating municipal corporate limits and extraterritorial jurisdiction boundaries to all concerned parties.
