## MINUTES OF THE TOWN OF SMYRNA BEER BOARD

April 5, 2021

The motion was duly seconded by Daniel Akpan. Following discussion, the motion was approved unanimously.

There were no citizen comments to consider.

The Board next considered a motion by Vice-Chairwoman Amanda Newbern to approve the minutes of the February 1, 2021 regular meeting of the Beer Board. The motion was duly seconded by Daniel Akpan. Following discussion, the motion was approved unanimously.

Chairwoman Miranda Swift next read the updated Beer Ordinance removing distances.

The Board next considered an application for an on-premises permit to sell beer from It's 5 O'clock Somewhere, LLC. Chairwoman Miranda Swift called the public hearing to order. Jody David Lopez Robinson spoke concerning the application. Following discussion, Vice-Chairman Amanda Newbern made a motion to approve the application. The motion was duly seconded by Daniel Akpan. Following further discussion, the motion was approved unanimously. A copy of said document is attached and incorporated herein by reference as Exhibit "1".

The Board next considered an application for an on-premises permit to sell beer from Southern Flare, LLC. Chairwoman Miranda Swift called the public hearing to order. Lovely Lancaster and Calvin Gatlin spoke concerning the application. Following discussion, Vice-Chairman Amanda Newbern made a motion to approve the application. The motion was duly seconded by Daniel Akpan. Following further discussion, the

The Board next considered an application for an on-premises permit to sell beer from Zhen, Inc. dba Yummy Poki. Chairwoman Miranda Swift called the public hearing to order. You Hong Liu spoke concerning the application. Following discussion, Vice-Chairman Amanda Newbern made a motion to approve the application. The motion was duly seconded by Daniel Akpan.
