- I. Call to Order and Roll Call
- II. New Business
  - (A) Confirmation of appropriate Board of Review and Open Meeting notices.
  - (B) Select a Chairperson and Vice-Chairperson.
  - (C) Verify that a member has met the mandatory training requirements.
  - (D) Consideration of Minutes from the May17, 2022 meeting.
  - (E) Filing and Summary of the Annual Assessment Report by the Village Assessor.
  - (F) Receive the Assessment Roll and sworn statements from the Clerk.
  - (G) Review the Assessment Roll and Perform Statutory Duties:
    - a. Examine the roll,

- b. Correct description or calculation errors,
  - c. Add omitted property, and
  - d. Eliminate double assessed property
- (H) Discussion and possible action to certify all corrections of error under state law (Wis. Stats. §70.43).
- (I) Discussion and possible action to verify with the Assessor that open book changes are included in the assessment roll.
- (J) Allow taxpayers to examine the assessment data.
- (K) During the first two hours, consideration of:
  - a. Waivers of the required 48-hour notice of intent to file an objection when there is good cause,
  - b. Requests for BOR hearing waiver to allow the property owner an appeal directly to circuit court,
  - c. Requests to testify by telephone or submit sworn written statement,
  - d. Subpoena requests, and
  - e. Act on any other legally allowed/required Board of Review matters
- (L) Review Notices of Intent to File Objection.
- (M) Proceed to hear objections, if any and if proper notice/waivers given unless scheduled for another date.
- (N) Consideration of possible dates of hearings for future meetings of 2022 Board of Review.
