

ORDINANCE NO. 2022-09

AN ORDINANCE AMENDING CHAPTER 26, BUSINESS, ARTICLE V, SPECIAL EVENTS, SECTION 26-200, SPECIAL EVENT PERMIT, OF THE CODE OF ORDINANCES FOR THE VILLAGE OF CHERRY VALLEY, ILLINOIS

WHEREAS, the Village of Cherry Valley (“Village”) has enacted a Code of Ordinances (“Code”); and

WHEREAS, Section 26-200 of the Code establishes that the cost that a special event will be charged for having an officer of the Cherry Valley Police Department present is \$45.00 per hour; and

WHEREAS, it is now necessary to update that ordinance to reflect the Village’s actual incurred costs for a Police Officer to work a special event; and

WHEREAS, the Village wishes to amend Section 26-200 of the Code of Ordinances to reflect the actual cost of \$90.00 per hour which includes all applicable hourly rates of pay and benefit costs.

NOW THEREFORE, be it ordained by the President and Board of Trustees for the Village of Cherry Valley, Illinois, as follows:

SECTION 1: Section 26-200, Special Event Permit, of the Code of Ordinances for the Village of Cherry Valley, which includes a copy of the Special Event Permit Application shall and hereby is amended, in relevant part, as follows (new language in **bold**, language to be removed show as ~~strikethrough~~):

- (a) Each public gathering or event which anticipates having 50 people or more **which charges any fee or requires any ticket for admittance** shall complete and file with the village clerk prior to the special event the following application and shall not conduct the special event until the necessary permit is issued by the village.
- (c) The organizers of the special event **or facility upon which the event is held** shall be fined \$500.00 for each day the event occurs without a permit as required by subsection (a) above.
- 5. Any event that requests the Cherry Valley Police Department as their event security will be charged ~~\$45.00~~ **\$90.00** per hour, per officer.
- 6. Any event that does not request the Cherry Valley Police Department as their event security and the event causes a continued response and/or permanent presence by a Cherry Valley Police Officer(s) requiring police presence beyond regular schedule patrol functions will be charged ~~\$45.00~~ **\$90.00** per hour, per officer.

SECTION 2: This Ordinance shall be in full force and effect ten (10) days after its approval, passage and publication in pamphlet form as required by law.


