

ORDINANCE NO. 2023-01

AN ORDINANCE OF THE VILLAGE OF CHERRY VALLEY, ILLINOIS AUTHORIZING THE DISPOSAL OF CERTAIN PERSONAL PROPERTY OWNED BY THE VILLAGE OF CHERRY VALLEY

WHEREAS, the VILLAGE OF CHERRY VALLEY, Illinois (“Village”) has adopted a Village Code of Ordinances (“Code”); and

WHEREAS, the Village owns certain items of personal property that are used by the Village Police Department but over time, are no longer necessary or useful to, or for the best interests of the Village; and

WHEREAS, 65 ILCS 5/11-76-4, authorizes the Village to sell personal property, which is no longer necessary or useful to, or for the best interest of, the Village; and

WHEREAS, it is of the opinion of the corporate authorities of the Village that it is no longer necessary, or useful to, or in the best interest of the Village to retain its 2018 Dodge Charger, VIN Number 2wC3CDXKT8JH198345, 2018 Dodge Charger VIN Number 2wC3CDXKT8JH198346, (2) Setina Mfg. Co Squad car cage partition, (2) Code 3 LED overhead light bar, All center consoles, arm rests, emergency light controls and radios (the “Property”); and

WHEREAS, the Village desires to authorize the disposal of the Property by auction with Rockford Auto Auction for the automobiles and PropertyRoom.com for the remaining items.

NOW THEREFORE, be it ordained by the Mayor and Village Board of Trustees of the Village of Cherry Valley, Illinois as follows:

1. The above recitals are incorporated herein and made a part hereof.
2. Pursuant to 65 ILCS 5/11-76-4, the Mayor and Village Board of Trustees find that the Property is no longer necessary or useful to the Village and the best interest of the Village will be served by the disposal of the 2018 Dodge Charger, VIN Number 2wC3CDXKT8JH198345 and the 2018 Dodge Charger VIN Number 2wC3CDXKT8JH198346. The Village Police Chief, or his designee, is hereby authorized and directed to dispose of the Property by Auction with Rockford Auto Auction.
3. Pursuant to 65 ILCS 5/11-76-4 the Mayor and the Village Board of Trustees find that the following property is no longer necessary or useful to the Village and the best interest of the Village will be served by the disposal of (2) Setina Mfg. Co Squad car cage partition, (2) Code 3 LED overhead light bar, All center consoles, arm rests, emergency light controls and radios by auction on PropertyRoom.com.
4. To the extent there are no bidders or interested purchasers for the (2) Setina Mfg. Co Squad car cage partition, (2) Code 3 LED overhead light bar, all center consoles, arm rests, emergency light controls and radios, or any part thereof, the Village Police Chief or his designee is authorized to dispose of the Property via recycling.
5. The Mayor is hereby authorized to execute any documents necessary to effectuate the disposal by auction contemplated herein and the Village Clerk to attest the same.

6. Except as amended in this Ordinance, all other provisions and terms of Village Code of Ordinances shall remain in full force and effect as previously enacted except that those ordinances, or parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
7. This Ordinance shall be in full force and effect from after its passage, approval, and publication in pamphlet form as provided by law.
