

ORDINANCE NO. 2023-02

AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE VILLAGE OF CHERRY VALLEY, CHAPTER 46—PARKS AND RECREATION, SECTION 46-75—SHELTER AND PAVILION RENTAL FEES

WHEREAS, the Village of Cherry Valley, Illinois (“Village”) has adopted a Code of Ordinances (“Code”) for the Village; and

WHEREAS, the Chapter 46 of the Code governs maintenance, equipment, and operation of the playgrounds and recreational centers and the buildings thereon that have been acquired or built by the Village and have been designated as recreational areas; and

WHEREAS, the Section 46-75 of the Code governs shelter and pavilion rental fees; and

WHEREAS, the Village wishes to amend the Section 46-75 of the Code pertaining to shelter and pavilion rental fees; and

WHEREAS, the Village has determined that it is in the best interest of its residents to amend Section 46-75 of the Code.

NOW THEREFORE, be it ordained by the President and Board of Trustees for the Village of Cherry Valley, Illinois, as follows:

SECTION 1: Chapter 46—Parks and Recreation, Section 46-75—Shelter and pavilion rental fees of the Code of Ordinances for the Village of Cherry Valley, shall and hereby is amended, in relevant part, as follows (new language in **bold**, language to be removed show as ~~strikethrough~~):

Sec. 46-75. - Shelter and pavilion rental fees.

Any party, entity, or organization, wishing to use any shelter, gazebo, or pavilion located within the village's park system may do so by filing a written request with the village administration department. Full payment of rental and deposits and completed applications must be received at the time the reservations are made. The village administration department shall grant such request on a first come, first served basis and shall charge each group using each individual structure ~~in accordance with the following fee schedule:~~ **a rate of \$50.00 per day for gazebo rental and \$80.00 per day for pavilion rental.**

~~Resident: \$20.00 per day.~~

~~Nonresident: \$40.00 per day.~~

All ~~deposits and~~ rental fees shall be paid by cash **or paid electronically via the Village website.**

Not-for-profit groups which are located and conduct their normal meetings within a one and one-half mile radius of the village boundaries shall be charged no rental fee.

~~Additionally, every group requesting the use of a shelter, gazebo, or pavilion within the village shall deposit \$100.00 in cash, along with its request for the use of the structure. All fees, including security deposits, required by this section, shall accompany the request for the use of the park structure.~~

~~Deposits must be picked up no later than 30 days from the day of the event or it will be forfeited to the village.~~

SECTION 2: Except as amended in this Ordinance, all other provisions and terms of Village Code of Ordinances shall remain in full force and effect as previously enacted except that those ordinances, or parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 3: This Ordinance shall be in full force and effect ten (10) days after its approval, passage and publication in pamphlet form as required by law.
