 Outside Sales: \$150.00 for the period of Seven (7) days upon issuance. Any entity which is conducting outdoor sales shall obtain a license at least seven days prior to engaging such activity. Failure to do so shall increase the fee to \$250.00.

A \$30.00 non-refundable background check fee will also be assessed.

2. Hours limited to: Door-to-door: 12:00 PM – 5:00 PM Monday - Saturday  
 Outside: 9:00 AM – 9:00 PM Monday - Sunday
3. Village Chief of Police will investigate application within Twenty-Four (24) hours of receipt of application.
4. No more than Two (2) licenses affecting same property per calendar year allowing itinerant merchant sales, written permission from property owner required.
5. No license issued unless property where itinerant merchant is also open for business.
