NOTES

MULTIPLE APPLICATIONS – When multiple Planning Div. permits are required for a single project review (i.e. rezoning and a subdivision) involving concurrent processing, the total fee shall be the highest fee plus ½ fee for the remaining applications.

***MINOR USE PERMIT** – All use permits related to a single-family residence or Duplex, parking waiver, signs, temporary coach.

MAJOR USE PERMIT – All other use permits. Eff. 1/1/2024
